On behalf of the Los Angeles County Department of Public Works, I am respectfully requesting a meeting with Acting Commissioner Murillo and Scott Cameron. Representatives from DPW will be in Washington, DC on Tuesday, March 14 to Wednesday, March 15, 2017. DPW will be doing more to develop local groundwater resources and using storm water capture as a component of water supply.
