CAUTION: Prop 65 Ahead

New Proposition 65 Will Appear on Ohio Ballot

Anyone still struggling to comply with the requirements of Proposition 65 in California should examine a similar, but more stringent, proposal now appearing in Ohio. The Ralph Nader-sponsored "right to know" initiative, set to appear on the November ballot in Ohio, will create bureaucratic hardships for industry and consumers.

In 1986, California passed Proposition 65, a voter proposal entitled, "The Safe Drinking Water and Toxics Enforcement Act." Proposition 65 prohibits toxic discharges into drinking water and requires a warning before exposing any individual to these chemicals. The labeling and warning laws in the California statute are precursors to the more extensive chemical "right to know" initiative proposed in Ohio. In fact, the Ohio initiative is a "cut and paste" version of several California laws and is more stringent in many areas than California Proposition 65. A legal challenge to the Ohio initiative was rejected by the Ohio Supreme Court on May 13, guaranteeing that the proposed initiative will appear on the Ohio ballot this year. Based on the premise that government has not provided adequate public information concerning chemical exposure, the initiative's proponents are attempting to place heavy labeling and notification burdens on businesses and consumers.

The Chemical List

The proposed initiative adopts a list of 458 chemicals which it characterizes as carcinogenic or reproductive toxins based on their appearance on the California Proposition 65 list. Many of the listed chemicals are found in everyday items such as soap, plywood, aspirin, peanut butter, birth control pills, paint,

cosmetics, bleach, printing ink, glue, pool chlorine, suntan lotion, car exhaust, and household cleaning products. The chemical list may ex-

pand to more than 800 items once chemicals listed by FDA, EPA, IARC and NIOSH are included.

The Requirements

The Ohio initiative would mandate:

- ☐ warning labels on consumer products sold in Ohio that contain one of the listed chemicals regardless of form or amount;
- ☐ semi-annual mailed warnings to each person who lives or

works within two miles of any facility which emits or causes exposure to any of the listed chemicals;

- that the Ohio EPA require an extensive inventory and exposure assessment by any facility whenever an individual alleges that a required warning has not been provided; and,
- a tax of \$.01 per pound on SARA Title III emissions to fund administration of the initiative by Ohio EPA.

State and local governments are not required to comply with the initiative. Also exempt are products containing naturally occurring chemicals as long as the chemicals are not a result of human activity.

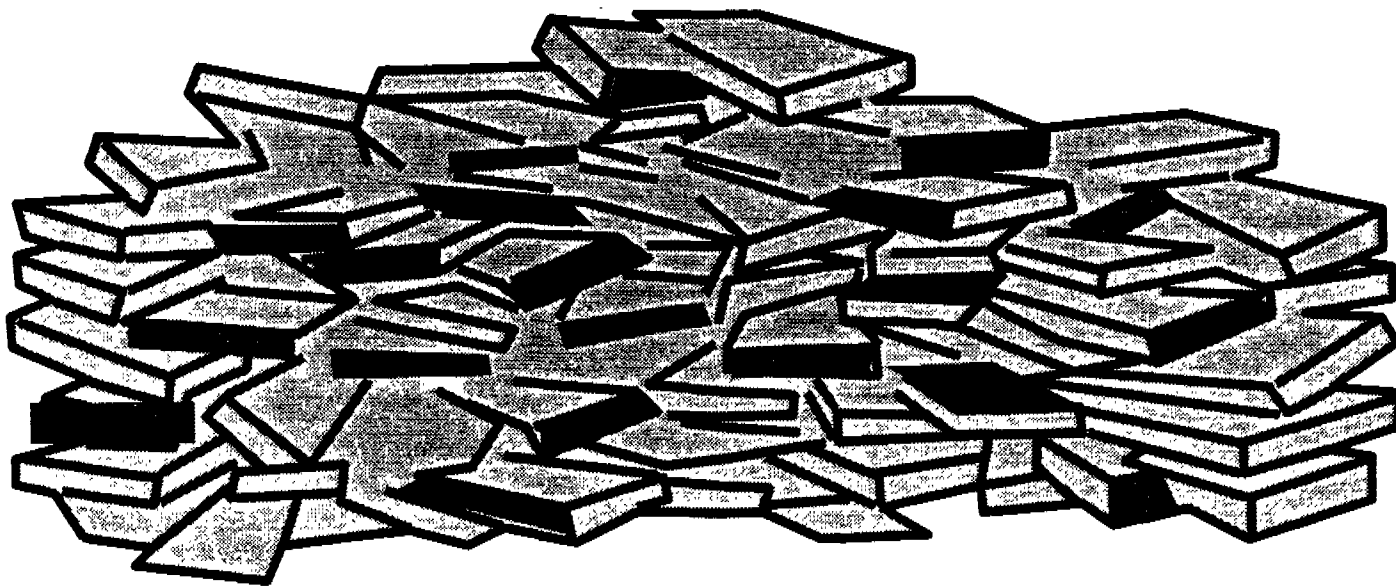
Several panels have discussed the implications of the Ohio initiative. Mr. Jim McIntire, Vice President-State Affairs of CMA has addressed the Bio-cides, Crystalline Silica and Phalate Esters Panels about CMA participation in the campaign to defeat the Ohio initiative. Many panels are concerned that the initiative requirements are unworkable. For example, voluminous mailings to Ohio citizens would produce tons of paper and provide warnings without education. The cost of compliance with the Ohio initiative could add to the difficult economic conditions in Ohio by forcing many companies to leave the state. The general consensus is that the Ohio initiative, if enacted, would set a precedent for labeling and warning regulations in other states.

The CMA Action

Following the 1986 enactment of California's Proposition 65, the CMA Board of Directors recommended that

each company voluntarily pledge a sum of money to assist industry efforts in responding to unreasonable state ballot initiatives. At its June meeting, the CMA Board of Directors approved activation of these pledges to provide support to the campaign to defeat the initiative. Activation of the contingency fund is targeted to raise about \$725,000 for the Ohio campaign. Other industries and trade associations also are participating in the effort. In addition to the petrochemical industry, the labor-industry coalition includes: the Ohio AFL-CIO; the Ohio agricultural community; small businesses; food manufacturing and retailing; and, general manufacturing and business interests.

Because enactment of the Ohio proposal is likely to encourage similar proposals in other states, the Ohio result is important to the entire industry. *If your company has an interest in the campaign and would like more information, please contact James D. TSCA Open Season

In Federal Register notice 57 FR 31714 (July 17, 1992), EPA proposed an "Open Season" for alternative approaches to testing under TSCA Section 4. The Open Season is an industry opportunity to initiate negotiations for TSCA Section 4 testing consent agreements. The Agency required industry representatives to submit a request for consideration as a consent agreement candidate for pending TSCA Section 4 chemicals by September 15. The Agency staff will meet to discuss the proposals on September 30.

EPA will negotiate a testing program and develop a testing consent agreement for chemicals selected as potential candidates. In meetings open to the public, EPA will conduct separate negotiations on each individual chemical substance or related group of chemical substances. If agreement cannot be reached within a specified timeframe, negotiations will be terminated and testing will be required under a test rule.

CHEMSTAR panels responding to the TSCA Open Season are: Aryl Phosphates, Brominated Flame Retardants,

Carbon Disulfide, Oxo Process, Phenol, Terephthalates, Phthalate Esters, and Cyclohexane. In addition, a Work Group representing the ten chemicals cited in the Neurotoxicity Endpoint Rule intends to submit an alternative testing proposal in response to the Open Season. *For more information on the TSCA Open Season, please consult your CHEMSTAR Panel Manager or call 202/887-1191.*

EPA RQ Requests Excessive

On July 29, 1992, representatives from several associations sent a letter to Mr. William Reilly, Administrator of the EPA (see box below). The associations asked for assistance in issuing a rulemaking under the Comprehensive Environmental Response, Compensation and Liability Act to adjust the reportable quantities for substances currently subject to a default one pound RQ. Copies of the letter to Mr. Reilly also were sent to the Office of Management and Budget and the President's Council on Competitiveness.

The one pound default value results in unwarranted waste of government and private sector resources.

Forty substances and five compound categories added to Section 112 of the Clean Air Act by the 1990 Clean Air Act Amendments became hazardous substances under CERCLA Section 102. Under the Agency's interpretation of the law, new substances and compound categories,

for which EPA had not previously established RQs, are subject to the default one pound RQ established by Section 102(b). The one pound default value results in unwarranted waste of government and private sector resources. In their letter, the associations point out that reports of trivial releases posing no real risk to anyone undermine the CERCLA purpose — to provide for timely responses to environmental emergencies.

The letter was prompted by reports that, although EPA staff members have completed the initial work necessary to determine appropriate RQs for the CAAA listed chemicals, EPA does not plan to promulgate these RQ revisions for two to three years. However, the adjustment of the RQs for the forty-five substances and compound categories is required by the President's directive to federal agencies to reduce the burden of government regulations. EPA recognized this fact when it reported RQ adjustments as one of its activities under review for action in its May 1992, "Report to the President on the 90-Day Review of Regulations." The associations believe that delaying the rulemaking for an additional three years

would be counteractive to the President's directive.

SPOTLIGHT ON

Vinyl Chloride



~ ~ This is the latest article in a series which highlights the activities of the various CHEMSTAR Panels and Councils.

The Vinyl Chloride Panel formed under CMA in 1974 to develop and assess health and safety data on vinyl chloride monomer. After funding several animal studies, the Panel shifted its focus to worker epidemiologic studies. The Panel completed its research goals and terminated activity in 1990. Vinyl chloride manufacturers reactivated the Panel in 1991 to promote greater safety in the transportation of the chemical.

Current Panel member companies include: The BF Goodrich Chemical Group; Borden Chemicals and Plastics; Dow Chemical Company; Formosa Plastics; Georgia Gulf Corporation; Occidental Chemical Corporation; PPG Industries Inc.; and, Vista Chemical Company. The Panel Chair is Mr. John Coburn of Occidental. Mr. Mike Kerlegon of Vista is the Vice Chair.

Vinyl chloride at room temperature is a highly-flammable, colorless gas with a mild, sweet odor. Common synonyms of vinyl chloride include chloroethene, chloroethylene, and ethylene monochloride. The major use of vinyl chloride is in the production of polyvinyl chloride plastics. Major transportation routes for vinyl chloride are rail, marine and pipeline. Currently, the Panel is focusing on rail safety.

VCNet Forms

The Panel formed the Vinyl Chloride Transportation Network (VCNet), as a first step in establishing a mutual aid network among Panel member companies to respond to vinyl chloride distribution incidents. VCNet members confidentially provided CMA with vinyl chloride rail shipment routes and volume of material transported. With this information, the Panel developed a composite vinyl chloride transportation map. The companies also provided additional information on their "advisory" and "hands-on" response capabilities to be identified on the map. Contracts with "For-Hire" contractors to respond to an incident when a company shipper cannot respond promptly are being completed.

Shippers of vinyl chloride will be able to activate the network through CHEMTREC, CMA's hazardous materials hotline. Through public outreach, VCNet will coordinate its activities with railroad and community response teams. VCNet is the first mutual-aid network to be formed under CHEMSTAR to respond to distribution incidents.

Once VCNet was formed, the Panel extended its membership to shippers of empty vinyl chloride railcars, because they share the same DOT regulatory responsibilities as shippers of loaded vinyl chloride railcars. Several shippers have joined the network as associate members.

VCNet is the first mutual-aid network to be formed under CHEMSTAR to respond to distribution incidents.

VCNet Safety Awareness

The Panel has developed a vinyl chloride safety awareness training manual and has held several workshops on vinyl chloride safety. The workshops were directed at emergency response personnel from fire departments, rescue squads, "for-hire" contractors, manufacturing plants, railroads and communities. VCNet designed the workshops to provide attendees with a better understanding of the principles and techniques involved in responding to a hazardous materials accident. Workshop presenters provided instruction on the safe approach to and assessment of a vinyl chloride incident and proper handling techniques to follow during

emergency response. Workshop attendees also participated in a simulated vinyl chloride incident. Completion of this course does not qualify the attendee as an emergency responder as per OSHA 1910.120, but prepares the attendee to better understand the response techniques and equipment. The Panel will continue holding training workshops at various locations throughout the U.S. to maximize emergency response personnel training for vinyl chloride.

Panel members, on a periodic basis, shared non-proprietary safe-handling and distribution incident information on vinyl chloride to promote safety and to improve environmental quality during manufacturing and distribution. As a result of Panel participation in activities such as

information exchange, member companies may be able to meet several Responsible Care Codes Management Practices—the Product Stewardship Code, the Community Awareness and Emergency Response Code, and the Distribution Code.

Panel Advocacy

The Panel has petitioned the Department of Transportation to reconsider the shipping label name for vinyl chloride containers. The DOT Hazardous Materials Regulations (HMR: 49 CFR Parts 171-180), recently converted to United Nations Standards, have changed the proper shipping name of vinyl chloride to "vinyl chloride inhibited." This change has concerned vinyl chloride producers because

an inhibitor is not added to the monomer for domestic shipments or for some international shipments. The Panel will continue discussion with DOT staff on the shipping label issue.

Panel Future

With the initiation of VCNet complete, the Vinyl Chloride Panel will continue to pursue the safe handling and distribution of vinyl chloride. The Panel is committed to support the mutual aid network and to educate personnel on vinyl chloride emergency response through safety awareness workshops. *For more information on VCNet, contact Dr. Hasnukh Shah, Vinyl Chloride Panel Manager, at 202/887-1192.*

will advance CAA objectives, specifically reformulated gasoline requirements and fuel detergent performance standards.

The Task Group supported EPA's approach of grouping fuels based upon characteristics of the raw product, and the use of a tiered approach for submitting combustion emissions speciation and biological data. Glycol Ethers Files CERCLA RQ Petition

(Washington, DC, July 8)

The Glycol Ethers Panel petitioned EPA for adjustment of the CERCLA reportable quantities for certain chemicals in the glycol ethers category. The Panel collected extensive data for all glycolethers manufactured in the U.S. by its members. Using the EPS methodology for calculating an RQ, the petition justifies raising the RQs to 5,000 pounds.

The current RQ of one pound for glycol ethers was established as the result of inclusion of the glycol ethers category on the Clean Air Act hazardous air pollutant list. A one pound RQ places an excessive and unnecessary burden on producers and users who are subject to CERCLA reporting for spills and other releases of these materials. *For more information, contact Dr. Carol Stack at 202/887-1196.*

MDA Final Rule

(Washington, DC, July 20)

The final rule on the Occupational Exposure Level for Methylenedianiline was signed at the Department of Labor. The rule is the first chemical specific standard developed by OSHA using a mediated rulemaking process. The provisions of the proposed rule were developed by

an advisory panel consisting of 3 industry, 3 labor unit representatives and reps from OSHA, NIOSH, EPA, DOE and Cal. OSHA. This advisory committee held several meetings to discuss technical issues and develop provisions of the standard. The committee report was published in 1986 and formed the basis of OSHA's 1987 proposed rule. Panels Submit HWIR Comments

(Washington, DC, July 24)

The Acetone, Ketones, Oxo Process, Carbon Disulfide, Cumene, Diisocyanates, Metal Catalysts and Phthalate Esters Panels submitted comments to the Agency in response to the proposed Hazardous Waste Identification Rule. ARC Workshop

The Atmospheric Research Council conducted a workshop to provide an update on the status of global climate change policy issues and current scientific knowledge, and to demonstrate the results of its first major research effort. Dr. Daniel Albritton of the National Oceanic and Atmospheric Administration gave a comprehensive scientific review. Melvin Keener of BP Americas addressed political and regulatory issues and Robert Reinstein of the U.S. Department of State

focussed on international activities. Atmospheric and Environmental Research, Inc., funded by ARC, provided a tutorial on key concepts related to global climate change. The tutorial was supplemented by a hands-on review of a workbook that gives step-by-step instructions for determining atmospheric lifetime and infrared absorption characteristics of chemical substances.
