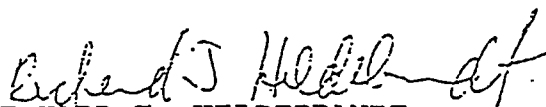
Dear Mr. Shingler:

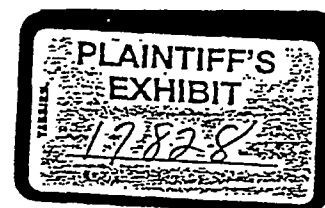
