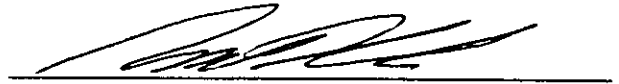

order and condition as when they were originally given to our office. They are not in chronological order.

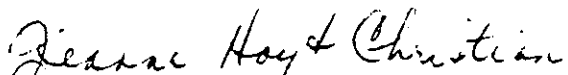
