- U . 04 DEVELOP A METHOD TO SCREEN MATERIAL PURCHASES AND MAINTAIN A CURRENT INVENTORY.
- U . 05 VERIFY THAT MSDS DISTRIBUTED IN THE WORKPLACE ARE CONSISTENT WITH THE INVENTORY.
- U . 06 PROVIDE A METHOD FOR EVALUATING AUDIOGRAMS AND ADVISING EMPLOYEES OF HEARING SHIFTS WHICH IS CONSISTENT WITH THE GUIDELINE ISSUED 7/19/84 RAC TO REF. MGRS.
