Tilo Roofing Company, Inc. a corporation duly organized under the laws of the State of Delaware, located at 347 Longbrook Avenue, in the county of Fairfield, town of Stratford, and State of Connecticut, and doing business at 347 Longbrook Avenue, Stratford, Connecticut, has adopted and is using the trade-mark shown in the accompanying drawing, for ROOFING MATERIALS—NAMESLY, SHINGLES OF THE INTERLOCKING TYPE, NORMALLY FLEXIBLE, AND PRODUCED FROM A COMPOSITION OF ROOFING MATERIALS—in Class 12, Construction materials, and presents herewith five specimens showing the trade-mark as actually used in connection with such goods, the trade-mark being applied to the goods by stamping, outlining, painting, stencilling or employing decalcomanias upon the goods, or upon containers holding the goods; or by printing or impressing the mark on labels or in tags which may be attached to the goods or to the containers therefor; or in applying the mark in any other manner customary to the trade, and requests that the same be regis-

tered in the United States Patent Office on the Principal Register in accordance with sec. 2(f) of the act of July 5, 1946.

The mark is claimed to have become distinctive of the applicant's goods in commerce which may lawfully be regulated by Congress through substantially exclusive and continuous use thereof as a mark by the applicant in commerce among the several States for the five years next preceding the date of the filing of this application.

Proof of distinctiveness under Sec. 2(f) of the act is supplemented by further evidence submitted in this case.

Applicant claims ownership of Registration 307,735.

The trade-mark was first used on December 8, 1922, and first used in commerce among the several States which may lawfully be regulated by Congress on December 6, 1922.
