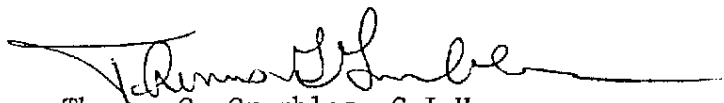
Dear Ms. Kliefoth:
