Given that the expected date of submission of the Annex XV Dossier has been postponed to January 2023, my colleagues assumed that this would give us a bit more time to properly finalize the SEA. We expect the **final draft of the SEA to be ready towards early April**.

5.1.1c The study includes a description of the PFAS use and emissions, a risk assessment, an analysis of alternatives, and socio-economic analysis. This information is intended to provide additional information compared to the previous call for evidence/consultations.
