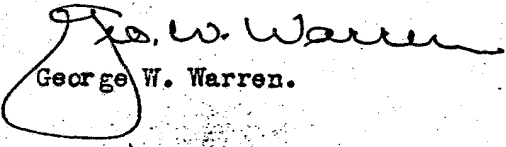
Dear Dr. Kehoe,

My dear Mr. Warren:

I regret very much that I was out of the city at the time that Dr. Kitzmiller was here. Also that I have not had the pleasure of a visit from you in some time.

According to your letter, I have talked to Miss McGlothlin, who was stenographer at the Central, and she seems to think that the last part of the work took just about as much time as the first part, and now it is completed, I think that possibly \$25.00 more would be in keeping with the copy of the charts, which you must admit is rather tedious work. I will collect these charts and send them to you at your Atlanta office not later than December 10th, so as to get them in before the mad rush of the Christmas mail.

For your information I would say that [REDACTED] is in the Charity Hospital under my observation. not on account of any disease that he may have contracted through his occupation, but merely due to the fact that he is an imbecile and his family is more or less scared of him and don't know how to take care of him, and of course, they are going to blame it on conditions of the past.

I understand that Mr. Kitchens has returned to work and is perfectly all right, but [REDACTED] and [REDACTED] report to me regularly about once a week and they can concoct more damn complaints from head to feet than any two niggers I have ever seen. However, I try to humor them, do examine them, ascertain that there is nothing wrong with them, and send them rejoicing in the fact that the Doctor has seen them and they are all right.

During the time of the illnesses of these patients, the laboratory sent four large containers, which I had parked at the Charity Hospital. Three of these I have returned to the laboratory, but I still have fourth unopened. This is a box which measures at least 4 feet by 4 feet and contains glass jars, etc. It seems to me that it would be advisable for me to return this to the laboratory, as the way conditions are now there is really no need for me to go into the urinary examinations of these patients any more. A letter from you regarding the disposition of this will be much appreciated.

I hope that when you come to Savannah again you will give me the opportunity of not only seeing you at the office, but having you come out to the house and again meeting Mrs. Train and the children all of whom enjoyed your visit so much. Kindest regards to you and yours.
