- We will follow up with a breakdown of dioxins and furans once we have the December 2022 sample.
- Some monitoring for A4 and A5 has been missed Q3-Q4, addition monitoring is proposed in 2023 – comment added to reporting form.
- In Form Number: Energy 1 / 2017 it states * Conversion factor for delivered electricity to primary energy = 2.4, we have been reporting Primary energy Mwh (data taken from invoices and energy delivered to site) no conversion applied, it appears as though no conversion has been applied on previous reports – please could you let us know if this is correct? (If so we will remove this note from the reporting form).
- Octylphenoethoxylate (OP10) no longer used in our processes – potential to removed from monitoring requirement – we will send a separate communication on this.
