Thanks for the letter. I was very happy to hear from you. It looks like Cincinnati has been in the spotlight the past few days with airplane crashes and janitors refusing to turn on the heat. I lost no time in looking over the list of casualties in the airplane accident and was pleased to find your name missing.

You probably are anxious to know how [REDACTED] is progressing, and I must say right now that his convalescence since leaving the hospital has been uneventful. At this time he has no complaints to speak of. He has gained over ten pounds in weight in the past week with a good return of his appetite and strength. He has had no trouble in sleeping since coming home. A few days ago he went to Idaho Springs, where he took some hot mineral baths together with drinking a lot of so-called "radium water". The day following he felt well but had a return of the metallic taste to quite a marked degree. Do you think there is any connection?

Just yesterday I presented his case to the students at the school, and we had a very interesting clinic on lead poisoning. Cummings also presented a mild case that he had picked up from a similar plant operating in Englewood, Colorado. His exposure was through cutaneous absorption and had about 0.36 Mm Pb/Liter of Urine.

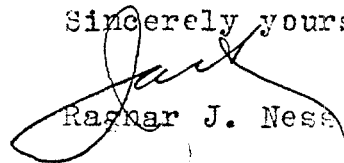
