The duration of the patent is 20 years as from the date of filing the European
application. The 20th year ends on April 27, 2007.

European patent. The fees become due on April 30 and can be paid without
fine within two months (whereafter, if payment is not made, the Patent Office will
issue a reminder that payment is possible with fine within a further 4 months term
