- 1910 Acquired Detroit White Lead Works; now Rogers Paint Products, Inc.
- 1911 Sold Canadian and London plants to The Sherwin-Williams Co. of Canada, Ltd.
- 1912 Warehouses erected at Denver, Birmingham, and Indianapolis
- 1913 Distributing depot at Pasadena, Calif. built.

- 1914 Manufacture chemical products begun at Chicago.
- 1915 Depots opened at Houston, Baltimore, Knoxville, Albany, and Columbus.
- 1917 Martin-Samour Co. at Chicago acquired.
Lithopone manufacture begun at Chicago.
- 1919 Purchased Heringway plant at Bound Brook.
Oakland plant opened.
- 1920 Acme Company at Detroit acquired.
- 1921 Tin can manufacture transferred to Chicago.
Insecticide plant at Oakland erected.
- 1922 Lacquer manufacture begun at Chicago.

- 1940 Opened plant at Buenos Aires, Argentina.
- 1941 New very large warehouse opened at Chicago
Chemical products much enlarged for new products for war needs, etc.
S-W Defense Corp. The War Department asked S-W to construct and
manage shell loading plant at Carbondale, Illinois. A group of
about 50 S-W men selected for this. 15,000 men employed in con-
struction. 6,000 employed to operate at full capacity. Shipped
many millions of shells, anti-tank mines, 500-lb. aerial bombs.
Some days over 100 carloads of ammunition shipped direct to war
front. Plant continued to operate until 1945, when almost all
S-W men returned to employment with the parent company.
- 1943 Large addition to tin can plant to make fibre body cans.
- 1944 Plant established at Sao Paulo, Brazil.
Discontinued coal tar product manufacture.
- 1946 New power house at Chicago.
- 1947 Linseed oil solvent extraction plant erected.
Newark factory acquired additional land.
- 1948 White lead manufacture discontinued. Plant converted to manufacture
of white enamel.
Manufacture lithograph cans begun at Chicago.
Pigment and vegetable oil research laboratories established.
Paint and varnish plant erected at Mexico City.

- 1949 Warehouse erected at Atlanta.
- 1950 Introduced Super Ken-Tone
Newark alloyed resin plant began operating.
Remodeled paint making equipment at Newark.
- 1951 Enlarged enamel equipment at Chicago.
Remodeled paint equipment at Detroit with ball mills, tanks, etc.
New raw material warehouse at Newark.
Remodeled paint department at Newark.
New raw material warehouse at Gibbstere.
New tin can plant at Hubbard, Ohio.
New raw material warehouse at Dayton.
Installed synthetic varnish kettles at Dayton.
New printing and sampling plant at North Olmsted.
