Per my conversation with Ryan Jackson, I am writing you to request a meeting with EPA Administrator Pruitt and Andrew Littlefair, the President and CEO of Clean Energy Fuels. Mr. Littlefair would like to meet with EPA Administrator Pruitt to discuss some recent technological advancements in terms of natural gas vehicles. The new generation of Near Zero NOx emissions natural gas engines, while using renewable natural gas, has an emissions profile that can compete, and in many cases exceed, the emissions profile of electric vehicles when drawing electricity from the grid.

Mr. Littlefair would also like to discuss how a more robust natural gas vehicle industry can create thousands of additional U.S. jobs, and how using a domestic fuel can make our country safer and enhance our national security.

Clean Energy is the largest provider in North America of natural gas used as a transportation fuel. As you know, natural gas is now used as a transportation fuel in motor vehicles, railroad locomotives, and in marine vessels.
