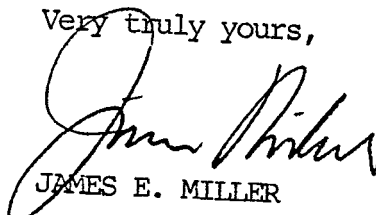
Dear Barry:

REPORT OF REFEREE

Asbestos worker, 26, claims injury to lung from breathing substances in the course of work harmful to chest and lungs.

SUMMARY OF TESTIMONY:

Applicant testified substantially as follows:

While he worked at Western Asbestos his rate of pay was as set forth in the letter of February 14, 1955. His hourly rate was for a 40-hour week.

He first worked at Western as a helper. He did work aboard the S. S. Lurline. This work consisted of packing materials from the dock to the ship. He worked as a helper for three and a half months. The asbestos that he handled during this period of time was in closed cartons. He worked mostly on the dock.

He worked for Western Asbestos on the Standard Oil job as a helper. This job consisted of making cork insulation.

During the period 1947 to 1950 he handled various materials including asbestos, rock wool, fiber glass and asbestos paper. His job was that of a helper and he would pass these materials to the mechanics. Sometimes the air in which he was working was dense. Sometimes he would work in enclosed areas.

He worked on the Standard Oil job for three and a half months. On that job he had very little contact with the materials of asbestos and rock wool. He also worked on the Union Oil Company job.

He worked for Mundet on a job at the Bethlehem yard. This job required him to work mostly on the ships. He also worked at Moss Landing. While he was working at the Moss Landing job he was an asbestos worker. He was also known as a mechanic and he would apply the asbestos to pipes and boilers. On this job his clothes were dusty and he noticed that the inside of his nose was also dusty.

In 1953 he went to Dr. Thompson and Dr. Thompson took x-rays. Dr. Thompson in turn sent him to Dr. Crenshaw.

Under Dr. Crenshaw he underwent surgery to obtain a diagnosis. At that time he was having pains.

He stopped work on September 30, 1953, and was off work for one month because of the surgery. The doctor found nothing wrong and the doctor told him to go back to work.

He continued working until October 19, 1954, when he had further surgery on his chest. Dr. Crenshaw performed this surgery.

He has been off work ever since October 19, 1954. He has not returned to his trade.

It was on October 22, 1954, that Dr. Crenshaw advised him that his condition was due to his work.

The bill for the first surgery was paid half by himself and half by the Occidental Life.

The bill for the second surgery is to be paid half by him and half by the Occidental Life.

Dr. Crenshaw has sent him a bill, but he left the bill home.

He worked from July 15, 1955, to August 14, 1955. During this time he earned \$58 a week.

At one time in his career he was an able-bodied seaman. He held a card as such for a period of three years, but he was not three years on the sea.

On October 15, 1954, he gave a work history when he was in the Herrick Memorial Hospital.

His work on the Lurline was that of a helper. He would transfer the materials from the dock to the ship. He worked on this job for three or four months.

On the Standard Oil job he would use rock wool and cork.

The Lurline job required him to mix wet and dry asbestos. Occasionally he worked aboard ship. His general duties required him to bring the materials aboard. He was just a helper on the Standard Oil job.

He worked about six weeks with the rock wool.

During the last four and a half months he worked for Western he was a journeyman. He does not know whether or not the ships at Bethlehem were new construction. On these ships fiber glass was used.

He is a journeyman asbestos worker. The job at the ship yard was a rush job and it was very dusty in the shop at the ship yard. This job

required him to work 10 hours a day. He was tired after this job but he had no other complaints.

When he worked for Mundet Cork the job was at the Alameda ship yard. On this job he used the tools of an asbestos worker. He worked in asbestos and cork but it was mostly cork.

The materials were applied to the ship "Wilson" and working on this ship required him to work in a dusty place. For Mundet Cork he worked eight hours a day.

The job at the Moss Landing was an outside job. He worked in the open air, but it was very dusty. There was no control of the wind. He had no difficulty while working at Moss Landing. He had no complaints regarding his chest when he left Western Asbestos.

After his first surgery he continued under the care of Dr. Crenshaw.

Dr. Crenshaw, called by the applicant, testified substantially as follows:

Stated his qualifications.

The applicant has been under his care since September 22, 1953.

Surgery was performed the second time October 18, 1954.

The doctor is of the opinion that the reasonable period of convalescence from this surgery would be four or five months and thereafter the applicant could return to light work.

The doctor is of the opinion that the reasonable period of convalescence from this surgery is six months after the surgery.

The doctor is of the opinion that the applicant is 20 percent disabled at the present time and that the applicant's condition will get worse.

The applicant needs medical observation, but he does not need any medical treatment.

The applicant could go to work now, but the applicant is enjoined from working in asbestos work or doing heavy labor work.

The doctor is of the opinion the applicant suffers from asbestosis, and when asked whether or not the applicant also suffered from silicosis, the doctor answered yes and no.

It was only after the second operation that the doctor told the applicant that his condition was connected with his work.

Years of exposure to harmful substances can cause the condition from which the applicant suffers.

On September 22, 1953, the applicant was complaining of a right side pleural effusion. His condition was diagnosed as non specific thoracis. Following this surgery the doctor ruled out the serious causes of the condition.

The fibrosis did not show in the x-rays. It was just prior to or subsequent to the second surgery that he notified the applicant of his opinion that the condition was due to the applicant's work. Possibly it was roughly a week after the second surgery that the doctor so advised the applicant.

The doctor does not believe that the applicant could return to work of a seaman. The doctor believes that a seaman's work requires heavy exertion. That the applicant could do general work, except that the applicant can not do hard work and he must work in a place that is free from harmful dust.

It is reasonable to expect that the applicant's capacity to work in the future will be less than it is now. In the opinion of the doctor the fibrosis that is present will continue to increase.

The doctor came to the conclusion that the work was responsible for the condition because he found substances of elements used in the work in the lung.

There is a possibility that the fiber glass may have caused the disability.

The present factors of disability in the applicant are shortness of breath and weakness.

SUMMARY OF TESTIMONY

APPLICANT testified substantially as follows:

He was born May 4, 1928.

He is right-handed.

He is an asbestos worker. In 1949 he worked for Western Asbestos. He went to work sometime before April, 1949, as a helper. His job was to pack asbestos onto a ship. He worked two or three months. Sometimes he worked below the decks and in the engine room.

His work required him to pack and mix dry asbestos. His earnings were about \$46.00 a week.

On the Standard Oil job he helped with the supplies. He used rock wool and hot tar on this job. He worked in an enclosed area. There were 20 to 30 men working and the ventilation was poor. He worked with asbestos blocks.

He worked for Armstrong in 1950 and stopped work in 1953. He started working for Western Asbestos in 1949 and worked about two years. He worked for Plant Asbestos about nine months beginning in 1950. He worked for Western Asbestos in 1940 and 1950. He worked for Plant Asbestos for one week. He worked for Armstrong Cork in 1951.

It appeared to this referee that the proper parties defendant were not before the Commission at this time and the matter was continued, to be reset.

Notice was given to counsel for the applicant that in the event that a proper amended application was not on file within a reasonable time the application filed herein would be ordered dismissed without prejudice. It appeared that the testimony of the applicant should be stricken from the record inasmuch as the proper parties defendant were not before the Commission at this time and the testimony was ordered stricken from the record.

The matter was continued, to be reset on the first available calendar in the event that a proper amended application was on file herein.

The doctor is of the opinion that the applicant first became afflicted with asbestosis in 1953 when the applicant experienced the pain. The onset of the clinical disease occurred in 1953.

The doctor believes that each employment should bear an equal share all the way through. Continued exposure increases asbestosis.

ROLAND E. MASTERS, called by the defendant, testified substantially as follows:

He is the office manager of the San Francisco office and of the Marine Department of J. T. Thorpe and Sons.

In 1948 and 1949 the company was using asbestos products, which included block insulations, both hot and cold temperatures, pipe coverings and certain cements. He enumerated the content of asbestos in some of the products he used. During those years most of the work was outside work and was new construction.

In 1948 and 1949 he received no complaints regarding dusty conditions at the job sites.

A helper would usually mix the materials used at the job.

One of the samples contained 15 per cent asbestos and another of the samples contained 15 to 20 per cent asbestos.

CARL O. JUST, called by the defendant, testified substantially as follows:

He is a supervisor at Plant Asbestos and has been such for six years. He knows the applicant and knows the employment of the applicant at the plant. The employment consisted of work mostly on new construction.

No request was ever made of him for any change in the ventilation on the job. He received no complaints regarding dust on any job.

ALLAN HOLDEN, called by the applicant, testified substantially as follows:

He is employed by the Occidental Life Insurance Company and the Occidental Life Insurance Company have filed a lien herein in the sum of \$591.87. The following bills make up this item: Bill of Dr. Thompson, 10-9-53, for \$30.00; bill of Dr. Crenshaw of 10-9-53 for \$220.00; bill of the Blood Bank of 10-16-53 in the sum of \$33.25, of which the lien claimant has paid \$24.75; the bill of the Herrick Hospital in the sum of \$361.07, dated 10-23-53, of which the lien claimant has paid \$292.12; the bill of the Peralta Hospital for laboratory examination in the sum of \$20.00, dated 10-30-53.

The lien claimant has paid hospitalization and medical benefits under their accident and sickness policy. They have also paid \$15.00 a week for 47-1/7 weeks. This sum was paid beginning April 5, 1955, to 9-14-55 and the witness corrected this period to be 10-20-54 to 9-14-55.

The policy does not cover reimbursement of workmen's compensation benefits.

APPLICANT, recalled, testified substantially as follows:

He was born May 4, 1928.

In 1953 while he was in the hospital special nurses were hired for eight shifts at \$8.00 each and \$64.00 was paid by him to the nurses.

In September, 1954, he incurred the bill of \$12.50 at the Herrick Hospital. In January, 1955, there was a charge of \$15.00 for a laboratory test. On February 20, 1954, there were laboratory tests and X-ray, for which he was billed the sum of \$37.50.

DISPOSITION

The matter was ordered submitted at the end of 10 days and the case to remain open for said 10 days to permit the filing of the copies of the medical reports of the Department of Employment, together with the hospital record of Herrick Hospital and further medical reports from the applicant; the parties were requested to submit briefs on all of the issues within 20 days.

Application for Hearing having been filed herein,
and all parties having appeared or having been duly notified,
and the matter having been regularly heard before Referee
Joseph Sheehan, and submitted for decision, said Referee now
makes his Findings and Award, as follows:

FINDINGS OF FACT

1. Jack Cuthbertson, born May 4, 1928, while em-
ployed as an asbestos worker by Western Asbestos Company,
Plant Asbestos Company, Armstrong Cork Company, J. T. Thorpe
& Sons, during periods of employment stipulated to by each
of the several defendant employers herein, contracted an

1 occupational disease, to wit, a form of pneumoconiosis,
2 namely, asbestosis.

3 2. The date on which said employee first suffered
4 disability from said occupational disease and either knew,
5 or in the exercise of reasonable diligence should have known,
6 that said disability was caused by his present or prior em-
7 ployment, was October 23, 1954.

8 3. The occupation of the applicant was asbestos
9 worker.

10 4. At the time of said injury the weekly earnings
11 of the employee were maximum.

12 5. Employee has incurred expenses for diagnostic
13 treatment beginning October 17, 1954 and thereafter, and
14 said treatment was reasonably required to cure or relieve
15 the effects of said disease. A supplemental award for the
16 amount of such expenses will be made upon the service and
17 filing of a supplemental petition in the event the parties
18 are unable to adjust such expense to their mutual satisfac-
19 tion.

20 6. Employee is in need of further medical treat-
21 ment reasonably required to cure or relieve him from the
22 effects of said disease.

23 7. Said disease caused temporary total disability
24 beginning October 17, 1954, to and including July 14, 1955.

25 8. Employee's condition is not yet permanent.

26 9. Statutory notice was given by the employee to
27 Plant Asbestos Company. None of the defendants herein on
28 whom liability is imposed have been prejudiced by the al-
29 leged lack of notice.

30 10. The filing of the Application was timely.

31 11. Department of Employment, State of California,
32 has paid to the employee unemployment compensation disability

1 benefits in the sum of \$970.00 during the period of disa-
2 bility found herein.

3 12. Occidental Life Insurance Company paid no sum
4 of money for medical treatment reasonably required to cure
5 or relieve from the effects of the injury found herein.

6 13. Employee has incurred costs in the sum of
7 \$70.00.

8 14. The determination of apportionment or contri-
9 bution among the several defendant carriers is deferred.

10 15. It is not true that employee is estopped to
11 assert the claim made herein.

12 16. The Commission does have jurisdiction of the
13 subject matter of said claim and of each of the defendants
14 upon whom any liability is imposed herein.

15 17. Employee's attorneys, Smith & Parrish, have
16 rendered services to the employee in the reasonable value
17 of \$300.00.

18 18. Cork Insulation Company is not a necessary or
19 proper party.

20 19. Plant Rubber & Asbestos Works is not a neces-
21 sary or proper party.

22 20. Mundet Cork Corporation is not a necessary or
23 proper party.

24 A W A R D

25
26 AWARD IS MADE in favor of Jack Cuthbertson against
27 State Compensation Insurance Fund, Pacific Employers Insur-
28 ance Company, Standard Accident Insurance Company, Travelers
29 Insurance Company and Industrial Indemnity Company of reim-
30 bursement for the reasonable value of medical treatment ob-
31 tained by the employee on and after October 17, 1954 to and
32 including July 14, 1955.

9 subrogation on petition properly filed.

10 IT IS FURTHER ORDERED that this Award shall bear
11 interest pursuant to the provisions of Section 5800 of the
12 Labor Code.

REPORT OF REFEREE ON DECISION

Alleged asbestos worker, born May 4, 1928, claims injury to lungs from "breathing substances in course of work harmful to chest and lungs."

The proper names of the defendants have been shortened in this report, as follows:

Western Asbestos Company	- Western
State Compensation Insurance Fund	- Fund

In the application it is alleged that applicant was employed by Mundet, as follows:

"1948 - in February, March, April and May, approximately 4 months (4)."

Mundet never appeared in this matter. No appearance was made for it. No proof of proper service was made. The letter of Mundet of 2-16-56 was filed in answer to a subpoena of the Commission. During the time applicant worked for Mundet he used strictly cork. (Testimony of applicant.) Applicant's counsel has assured the Commission that "we are not going to proceed against Mundet Cork or Cork Insulation." (Transcript p. 46). Mundet should be dismissed forthwith. (Rule 10775 and 10782).

Employment with Cork is alleged to have been:

"Cork Insulation Co., San Francisco, Cal. 1949 - February to April, approximately 2 months."

Cork made no appearance herein. Applicant's counsel has submitted no proof of proper service. His assurances (transcript p. 46) constitute a request for dismissal of Cork. Cork should be dismissed forthwith. (Rule 10775 and 10782).

The Application, filed March 8, 1955, alleges:

"Original employment, Plant Rubber & Asbestos Works, San Francisco, Calif. 1944 - February 26th to June 12th, approximately 3-1/2 months."

Apparently purported service on this defendant was made at:

"Plant Rubber & Asbestos Works, 5309 Horton Street, Emeryville, Calif."

SUMMARY OF TESTIMONY

HERBERT E. SIMONS, called by the defendant State Compensation Insurance Fund, testified substantially as follows:

He is employed as Safety and Transportation Supervisor at the Western Asbestos. The record at the plant shows that the applicant worked at the plant from April, 1947, to July, 1950.

The applicant handled asbestos and other materials used at the plant. A list of ingredients of the products used is contained in the insulation list. He prepared this list from the samples submitted to him by the manufacturers. The same material was used in 1947 and 1948.

JACK CUTHBERTSON, recalled, testified substantially as follows:

He worked for J. T. Thorpe and Son beginning in August, 1948 to 1949. It was outside work on a power house. He applied asbestos blocks to the boiler. It was quite dusty and windy. The boiler was located in the open. He did not become ill on this job. He was a mechanic or insulator on this job.

All of the men on the job were using the same insulation. It was dry material. The first application would be dry and the second application would be wet. Magnesium blocks were handled about 85 per cent of the time. He handled dry asbestos blocks about 80 per cent of the time. The magnesium blocks contained magnesium, 85 per cent, and asbestos, 15 per cent. After handling the magnesium blocks he would apply a wet coating. This coating material was handled like plaster.

He also worked for J. T. Thorpe in 1953, that is, from September 1, 1953, to October 23, 1953. Beginning September 28, 1953, he was off work for a month while he was in the hospital. Just prior to going to the hospital he was working for Armstrong Cork.

On further questioning he said he worked for J. T. Thorpe and Son from May 9, 1952, to June 2, 1952. During this time he handled asbestos covering and various asbestos products.

While he was working at Hunters Point the boiler was in the open air. You could see particles of asbestos dust.

No notice was given to Pacific Employers or to J. T. Thorpe and Son. Neither of them have made any promises of compensation to him and neither of them have made any payments of compensation.

He went to the hospital in September, 1953, following the directions of Dr. Crenshaw. Two weeks prior to going to the hospital he'd been under Dr. Crenshaw's care. Dr. Crenshaw did not tell him what was wrong with him. Dr. Crenshaw has continued to give him treatment. When he first saw Dr. Crenshaw Dr. Crenshaw could not tell him what was wrong and he believes that the doctors were looking for cancer at that time. He remained for two weeks in the hospital.

He first learned about his condition about six days after October 6, 1954. He knew about the theory of asbestos becoming lodged in the lungs. He first learned about this theory seven or eight years ago when he first took up the trade.

He had no cough before the first operation. He had severe pains behind his left shoulder and these pains led him to see another doctor. He has never been called by the draft. He was in the Merchant Marine in 1944 to 1946.

He was in asbestos work prior to 1944. He was a helper at that time. They did not make any X-ray examination of him while he was in the service.

He drew the maximum amount of benefits from the State. These benefits covered all of the time he was off work because of his disability. He drew \$35.00 from the State and \$15.00 from Occidental for each week he was off. The two payments together, being \$50.00 a week, were paid to him during the entire period he was off work. He returned to work on September 18, 1955.

(It was stipulated that Travelers Insurance Company had coverage for Armstrong Cork from January 1, 1952, until the present time and that Standard Accident had coverage for the period beginning January 1, 1949, to December 31, 1951. It was likewise stipulated the applicant worked for Armstrong Cork for different periods totaling approximately 191 weeks beginning in September, 1949.)

He worked for Armstrong Cork for about two weeks in 1949, that is, from September to October. In this job he used only cork board and hot tar.

He worked for Armstrong Cork from September 6, 1950, to 1954. He was an insulating mechanic. He used asbestos pipe covering, asbestos blocks, various forms of asbestos, rock wool and cork board on the job. The dry asbestos came in hundred pound sacks. It was the job of a helper to mix this dry asbestos. 85 per cent of the time the applicant mixed his own dry asbestos. The asbestos blocks were installed on boilers. He had no helper and there was heavy dust on the job.

He has worked in the asbestos trade for a period of about eight years and during this time has worked for six or seven companies. On all these jobs he did not use the same materials. While he worked for Mundet he used strictly cork.

Samples which have been introduced were similar to those that he used while working for Armstrong. He used the same type of material for Plant Asbestos, J. T. Thorpe and for Western. He is a union man and most of the jobs are the same. They used the same materials on the jobs. It is asbestos or asbestos products. On all these jobs he had windy days. On some of the jobs the ventilation was poor. On others the dust just hung in the air. The dust was worse on windy days. All through the different jobs the same exposure occurred. Some of the Armstrong jobs were all cork jobs.

Generally speaking, the materials used and the amount of dust produced was the same for all his employers.

He was hospitalized in September, 1953, and prior to that time he made no request for compensation of Armstrong, Standard or Travelers.

At the present time he has still complaints regarding pains in the chest, tiredness in the arms. After a day's work he has to go to bed after dinner. The scars in his chest give him sharp pains at times. The adhesions around the scars hurt more in cold weather than warm weather. It is an effort for him to go up ladders. He is still going to Dr. Crenshaw. He feels better than he did at the time of the last hearing.

At night he has a tired feeling. It is an exhausted feeling. It is hard for him to keep his average up while working in the afternoon.

On July 15, 1955, he went to work for a foundry and this work required him to shovel sand all day long. He worked at this job from July 15, 1955, to August 14, 1955, and thereafter he was off work until September 18, 1955. He gave this work up on August 14, 1955, because he did not continue doing the work.

After August 14, 1955, he listed himself as available for work after about two weeks.

(As regards Plant Asbestos, it was stipulated that the employer's insurance company had coverage from October 1, 1947, to

It was stipulated that the Industrial Indemnity Company had coverage for Plant Asbestos for the period beginning July 18, 1954, to October 17, 1954, and it was also stipulated that applicant worked at the plant during that period.)

While working for Plant Asbestos he used heat and frost insulations. He worked as a mechanic applying these products which were made from asbestos products.

From July, 1954, to October, 1954, he did mostly little jobs. He handled asbestos products during this time. They had to mix the products themselves. It was dusty. It was very dusty while they were mixing.

The job at Mare Island during this time they had to work in a trench, and the material was on top of the trench. The wind would blow the material at him.

On October 17, 1954, he stopped work because he was wheezing and subsequently he went to surgery.

The first notice he gave to Plant Asbestos was about a week and a half after leaving the hospital. His attorney told him that he had to notify his employer.

Plant Asbestos or Pacific Employers or Industrial Indemnity or any of them have made no promises or payments of compensation to him.

He has received payments of disability benefits during the entire period he was off. He drew disability from the State for the maximum amount. He received no benefits after leaving the job he had at the foundry. The majority of all his work was new work. He did not receive benefits for all the time he lost from work.

A recess was taken in this matter until 9:00 A.M. tomorrow, February 21, 1956.

The matter came on regularly for further hearing on February 21 at 9:00 A.M.

SUMMARY OF TESTIMONY

SIDNEY J. SHIPMAN, M.D., called by the defendants, testified substantially as follows:

He saw the applicant on one occasion, that is, on June 15, 1955.

His diagnosis was asbestosis or pneumoconiosis caused by asbestosis. This results from an exposure to asbestosis dust.

As to the degree of disability seen in the applicant on June 15, 1955, he said that his chest was normal to examination. However, an examination at U. C. Hospital showed that the oxygen saturation of the blood was slightly low.

The doctor believes that the applicant is able to work at the present time. He cannot give a probable prognosis. He cannot say the condition will become worse or better or remain the same.

The applicant should have a periodical check by the doctor. The applicant is able to resume normal activity.

The oxygen saturation test showed that the oxygen was not absorbed by the blood like the oxygen should be absorbed. There is some impairment.

No showing has been made that the address of this defendant is at Emeryville. Jurisdiction over this defendant is not shown by the record. Plant Rubber & Asbestos Works should be dismissed. (Rule 10775 and 9745). Applicant has elected not to proceed against this defendant.

One or more of the other defendants have raised seven-teen issues herein. These issues are:

1. Jurisdiction
2. Employment
3. Occupation
4. Injury
5. Insurance
6. Medical expense
7. Medical
8. Earnings
9. Permanent
10. Temporary
11. Notice and prejudice
12. Statute of Limitations
13. Department of Employment lien
14. Occidental Life Insurance Co. Lien
15. Costs
16. Apportionment
17. Estoppel

Only Fund has raised the issue of estoppel. Counsel for Fund has advised that this issue is "to lure to support the injury." The issue is the same as notice and prejudice. The law does not require the impossible of an applicant. No basis in this record exists for finding estoppel on the part of the applicant.

Industrial has put in issue employment and insurance. It has disposed of these issues by stipulation. In view of the stipulations, no findings on these issues are necessary. (Rule 10744).

Industrial and Fund have put in issue earnings and occupation. The answer of the Fund admits maximum wages and the occupation of asbestos worker.

While working for Industrial's assured (Plant) on October 17, 1954, applicant received maximum earnings (stipulated) and his occupation was asbestos worker (stipulated).

Fund's assured, Western, paid applicant wages of \$100.00 a week. (Applicant's testimony).

The entire record compels the finding of asbestos worker as the occupation of the applicant, and maximum earnings.

Fund, Thorpe, Plant, and PE, as to themselves, question the jurisdiction of the Commission. By its answer, Fund relies on the defense that maritime injuries are beyond the jurisdiction of the Commission. The evidence fails to support the position taken by these four defendants on this issue. In holding that the Commission does have jurisdiction, uniformity of the maritime law is not disturbed.

Work done by this employee was not of maritime import since the transaction was of local concern and not prejudicial to uniform application of admiralty law.

The request filed 4-22-55 is for \$1,149.71. This amount consists of two parts:

- (1) \$35 a week from 10-18-54 thru 4-17-55 --
\$910 plus \$60 Hospital benefits, and
- (2) \$30 a week from 9-28-53 thru 10-24-53 --
\$115.71 plus \$64 (8 days hospital benefits)

A lien for \$970 should be allowed to the Department and the Department's request for the additional \$179.71 should be denied. No recovery can be had for this additional amount, the same being properly payable to the employee under the unemployment insurance code.

Applicant's counsel contends "that he is entitled to reimbursement and payment of medical expense." (Letter of Mr. Smith 3-5-56). He argues that Simien case (21 CCC 10) is controlling.

Beginning October 17, 1954 applicant obtained diagnostic treatment which was successful and led to the diagnosis, namely, asbestosis. It follows he is entitled to recovery of such reasonable expense as was necessary to enable his doctor and the defendants' doctors to properly diagnose the cause of the disability.

The evidence as to the exact amount of the expense is vague and indefinite. This referee is unable to speculate as to the true total. Applicant's counsel sent to the Commission some exhibits attached to his letter of February 23, 1956. These exhibits were never properly introduced as evidence. (Transcript, page 86).

A determination of the exact amount of medical expense will be made upon the service and filing of a proper petition in the event the parties are unable to adjust this among themselves. The evidence allows, and standard practice permits, only a general finding.

Applicant has reasonably incurred costs in the sum of \$70.00. (Exhibit A-2).

As reflected by this record, applicant's attorneys have rendered services to the employee in the reasonable value of \$300.00.

Apportionment or contribution of a defendant carrier is properly the subject matter of a supplemental petition.

FINDINGS OF FACT

1. Jack Guthbertson, born May 4, 1928, while employed as an asbestos worker by Western, Plant, Armstrong, Thorpe, during periods of employment stipulated to by each of the several defendant employers herein, contracted an occupational disease, to wit, a form of pneumoconiosis, namely, asbestosis.

2. The date upon which said employee first suffered disability from said occupational disease and either knew, or in the exercise of reasonable diligence should have known, that said disability was caused by his present or prior employment, was October 23, 1954.

3. The occupation of the applicant was asbestos worker.

4. At the time of said injury the weekly earnings of employee were maximum.

5. Employee has incurred expenses for diagnostic treatment beginning October 17, 1954 and thereafter, and said treatment was reasonably required to cure or relieve the effects of said disease. A supplemental award for the amount of such expenses will be made upon the service and filing of a supplemental petition in the event the parties are unable to adjust such expense to their mutual satisfaction.

6. Employee is in need of further medical treatment reasonably required to cure or relieve from the effects of said disease.

7. Said disease caused temporary total disability beginning October 17, 1954, to and including July 14, 1955.

8. Employee's condition is not yet permanent.

9. Statutory notice was given by the employee to Plant. None of the defendants herein on whom liability is imposed have been prejudiced by the alleged lack of notice.

10. The filing of the Application was timely.

11. Department has paid to employee unemployment compensation disability benefits in the sum of \$173.00 during the period of disability found herein.

12. Occidental paid no sum of money for medical treatment reasonably required to cure or relieve from the effects of injury found herein.

13. Employee has incurred costs in the sum of \$70.00.

14. The determination of apportionment or contribution among the several defendant carriers is deferred.

15. It is not true that employee is estopped to assert the claim made herein.

16. The Commission does have jurisdiction of the subject matter of said claim and of each of the defendants upon whom any liability is imposed herein.

17. As reflected by this record, employee's attorneys have rendered services to employee in the reasonable value of \$300.00.

18. Cork is not a necessary or proper party.

19. Plant Rubber is not a necessary or proper party.

20. Mundet is not a necessary or proper party.

CONCLUSIONS OF LAW

Employee is entitled to a joint and several award against Fund, PE, Standard, Travelers, Industrial, of:

The reasonable value of medical treatment obtained by the employee on and after October 17, 1954 to and including July 14, 1955, and

Temporary total disability indemnity at maximum rate beginning October 17, 1954 to and including July 14, 1955, and

Costs in the sum of \$70.00, said sum being payable \$35.00 to Dr. Thompson and \$35.00 to Dr. Crenshaw, and

Further medical treatment reasonably required to cure or relieve from the effects of said disease.

Employee's attorneys are entitled to a first lien in the sum of \$300.00.

Department is entitled to a second lien in the sum of \$970.00. Request of Department for additional lien of \$179.71 should be denied.

Cork, Mundet, Plant Rubber should be dismissed.

Jurisdiction is reserved to determine apportionment or equitable subrogation on petition properly filed.

This is the claim of an asbestos worker, 26, who claims injury to lungs from "breathing substances in course of work harmful to chest and lungs."

One or more of the defendants have raised herein seventeen issues.

Findings were made on all issues presented, and said findings are contained in the Findings and Award, filed herein June 11, 1956.

On June 29, 1956 the employee filed herein his Petition for Reconsideration, and alleged that the Commission acted in excess of its powers, the evidence does not justify the findings of fact, and the findings of fact do not support the award.

The employee objects to the finding that he first suffered disability on October 23, 1954, and he contends he is entitled to temporary disability indemnity for approximately one month in 1953, together with the expense of medical treatment procured by him in the year 1953.

One of the defendants, to wit: Pacific Employers Insurance Company, has filed herein its Petition for Reconsideration. This carrier wants the petition to be considered as an Answer to the applicant's petition and also as a Petition for Reconsideration.

The carrier's petition is directed to the imposition of liability for temporary disability indemnity, and medical expense prior to October 23, 1954 and subsequent to October 17, 1954. The carrier contends there was no obligation to the employee prior to the date of the injury, which was found to be October 23, 1954.

The employee entered the hospital on October 17, 1954, and left the hospital on October 23, 1954. It was during this period of hospitalization that the diagnostic treatment was successful and resulted in the diagnosis of asbestosis.

On June 29, 1956 the employee filed herein his Petition for Reconsideration, and alleged that the Commission acted in excess of its powers, the evidence does not justify the findings of fact, and the findings of fact do not support the award.

The employee objects to the finding that he first suffered disability on October 23, 1954, and he contends he is entitled to temporary disability indemnity for approximately one month in 1953, together with the expense of medical treatment procured by him in the year 1953.

One of the defendants, to wit: Pacific Employers Insurance Company, has filed herein its Petition for Reconsideration. This carrier wants the petition to be considered as an Answer to the applicant's petition and also as a Petition for Reconsideration.

The carrier's petition is directed to the imposition of liability for temporary disability indemnity, and medical expense prior to October 23, 1954 and subsequent to October 17, 1954. The carrier contends there was no obligation to the employee prior to the date of the injury, which was found to be October 23, 1954.

The employee entered the hospital on October 17, 1954, and left the hospital on October 23, 1954. It was during this period of hospitalization that the diagnostic treatment was successful and resulted in the diagnosis of asbestosis.

In 1953 the employee consulted his own doctor, who hospitalized him for diagnostic treatment in the same year. This diagnostic treatment was not successful and failed to furnish any basis for a diagnosis.

The carrier contends that no liability may be imposed upon it prior to the time that the employee had disability, and either knew or in the exercise of reasonable diligence should have known that the disability was caused by his work.

This Referee recommends that applicant's petition be denied, and also that the carrier's petition be denied.

Applicant relies upon the Simien case (Simien vs I.A.C., 21 CCC 10) as authority for the imposition of liability on the defendants herein for the diagnostic treatment which was unsuccessful. The holding in the Simien case is not authority for imposing any liability on a carrier for medical treatment which has been unsuccessful. Simien received medical treatment which successfully relieved and cured from the effects of the injury.

In the instant case the diagnostic treatment secured by the employee in 1953 was unsuccessful, and it was obtained by the employee at his peril. It would be unreasonable to assess liability for this treatment against any of the defendants herein.

The successful diagnostic treatment which was secured by the employee 7 days before he was informed of the work connection of his disability has reasonably resulted in an obligation of the defendants herein.

The carrier has also urged other points, such as dismissal of unnecessary parties, and lack of cross-examination of some employments not herein specifically involved.

It is not true that the defendants, or any of them, have been denied an opportunity to cross-examine the applicant in any particular. Furthermore, this particular carrier may file a proper petition for contribution or subrogation just as soon as it pays more than its just share of the award herein.

Submitted herewith is appropriate order denying applicant's Petition for Reconsideration.

Also submitted herewith is appropriate order denying the Pacific Employers Insurance Company's Petition for Reconsideration.

SUMMARY OF TESTIMONY:

Applicant testified substantially as follows:

While he worked at Western Asbestos his rate of pay was as set forth in the letter of February 14, 1955. His hourly rate was for a 40-hour week.

He first worked at Western as a helper. He did work aboard the S. S. Lurline. This work consisted of packing materials from the dock to the ship. He worked as a helper for three and a half months. The asbestos that he handled during this period of time was in closed cartons. He worked mostly on the dock.

He worked for Western Asbestos on the Standard Oil job as a helper. This job consisted of making cork insulation.

During the period 1947 to 1950 he handled various materials including asbestos, rock wool, fiber glass and asbestos paper. His job was that of a helper and he would pass these materials to the mechanics. Sometimes the air in which he was working was dense. Sometimes he would work in enclosed areas.

He worked on the Standard Oil job for three and a half months. On that job he had very little contact with the materials of asbestos and rock wool. He also worked on the Union Oil Company job.

He worked for Mundet on a job at the Bethlehem yard. This job required him to work mostly on the ships. He also worked at Moss Landing. While he was working at the Moss Landing job he was an asbestos worker. He was also known as a mechanic and he would apply the asbestos to pipes and boilers. On this job his clothes were dusty and he noticed that the inside of his nose was also dusty.

In 1953 he went to Dr. Thompson and Dr. Thompson took x-rays. Dr. Thompson in turn sent him to Dr. Crenshaw.

Under Dr. Crenshaw he underwent surgery to obtain a diagnosis. At that time he was having pains.

He stopped work on September 30, 1953, and was off work for one month because of the surgery. The doctor found nothing wrong and the doctor told him to go back to work.

He continued working until October 19, 1954, when he had further surgery on his chest. Dr. Crenshaw performed this surgery.

He has been off work ever since October 19, 1954. He has not returned to his trade.

It was on October 22, 1954, that Dr. Crenshaw advised him that his condition was due to his work.

The bill for the first surgery was paid half by himself and half by the Occidental Life.

The bill for the second surgery is to be paid half by him and half by the Occidental Life.

Dr. Crenshaw has sent him a bill, but he left the bill home.

He worked from July 15, 1955, to August 14, 1955. During this time he earned \$58 a week.

At one time in his career he was an able-bodied seaman. He held a card as such for a period of three years, but he was not three years on the sea.

On October 15, 1954, he gave a work history when he was in the Herrick Memorial Hospital.

His work on the Lurline was that of a helper. He would transfer the materials from the dock to the ship. He worked on this job for three or four months.

On the Standard Oil job he would use rock wool and cork.

The Lurline job required him to mix wet and dry asbestos. Occasionally he worked aboard ship. His general duties required him to bring the materials aboard. He was just a helper on the Standard Oil job.

He worked about six weeks with the rock wool.

During the last four and a half months he worked for Western he was a journeyman. He does not know whether or not the ships at Bethlehem were new construction. On these ships fiber glass was used.

He is a journeyman asbestos worker. The job at the ship yard was a rush job and it was very dusty in the shop at the ship yard. This job

required him to work 10 hours a day. He was tired after this job but he had no other complaints.

When he worked for Mundet Cork the job was at the Alameda ship yard. On this job he used the tools of an asbestos worker. He worked in asbestos and cork but it was mostly cork.

The materials were applied to the ship "Wilson" and working on this ship required him to work in a dusty place. For Mundet Cork he worked eight hours a day.

The job at the Moss Landing was an outside job. He worked in the open air, but it was very dusty. There was no control of the wind. He had no difficulty while working at Moss Landing. He had no complaints regarding his chest when he left Western Asbestos.

After his first surgery he continued under the care of Dr. Crenshaw.

Dr. Crenshaw, called by the applicant, testified substantially as follows:

Stated his qualifications.

The applicant has been under his care since September 22, 1953.

Surgery was performed the second time October 18, 1954.

The doctor is of the opinion that the reasonable period of convalescence from this surgery would be four or five months and thereafter the applicant could return to light work.

The doctor is of the opinion that the reasonable period of convalescence from this surgery is six months after the surgery.

The doctor is of the opinion that the applicant is 20 percent disabled at the present time and that the applicant's condition will get worse.

The applicant needs medical observation, but he does not need any medical treatment.

The applicant could go to work now, but the applicant is enjoined from working in asbestos work or doing heavy labor work.

The doctor is of the opinion the applicant suffers from asbestosis, and when asked whether or not the applicant also suffered from silicosis, the doctor answered yes and no.

It was only after the second operation that the doctor told the applicant that his condition was connected with his work.

Years of exposure to harmful substances can cause the condition from which the applicant suffers.

On September 22, 1953, the applicant was complaining of a right side pleural effusion. His condition was diagnosed as non specific thoracis. Following this surgery the doctor ruled at the serious causes of the condition.

The fibrosis did not show in the x-rays. It was just prior to or subsequent to the second surgery that he notified the applicant of his opinion that the condition was due to the applicant's work. Possibly it was roughly a week after the second surgery that the doctor so advised the applicant.

The doctor does not believe that the applicant could return to work of a seaman. The doctor believes that a seaman's work requires heavy exertion. That the applicant could do general work, except that the applicant can not do hard work and he must work in a place that is free from harmful dust.

It is reasonable to expect that the applicant's capacity to work in the future will be less than it is now. In the opinion of the doctor the fibrosis that is present will continue to increase.

The doctor came to the conclusion that the work was responsible for the condition because he found substances of elements used in the work in the lung.

There is a possibility that the fiber glass may have caused the disability.

The present factors of disability in the applicant are shortness of breath and weakness.

Continued, to be reset on the first available calendar.

SUMMARY OF TESTIMONY

APPLICANT testified substantially as follows:

He was born May 4, 1928.

He is right-handed.

He is an asbestos worker. In 1949 he worked for Western Asbestos. He went to work sometime before April, 1949, as a helper. His job was to pack asbestos onto a ship. He worked two or three months. Sometimes he worked below the decks and in the engine room.

His work required him to pack and mix dry asbestos. His earnings were about \$46.00 a week.

On the Standard Oil job he helped with the supplies. He used rock wool and hot tar on this job. He worked in an enclosed area. There were 20 to 30 men working and the ventilation was poor. He worked with asbestos blocks.

He worked for Armstrong in 1950 and stopped work in 1953. He started working for Western Asbestos in 1949 and worked about two years. He worked for Plant Asbestos about nine months beginning in 1950. He worked for Western Asbestos in 1940 and 1950. He worked for Plant Asbestos for one week. He worked for Armstrong Cork in 1951.

It appeared to this referee that the proper parties defendant were not before the Commission at this time and the matter was continued, to be reset.

Notice was given to counsel for the applicant that in the event that a proper amended application was not on file within a reasonable time the application filed herein would be ordered dismissed without prejudice. It appeared that the testimony of the applicant should be stricken from the record inasmuch as the proper parties defendant were not before the Commission at this time and the testimony was ordered stricken from the record.

The matter was continued, to be reset on the first available calendar in the event that a proper amended application was on file herein.

The doctor is of the opinion that the applicant first became afflicted with asbestosis in 1953 when the applicant experienced the pain. The onset of the clinical disease occurred in 1953.

The doctor believes that each employment should bear an equal share all the way through. Continued exposure increases asbestosis.

ROLAND E. MASTERS, called by the defendant, testified substantially as follows:

He is the office manager of the San Francisco office and of the Marine Department of J. T. Thorpe and Sons.

In 1948 and 1949 the company was using asbestos products, which included block insulations, both hot and cold temperatures, pipe coverings and certain cements. He enumerated the content of asbestos in some of the products he used. During those years most of the work was outside work and was new construction.

In 1948 and 1949 he received no complaints regarding dusty conditions at the job sites.

A helper would usually mix the materials used at the job.

One of the samples contained 15 per cent asbestos and another of the samples contained 15 to 20 per cent asbestos.

CARL O. JUST, called by the defendant, testified substantially as follows:

He is a supervisor at Plant Asbestos and has been such for six years. He knows the applicant and knows the employment of the applicant at the plant. The employment consisted of work mostly on new construction.

No request was ever made of him for any change in the ventilation on the job. He received no complaints regarding dust on any job.

ALLAN HOLDEN, called by the applicant, testified substantially as follows:

He is employed by the Occidental Life Insurance Company and the Occidental Life Insurance Company have filed a lien herein in the sum of \$591.87. The following bills make up this item: Bill of Dr. Thompson, 10-9-53, for \$30.00; bill of Dr. Crenshaw of 10-9-53 for \$220.00; bill of the Blood Bank of 10-16-53 in the sum of \$33.25, of which the lien claimant has paid \$24.75; the bill of the Herrick Hospital in the sum of \$361.07, dated 10-23-53, of which the lien claimant has paid \$292.12; the bill of the Peralta Hospital for laboratory examination in the sum of \$20.00, dated 10-30-53.

The lien claimant has paid hospitalization and medical benefits under their accident and sickness policy. They have also paid \$15.00 a week for 47-1/7 weeks. This sum was paid beginning April 5, 1955, to 9-14-55 and the witness corrected this period to be 10-20-54 to 9-14-55.

The policy does not cover reimbursement of workmen's compensation benefits.

APPLICANT, recalled, testified substantially as follows:

He was born May 4, 1928.

In 1953 while he was in the hospital special nurses were hired for eight shifts at \$8.00 each and \$64.00 was paid by him to the nurses.

In September, 1954, he incurred the bill of \$12.50 at the Herrick Hospital. In January, 1955, there was a charge of \$15.00 for a laboratory test. On February 20, 1954, there were laboratory tests and X-ray, for which he was billed the sum of \$37.50.

DISPOSITION

The matter was ordered submitted at the end of 10 days and the case to remain open for said 10 days to permit the filing of the copies of the medical reports of the Department of Employment, together with the hospital record of Herrick Hospital and further medical reports from the applicant; the parties were requested to submit briefs on all of the issues within 20 days.

FINDINGS OF FACT

1. Jack Cuthbertson, born May 4, 1928, while em-
ployed as an asbestos worker by Western Asbestos Company,
Plant Asbestos Company, Armstrong Cork Company, J. T. Thorpe
& Sons, during periods of employment stipulated to by each
of the several defendant employers herein, contracted an

1 occupational disease, to wit, a form of pneumoconiosis,
2 namely, asbestosis.

3 2. The date on which said employee first suffered
4 disability from said occupational disease and either knew,
5 or in the exercise of reasonable diligence should have known,
6 that said disability was caused by his present or prior em-

8 3. The occupation of the applicant was asbestos

10 4. At the time of said injury the weekly earnings
11 of the employee were maximum.

12 5. Employee has incurred expenses for diagnostic

REPORT OF REFEREE ON DECISION

Alleged asbestos worker, born May 4, 1928, claims injury to lungs from "breathing substances in course of work harmful to chest and lungs."

The proper names of the defendants have been shortened in this report, as follows:

Western Asbestos Company	- Western
State Compensation Insurance Fund	- Fund
Plant Asbestos Company	- Plant

In the application it is alleged that applicant was employed by Mundet, as follows:

"1948 - in February, March, April and May, approximately 4 months (4)."

Mundet never appeared in this matter. No appearance was made for it. No proof of proper service was made. The letter of Mundet of 2-16-56 was filed in answer to a subpoena of the Commission. During the time applicant worked for Mundet he used strictly cork. (Testimony of applicant.) Applicant's counsel has assured the Commission that "we are not going to proceed against Mundet Cork or Cork Insulation." (Transcript p. 46). Mundet should be dismissed forthwith. (Rule 10775 and 10782).

Employment with Cork is alleged to have been:

"Cork Insulation Co., San Francisco, Cal. 1949 - February to April, approximately 2 months."

Cork made no appearance herein. Applicant's counsel has submitted no proof of proper service. His assurances (transcript p. 46) constitute a request for dismissal of Cork. Cork should be dismissed forthwith. (Rule 10775 and 10782).

The Application, filed March 8, 1955, alleges:

"Original employment, Plant Rubber & Asbestos Works, San Francisco, Calif. 1944 - February 26th to June 12th, approximately 3-1/2 months."

Apparently purported service on this defendant was made at:

"Plant Rubber & Asbestos Works, 5309 Horton Street, Emeryville, Calif."

No showing has been made that the address of this defendant is at Emeryville. Jurisdiction over this defendant is not shown by the record. Plant Rubber & Asbestos Works should be dismissed. (Rule 10775 and 9745). Applicant has elected not to proceed against this defendant.

One or more of the other defendants have raised seven-teen issues herein. These issues are:

1. Jurisdiction
2. Employment
3. Occupation
4. Injury
5. Insurance
6. Medical expense
7. Medical
8. Earnings
9. Permanent
10. Temporary
11. Notice and prejudice
12. Statute of Limitations
13. Department of Employment Issue
14. Occidental Life Insurance Co. Lien
15. Costs
16. Apportionment
17. Estoppel

Only Fund has raised the issue of estoppel. Thorpe for Fund has advised that this issue is the first in our case. The issue is the same as notice and prejudice. This law does not require the impossible of an applicant. No issue in this record exists for finding estoppel on the part of the defendant.

Industrial has put in issue on payment and insurance. It has disposed of these issues by stipulation. In view of the stipulations, no findings on these issues are necessary. (Rule 10744).

Industrial and Fund have put in issue earnings and occupation. The answer of the Fund admits maximum wages and the occupation of asbestos worker.

While working for Industrial's assured (Plant) on October 17, 1954, applicant received maximum earnings (stipulated) and his occupation was asbestos worker (stipulated).

Fund's assured, Western, paid applicant wages of \$100.00 a week. (Applicant's testimony).

The entire record compels the finding of asbestos worker as the occupation of the applicant, and maximum earnings.

Fund, Thorpe, Plant, and PE, as to themselves, question the jurisdiction of the Commission. By its answer, Fund relies on the defense that maritime injuries are beyond the jurisdiction of the Commission. The evidence fails to support the position taken by these four defendants on this issue. In holding that the Commission does have jurisdiction, uniformity of the maritime law is not disturbed.

Work done by this employee was not of maritime import since the transaction was of local concern and not prejudicial to uniform application of admiralty law.

The evidence of Drs. Shipman, Thompson, Crenshaw, and Watson indicates that the applicant does have and does suffer from an occupational disease, namely, a form of pneumoconiosis, to wit, asbestosis.

Dr. Shipman testified the periods of stipulated employment contributed equally to the disabling effects of the disease on October 17, 1954.

Knowledge of the causal connection between the disease and said employment was first had by the applicant six days after October 17, 1954, and prior thereto applicant had, and in the exercise of reasonable diligence obtained, no knowledge of such connection. (Testimony of applicant and Dr. Crenshaw).

Dr. Shipman and Dr. Crenshaw testified the employee needs medical observation. Such evidence supports a finding in favor of the applicant that he is in need of further medical treatment.

Said occupational disease caused temporary total disability beginning October 17, 1954, to and including July 14, 1955. (Testimony of applicant and Dr. Crenshaw).

Dr. Shipman's testimony indicated the condition is not permanent. Applicant's counsel has requested determination of permanent disability be deferred. (Letter of Mr. Smith, 3-5-56).

Some evidence indicates the employee is still disabled and that his condition will get worse. On the other hand Dr. Hinshaw (5-24-55) advises that there will be no progress on or of the disease. The evidence of Dr. Shipman moves this referee to defer determination of this issue.

Notice of injury was promptly given to Plant and Industrial. (Testimony of applicant). None of the defendants have been prejudiced by alleged lack of notice on October 17, 1954, or subsequent to October 17, 1954.

The evidence does not establish any obligation in the defendants to, in any manner whatsoever, compensate applicant for a disability occurring in 1953 and the diagnostic treatment procured by him in 1953. (Record of Herrick Hospital and testimony of applicant). The medical services obtained by the applicant in 1953 were obtained by him at his peril.

The filing of the Application was well within the statutory period of one year of October 23, 1954.

Occidental claims a lien in the sum of \$591.87. The sums making this total of \$591.87 were paid from 10-9-53 to 10-30-53. Such payments were not made for the reasonable expense incurred by or on behalf of said employee for medical treatment to cure or relieve from the effects of the injury found hereinabove. Diagnostic thoracotomy in 1953 did not result in a diagnosis so far as the parties herein are concerned. Payments made by this lien claimant cannot be made a basis for recovery by it either from the applicant or the defendants.

The Department has filed two requests for allowance of lien. One request was filed 1-4-55 for \$589.71. This request is a duplication of the request filed 4-22-55. It should be dismissed.

The request filed 4-22-55 is for \$1,149.71. This amount consists of two parts:

- (1) \$35 a week from 10-18-54 thru 4-17-55 --
\$910 plus \$60 Hospital benefits, and
- (2) \$30 a week from 9-28-53 thru 10-24-53 --
\$115.71 plus \$64 (8 days hospital benefits)

A lien for \$970 should be allowed to the Department and the Department's request for the additional \$179.71 should be denied. No recovery can be had for this additional amount, the same being properly payable to the employee under the unemployment insurance code.

Applicant's counsel contends "that he is entitled to reimbursement and payment of medical expense." (Letter of Mr. Smith 3-5-56). He argues that Simien case (21 CCC 12) is controlling.

Beginning October 17, 1954 applicant obtained diagnostic treatment which was successful and led to the diagnosis, namely, asbestosis. It follows he is entitled to recovery of such reasonable expense as was necessary to enable his doctor and the defendants' doctors to properly diagnose the cause of the disability.

The evidence as to the exact amount of the expense is vague and indefinite. This referee is unable to ascertains as to the true total. Applicant's counsel sent to the Commission some exhibits attached to his letter of February 23, 1956. These exhibits were never properly introduced as evidence. (Transcript, page 86).

A determination of the exact amount of medical expense will be made upon the service and filing of a proper petition in the event the parties are unable to adjust this among themselves. The evidence allows, and standard practice permits, only a general finding.

Applicant has reasonably incurred costs in the sum of \$70.00. (Exhibit A-2).

As reflected by this record, applicant's attorneys have rendered services to the employee in the reasonable value of \$300.00.

Apportionment or contribution of a defendant carrier is properly the subject matter of a supplemental petition.

FINDINGS OF FACT

1. Jack Cuthbertson, born May 4, 1928, while employed as an asbestos worker by Western, Plant, Armstrong, Thorpe, during periods of employment stipulated to by each of the several defendant employers herein, contracted an occupational disease, to wit, a form of pneumoconiosis, namely, asbestosis.

2. The date upon which said employee first suffered disability from said occupational disease and either knew, or in the exercise of reasonable diligence should have known, that said disability was caused by his present or prior employment, was October 23, 1954.

3. The occupation of the applicant was asbestos worker.

4. At the time of said injury the weekly earnings of employee were maximum.

5. Employee has incurred expenses for diagnostic treatment beginning October 17, 1954 and thereafter, and said treatment was reasonably required to cure or relieve the effects of said disease. A supplemental award for the amount of such expenses will be made upon the service and filing of a supplemental petition in the event the parties are unable to adjust such expense to their mutual satisfaction.

6. Employee is in need of further medical treatment reasonably required to cure or relieve from the effects of said disease.

7. Said disease caused temporary total disability beginning October 17, 1954, to and including July 14, 1955.

8. Employee's condition is not yet permanent.

9. Statutory notice was given by the employee to Plant. None of the defendants herein on whom liability is imposed have been prejudiced by the alleged late filing.

10. The filing of the Application is timely.

11. Department has paid to employee compensation disability benefits in the sum of \$173.00 during the period of disability found herein.

12. Occidental paid no sum of money for medical treatment reasonably required to cure or relieve from the effects of injury found herein.

13. Employee has incurred costs in the sum of \$70.00.

14. The determination of apportionment or contribution among the several defendant carriers is deferred.

15. It is not true that employee is estopped to assert the claim made herein.

16. The Commission does have jurisdiction of the subject matter of said claim and of each of the defendants upon whom any liability is imposed herein.

17. As reflected by this record, employee's attorneys have rendered services to employee in the reasonable value of \$300.00.

18. Cork is not a necessary or proper party.

19. Plant Rubber is not a necessary or proper party.

20. Mundet is not a necessary or proper party.

CONCLUSIONS OF LAW

Employee is entitled to a joint and several award against Fund, PE, Standard, Travelers, Industrial, of:

The reasonable value of medical treatment obtained by the employee on and after October 17, 1954 to and including July 14, 1955, and

Temporary total disability indemnity at maximum rate beginning October 17, 1954 to and including July 14, 1955, and

Costs in the sum of \$70.00, said sum being payable \$35.00 to Dr. Thompson and \$35.00 to Dr. Crenshaw, and

Further medical treatment reasonably required to cure or relieve from the effects of said disease.

Employee's attorneys are entitled to a first lien in the sum of \$300.00.

Department is entitled to a second lien in the sum of \$970.00. Request of Department for additional lien of \$179.71 should be denied.

Cork, Mundet, Plant Rubber should be dismissed.

Jurisdiction is reserved to determine apportionment or equitable subrogation on petition properly filed.

SUMMARY OF TESTIMONY

HERBERT E. SIMONS, called by the defendant State Compensation Insurance Fund, testified substantially as follows:

He is employed as Safety and Transportation Supervisor at the Western Asbestos. The record at the plant shows that the applicant worked at the plant from April, 1947, to July, 1950.

The applicant handled asbestos and other materials used at the plant. A list of ingredients of the products used is contained in the insulation list. He prepared this list from the samples submitted to him by the manufacturers. The same material was used in 1947 and 1948.

JACK CUTHBERTSON, recalled, testified substantially as follows:

He worked for J. T. Thorpe and Son beginning in August, 1948 to 1949. It was outside work on a power house. He applied asbestos blocks to the boiler. It was quite dusty and windy. The boiler was located in the open. He did not become ill on this job. He was a mechanic or insulator on this job.

All of the men on the job were using the same insulation. It was dry material. The first application would be dry and the second application would be wet. Magnesium blocks were handled about 85 per cent of the time. He handled dry asbestos blocks about 80 per cent of the time. The magnesium blocks contained magnesium, 85 per cent, and asbestos, 15 per cent. After handling the magnesium blocks he would apply a wet coating. This coating material was handled like plaster.

He also worked for J. T. Thorpe in 1953, that is, from September 1, 1953, to October 23, 1953. Beginning September 28, 1953, he was off work for a month while he was in the hospital. Just prior to going to the hospital he was working for Armstrong Cork.

On further questioning he said he worked for J. T. Thorpe and Son from May 9, 1952, to June 2, 1952. During this time he handled asbestos covering and various asbestos products.

While he was working at Hunters Point the boiler was in the open air. You could see particles of asbestos dust.

No notice was given to Pacific Employers or to J. T. Thorpe and Son. Neither of them have made any promises of compensation to him and neither of them have made any payments of compensation.

He went to the hospital in September, 1953, following the directions of Dr. Crenshaw. Two weeks prior to going to the hospital he'd been under Dr. Crenshaw's care. Dr. Crenshaw did not tell him what was wrong with him. Dr. Crenshaw has continued to give him treatment. When he first saw Dr. Crenshaw Dr. Crenshaw could not tell him what was wrong and he believes that the doctors were looking for cancer at that time. He remained for two weeks in the hospital.

He first learned about his condition about six days after October 6, 1954. He knew about the theory of asbestos becoming lodged in the lungs. He first learned about this theory seven or eight years ago when he first took up the trade.

He had no cough before the first operation. He had severe pains behind his left shoulder and these pains led him to see another doctor. He has never been called by the draft. He was in the Merchant Marine in 1944 to 1946.

He was in asbestos work prior to 1944. He was a helper at that time. They did not make any X-ray examination of him while he was in the service.

He drew the maximum amount of benefits from the State. These benefits covered all of the time he was off work because of his disability. He drew \$35.00 from the State and \$15.00 from Occidental for each week he was off. The two payments together, being \$50.00 a week, were paid to him during the entire period he was off work. He returned to work on September 18, 1955.

(It was stipulated that Travelers Insurance Company had coverage for Armstrong Cork from January 1, 1952, until the present time and that Standard Accident had coverage for the period beginning January 1, 1949, to December 31, 1951. It was likewise stipulated the applicant worked for Armstrong Cork for different periods totaling approximately 191 weeks beginning in September, 1949.)

He worked for Armstrong Cork for about two weeks in 1949, that is, from September to October. In this job he used only cork board and hot tar.

He worked for Armstrong Cork from September 6, 1950, to 1954. He was an insulating mechanic. He used asbestos pipe covering, asbestos blocks, various forms of asbestos, rock wool and cork board on the job. The dry asbestos came in hundred pound sacks. It was the job of a helper to mix this dry asbestos. 85 per cent of the time the applicant mixed his own dry asbestos. The asbestos blocks were installed on boilers. He had no helper and there was heavy dust on the job.

He has worked in the asbestos trade for a period of about eight years and during this time has worked for six or seven companies. On all these jobs he did not use the same materials. While he worked for Mundet he used strictly cork.

Samples which have been introduced were similar to those that he used while working for Armstrong. He used the same type of material for Plant Asbestos, J. T. Thorpe and for Western. He is a union man and most of the jobs are the same. They used the same materials on the jobs. It is asbestos or asbestos products. On all these jobs he had windy days. On some of the jobs the ventilation was poor. On others the dust just hung in the air. The dust was worse on windy days. All through the different jobs the same exposure occurred. Some of the Armstrong jobs were all cork jobs.

Generally speaking, the materials used and the amount of dust produced was the same for all his employers.

He was hospitalized in September, 1953, and prior to that time he made no request for compensation of Armstrong, Standard or Travelers.

At the present time he has still complaints regarding pains in the chest, tiredness in the arms. After a day's work he has to go to bed after dinner. The scars in his chest give him sharp pains at times. The adhesions around the scars hurt more in cold weather than warm weather. It is an effort for him to go up ladders. He is still going to Dr. Crenshaw. He feels better than he did at the time of the last hearing.

At night he has a tired feeling. It is an exhausted feeling. It is hard for him to keep his average up while working in the afternoon.

On July 15, 1955, he went to work for a foundry and this work required him to shovel sand all day long. He worked at this job from July 15, 1955, to August 14, 1955, and thereafter he was off work until September 18, 1955. He gave this work up on August 14, 1955, because he did not continue doing the work.

After August 14, 1955, he listed himself as available for work after about two weeks.

(As regards Plant Asbestos, it was stipulated that the employer's insurance company had coverage from October 1, 1947, to

It was stipulated that the Industrial Indemnity Company had coverage for Plant Asbestos for the period beginning July 18, 1954, to October 17, 1954, and it was also stipulated that applicant worked at the plant during that period.)

While working for Plant Asbestos he used heat and frost insulations. He worked as a mechanic applying these products which were made from asbestos products.

From July, 1954, to October, 1954, he did mostly little jobs. He handled asbestos products during this time. They had to mix the products themselves. It was dusty. It was very dusty while they were mixing.

The job at Mare Island during this time they had to work in a trench, and the material was on top of the trench. The wind would blow the material at him.

On October 17, 1954, he stopped work because he was wheezing and subsequently he went to surgery.

The first notice he gave to Plant Asbestos was about a week and a half after leaving the hospital. His attorney told him that he had to notify his employer.

Plant Asbestos or Pacific Employers or Industrial Indemnity or any of them have made no promises or payments of compensation to him.

He has received payments of disability benefits during the entire period he was off. He drew disability from the State for the maximum amount. He received no benefits after leaving the job he had at the foundry. The majority of all his work was new work. He did not receive benefits for all the time he lost from work.

A recess was taken in this matter until 9:00 A.M. tomorrow, February 21, 1956.

The matter came on regularly for further hearing on February 21 at 9:00 A.M.

SUMMARY OF TESTIMONY

SIDNEY J. SHIPMAN, M.D., called by the defendants, testified substantially as follows:

He saw the applicant on one occasion, that is, on June 15, 1955.

His diagnosis was asbestosis or pneumoconiosis caused by asbestosis. This results from an exposure to asbestosis dust.

As to the degree of disability seen in the applicant on June 15, 1955, he said that his chest was normal to examination. However, an examination at U. C. Hospital showed that the oxygen saturation of the blood was slightly low.

The doctor believes that the applicant is able to work at the present time. He cannot give a probable prognosis. He cannot say the condition will become worse or better or remain the same.

The applicant should have a periodical check by the doctor. The applicant is able to resume normal activity.

The oxygen saturation test showed that the oxygen was not absorbed by the blood like the oxygen should be absorbed. There is some impairment.

We trust the above covers all the questions raised in your letter of August 3.

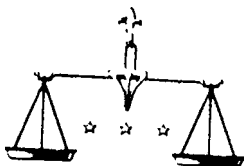

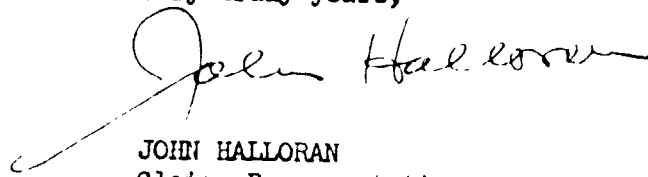

HISTORY. This patient gives a long history of industrial exposure to materials containing asbestos fibers, fiber glass and distemperous earth. He had a right thoracotomy in Sept. 29, 1934, at that time the diagnosis was chronic, non-specific inflammation of fibrous tissue (pleura). Excision of the left side was performed Oct. 12, 1934 at which time Dr. Vinquist at Herrick Hospital described the diagnosis as asbestososis and pleural fibrosis.

MICROSCOPIC EXAMINATION. Microscopic section shows a segment of lung tissue measuring 11 x 9 mm. The pleura is dense and uniformly thickened measuring approximately .8 mm. Scattered throughout are a few histiocytes, lymphocytes, fibroblasts, capillaries and small arteries exhibiting a symmetrical radial thickening with constriction of the lumen. The parenchyma displays patchy collagen and fresh alveolar hemorrhage apparent on high magnification. The alveolar pattern is not significantly disturbed and fibrosis is not a feature, although there is slight sub-pleural thickening of the septa. The alveoli contain many pigment laden macrophages. Part of this is hemosiderin and part is carbon. Such phagocytic elements are also found in the supporting tissue containing chiefly carbon. Examination under the polarizing microscope reveals small anisotropic crystals estimated to be present in quantities no greater than the average lung which is removed surgically for tuberculosis. In one area approximately 3 mm. in diameter there is evidence of collagen fibers with a number of red shaped, hyaline, homogeneous, dark brown distinctly segmented structures which are not anisotropic. Scattered throughout the remainder of the lung, both in the lumen and accompanied by tissue or lying within phagocytic cells are small bodies of similar character. More numerous are cellular, non-staining, refractile, non-anisotropic, straight, ridged structures considerably less than 1 micron in diameter and measuring from 30 to 50 microns or more in length. The identification of the latter is open to debate, however, one slightly larger, distinctly segmented body is found on they are probably related to the larger body structures.

DIAGNOSIS: 1) Asbestos FIBER INGESTION, MIN.
 2) PLEURAL FIBROSIS
NOTE: The asbestos bodies are characteristic, although of quite limited distribution and there is but little chronic reaction as a result. No diatoms are present and only a limited amount of anisotropic material in the form of small crystals. This is presumably silica. It is not more than is found in most of the lungs which pass through an industrial ventilation system.

Supplementary Report

I am attaching two copies of a report from Dr. George A. Watson, a pathologist particularly well experienced in the interpretation of pulmonary disease. You will note that Dr. Watson confirms the presence of asbestos fibers in the lung specimen obtained by biopsy from Mr. Jack Outhbertson. You will note also that he reports very little inflammatory or fibrotic reaction to these fibers. He does not find any abnormal deposition of silica.

This information is consistent with the conclusion reached in my report of March 15, 1955. I should like to stress again that x-ray examinations revealed no evidence of abnormalities which could be attributed to the asbestos fibers although the radiologist was informed of the biopsy report. It should also be recalled that the man's pulmonary function studies were not grossly abnormal with the exception of the maximal breathing capacity determination. This latter test is dependent upon the patient's voluntary performance and the lowered values reported might possibly be attributed to his lack of training or lack of desire to breathe deeply and rapidly while the recording was being made.

Further information concerning lung function would be desirable, especially studies of arterial oxygen saturation and arterial carbon dioxide content. Should you desire to have such studies made it would be best to hospitalize the patient at Stanford University Hospital for two or three days.

Summary: My conclusions are as reported in my previous communication dated March 15, 1955. The presence of asbestos fibers in the lung has been confirmed. These fibers appear to have produced very little microscopic reaction, no recognizable radiologic abnormality and little or questionable derangement of lung function. I would conclude therefore that Mr. Outhbertson is not disabled at this time and there is substantial reason to believe that he will never become disabled. Neither personal experience nor

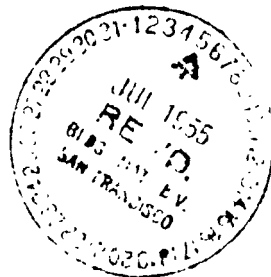
