Ryan -

I hope that things are well at EPA. My firm represents Repsol, a Spanish-based oil and gas company with significant operations in Alaska, Pennsylvania and Texas, among other states. In March, Repsol and Armstrong Energy announced the discovery of 1.2 billion barrels of oil on Alaska's North Slope, the largest US onshore conventional discovery in 30 years.
