Action Has Been Taken and on Which Other Action is Pending

ANSWERING LETTER OF

Paint Division

1. Fabrica Nacional de Pinturas, S. A. (11) - Renegotiation of our basic and "Domestic" contracts with Fabrica is awaiting Mr. Rodriguez's acceptance of the prerequisites to amendment of these contracts established by the Executive Committee on May 22 and modified on June 26.
2. Amendment of Ripolin Agreement (11) - Our September 26, 1951 Agreements with Ripolin (Paris) license the manufacture of water-thinned emulsion paints in France and Algeria and industrial and maintenance finishes in France, Algeria, Great Britain and Belgium. About a year ago Ripolin proposed amending these Agreements and certain revisions were discussed with the Paint Division. A draft of an amended contract, which would include granting Ripolin the right to manufacture industrial and maintenance finishes in Holland and additional technical provisions it requested, was forwarded to Ripolin for approval. Ripolin has informed us that the amended contract is being reviewed by its attorneys.
3. FFK's Covering Rehabilitation of Cleveland Plant (3) - FFK's covering reconstruction and rehabilitation of the Cleveland plant have, to date, been approved in the total amount of \$1,752,800. Project approval for additional items totaling \$270,000 has been granted.
4. Sale of Evansville Branch (3) - The prospective lessor of new branch premises, last week determined not to construct the branch for the Company. Negotiations are presently in progress with other prospective lessors. The sale of our present Evansville Branch property, as authorized by the Directors on March 15, will be delayed until arrangements can be made to assure obtaining other suitable branch facilities.
5. Acquisition of Additional Property at New Orleans Plant (2) - Negotiations to obtain this property have been abandoned pending determination by the Factory Insurance Association as to the feasibility of the installation of a sprinkler line along our property line in lieu of a fender wall and also final determination of the cost to obtain insurance should this property not be acquired.
6. Seidlitz Paint & Varnish Company - The directors of Seidlitz Paint & Varnish Company rejected the proposal for possible acquisition of all of the stock of that company as authorized by the Directors on June 21.
7. NBC Television News Program - NPC has tendered a commitment for an early evening television news program, as authorized by the Executive Committee on April 29, but the Paint Division's acceptance of this commitment has been withheld pending obtaining the desired nationwide station coverage.

Chemicals-Pigments-Metals Division

1. Agreement with Industrias Quimicas Basicas de Mexico S. F. (3) - The Technical Service Agreement between QICA and Industrias Quimicas Basicas de Mexico S. F. has been acted upon and informally approved by Nacional Financiera. Formal approval by Financiera is expected by July 18.
2. Cumberland Island (2) - The Supreme Court of Georgia, on July 8, heard arguments on the Superior Court of Camden County's rulings on demurrers filed at the Woodbine hearings on April 9. A ruling is expected within the next few weeks. The action filed in Federal Court by Mrs. Rockefeller's attorneys has been dismissed by Judge Scarlett.
3. Proposed Sale of Scranton, Pennsylvania Plant (1) - Negotiations for the sale of the plant are pending.
4. Project Z - No developments since June meeting.

Chemurgy Division

1. Indianapolis Protein Plant - The Indianapolis Board of Sanitary Commissioners is withholding action approving this project until September.

Food Division

1. Transfer of Condiment and Coconut Operations to Bethlehem (1) - Transfer of condiment and coconut operations from Elmhurst to Bethlehem, as approved by the Directors on April 19, is awaiting completion of authorized alterations to the new plant. Estimated completion date is September 1 and operations at this plant are expected to commence on October 1.
2. Proposed Sale of Iron Street and Norwalk Plants (1) - No offers of purchase for either the Iron Street or Norwalk plants have been received as a result of the listing of these plants with real estate agents as approved by the Executive Committee on April 1.
3. Coconut Requirements Contract with Biscuiteria Division of National Biscuit Company - The plan to purchase Biscuiteria's coconut manufacturing equipment authorized by the Executive Committee on June 11 has been abandoned. Another agreement whereby the Durkee Division will manufacture and package Biscuiteria's requirements of bulk and packaged sweetened coconut has been submitted to National Biscuit Company.

Southern Chemical Division

1. Crestwood Street Relocation - The Southern Chemical Division's negotiations with the City of Jacksonville for the relocation of Crestwood Street are pending, and, at the present time, the City has indicated that the total cost of this project will substantially exceed the sum of \$12,500 as authorized by the Directors on April 19.
