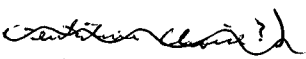

- Insurance companies refuse to back small capacitor makers. *David talks to insurance*
- Ban is applied to higher homologs only.
- Effluent regulations in one or more states make capacitor manufacture impossible within their jurisdiction.
- Government uses (e.g. defense priorities) demand a continuing supply.
- State of Illinois action against Krummrich
 - ban on PCB manufacture;
 - ban on bringing in waste PCB for incineration from outside Illinois;
 - operating permit for incinerator withdrawn.
- Government imposes extended moratorium on replacements pending safety/environmental testing.
- Plant disaster (Krummrich or Anniston) destroys PCB manufacturing capability (several \$M to restore).
- Government or Industry asks us to take the 1043/1016 route.
- Selective ban on transformer application (or transformer makers drop out).
- Major customers consider the ban illegal and want us to supply while fighting it.
