15 ABOUT IS IF THE DISPUTE CONCERNS QUESTIONS AND YOU NEED
16 TO SEEK A PROTECTIVE ORDER. NONE OF THAT HAS HAPPENED.

17 AGAIN, PLEASE START THE DEPOSITION.

18 MR. FISHBACK: AGAIN, IT'S -- OKAY.
