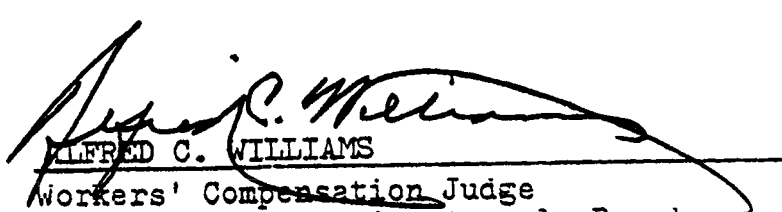

COMPROMISE AND RELEASE
AGREEMENT

16 The parties to this settlement, for the purpose of
17 compromise only, hereby submit the following agreed statements of
18 fact:

19 1. William C. McCormick, Social Security No. 441-09-3140,

26 The insurance carriers party hereto wish it understood
 27 that this settlement relieves them of all responsibility for the
 28 above-named insureds, whether or not the period of insurance coverage
 29 is correct, as alleged, and whether or not the employers that they
 30 may have insured during this claimed period of exposure from 1942
 31 to 1967 are mentioned specifically hereinabove or otherwise.

32 2. The actual weekly wages of the employee are believed

1 The parties wish to avoid the expense, delays and
2 frustrations of further litigation in this matter. The employee
3 wishes to provide his own medical treatment, if any should be
4 needed without the inconvenience of defendant control. The
5 defendants contend that applicant's disability, if any, is
6 constitutional in nature rather than being related to his work;
7 that the extent of impairment, if any, is difficult to ascertain,
8 and the defendants contend that his present condition is
9 approximately the same as it would have been in the normal course
10 of events without any occupational exposure whatever.

16 In further consideration of the payment in accordance
17 herewith, applicant agrees that this release will apply
18 to all unknown and unanticipated injuries and damages resulting
19 from such accident, casualty, event, and/or employment, as well
20 as all those now disclosed, and all rights under Section 1542
21 of the Civil Code of California are hereby expressly waived.

25 Section 1542 of the Civil Code of California reads as
26 follows

27 "A general release does not extend to
28 claims which the creditor does not know or
29 suspect to exist in his favor at the time of
30 executing the release, which if known by him
31 must have materially affected his settlement
32 with the debtor."

33 In further consideration of the payment of the aforesaid
34 sum, applicant agrees that this release extends to and
35 covers the executors, administrators, heirs, representatives,
36 successors, assigns, officers, directors, agents, servants, and
37 employees of the defendants, and each of them, and the physicians,
38 surgeons, and nurses of the defendants, and each of them, whether
39 acting individually or on behalf of them, or either of them.

2 3. The employee's present disability is in dispute, and
3 the employee has returned to work sometime in 1968.

4 4. No temporary total disability has been paid by any of
5 the defendants herein. The amount due, if any, is in dispute.

6 5. The parties agree to settle any and all claims on
7 account of the alleged injury and exposure by payment of the sum
8 of ~~\$13,036.00~~ ^{13032.00}, said sum to be payable as follows: Lump sum to
9 employee, less attorneys' fees; and less liens as may be allowed.
(SEE APPENDIX "A" FOR LIENS)

27 6. No medical expenses have been paid by the employers or
28 by the insurance carriers; all has been provided by applicant
29 through private sources. Future medical and hospital expenses
30 estimated at minimal. All unpaid and future is to be assumed by the
31 employee.

32 7. The applicant's attorneys are Rose, Klein & Marias,

2 8. Said attorneys request a fee of \$ 1,500.00

3 9. The parties attach hereto a separate statement of
4 reasons for the compromise and release agreement.

5 10. The undersigned request that this Compromise Agreement
6 and Release be approved.

7 11. Upon approval of this Compromise Agreement by the
8 Workmen's Compensation Appeals Board or a Referee, and payment in
9 accordance with the provisions hereof, said employee releases and
10 forever discharges said employer and insurance carrier from all
11 claims and causes of action, whether now known or ascertained, or
12 which may hereafter arise or develop as a result of said injury,
13 including any and all liability of said employer and said insurance
14 carrier and each of them to the dependents, heirs, executors,
15 representatives, administrators or assigns of said employee.

16 12. It is agreed by all parties hereto that the filing of
17 this document is the filing of an application on behalf of the
18 employee, and that the W.C.A.B. may in its discretion set the matter
19 for hearing as a regular application, reserving to the parties the
20 right to put in issue any of the facts admitted herein, and that if
21 hearing is held with this document used as an application the
22 defendants shall have available to them all defenses that were

24 W.C.A.B. may thereafter either approve said Compromise Agreement

Gentlemen:

At your request I examined Mr. William C. McCormick at my offices on Dec. 30, 1968. In addition I reviewed the available medical file. My history, physical findings and laboratory studies are as follows:

I CHIEF COMPLAINT:

Shortness of breath and easy fatigability.

II PRESENT ILLNESS:

Mr. McCormick had been working in the insulating field since 1943 for a number of different companies. He had carried out the same type of work activity for these different companies.

He felt well until Oct. of 1966. He began to have complaints of shortness of breath and easy fatigability. He would have occasional episodes of dizziness while climbing.

He also indicates that he had periodic episodes of coughing in the past 5-6 years. He would cough when he would first get to work in the morning and would have a cigarette. He would throw the cigarette away and start working. He would have occasional cough during the day.

He continued to have complaints of shortness of breath and easy fatigability from Oct. 1966 until Oct. 1967. Because of these increasing complaints, he was seen by Carlos Prietto, M. D., a thoracic surgeon.

Dr. Prietto hospitalized him at the St. Francis Hospital in Oct. 1967. He complained of tiring easily together with shortness of breath and also a severe cough occurring both day and night. He had also tightness and burning in the chest with wheezing.

Chest X-rays showed bilateral emphysematous bullae and he had a left thoracotomy carried out.

The surgery was performed on Nov. 2, 1967. This consisted of resection of the emphysematous bullae of the left upper lobe. At the time of the surgery, it was noted that one of the bulla was the size of a grapefruit and the other was about the size of an orange.

X-rays also indicated that underlying bronchiectasis at the bases was not excluded.

He had an electrocardiogram on Nov. 1, 1967, which was within normal limits, and he had an eventful clinical course after the surgery.

He had a second surgical procedure during a hospitalization in Feb. 1968. The left lung was operated on at that time with the removal of emphysematous bullae.

A report by Dr. Prietto dated May 22, 1968, was reviewed. He indicated that Mr. McCormick was discharged to return to work on May 9, 1968.

He felt it was acceptable to believe that his occupation and using asbestos for many years may be the cause of the fibrogenic disease with emphysema and bullae resulting. He felt the scarring in the lungs would continue to progress. He felt there was a 25-30 per cent loss in each lung as that was the size of the bullae removed.

Mr. McCormick returned to work about 6 months prior to my examination. He worked in a shipyard doing insulating work for a period of about 5 weeks. He was laid off but he does not know the reason.

He was evaluated by Morton Kritzer, M. D. on July 2, 1968. Dr. Kritzer had pulmonary function studies carried out by Herbert Shubin, M. D. These showed an increase in residual air volume compatible with the presence of either pulmonary cysts or pulmonary emphysema. However, the increase in the residual air volume was only of slight degree. There was no delay in the helium equilibration time.

The findings were compatible with a history of resection of pulmonary cysts.

Chest X-rays were taken by Charles Weinstein at the request of Dr. Kritzer on July 3. These showed elongation and dilatation of the thoracic aorta; also linear stranding in both upper lobes representing the residue of previous inflammatory disease. The impression was that of mild pulmonary emphysema.

Dr. Kritzer felt he had a pulmonary ventilatory deficit of moderate degree, probably due to pulmonary emphysema and fibrosis. He was also of the opinion that he had gastrointestinal problems possibly secondary to gastritis.

He advised that he find some form of sedentary or semi-sedentary work where he was not asked to climb stairs or lift anything over 10 pounds; also where he was not asked to walk long distances or do excessive physical activity.

He felt that working with asbestos over a period of 30 years in a dusty atmosphere contributed to his present condition. He also indicated that smoking a pack of cigarettes per day over 25 years together with an inherent disposition to develop a type of emphysematous lung, contributed to the condition. He apportioned 75% to his occupation and 25% to underlying causes.

Mr. McCormick worked at another insulating job for Standard Oil for a period of about 2 weeks and then was laid off. He worked a third time for a small insulating company in San Diego. He worked there for only 1 week and was laid off about 3 weeks ago.

Mr. McCormick continues to complain of shortness of breath and easy fatigability and he feels that his general complaints are remaining about the same.

He has occasional complaints of "a dizzy spell when I climb." When he sits down this will subside.

III PAST MEDICAL HISTORY:

- A. Illnesses - see the present illness.
- B. Injuries - none.
- C. Operations - see the present illness.

IV SOCIAL HISTORY:

- A. Alcohol - social drinker.
- B. Tobacco - averaged 1 pack per day throughout his adult life until the present illness. Does not smoke at all at present.
- C. Medications - none.

V MARITAL HISTORY:

- A. Wife - age 54, has a history of "an enlarged heart."
- B. 3 children - alive and well.

VI FAMILY HISTORY:

- A. Mother - age 87, alive and well.
- B. Father - died of some type of heart trouble at the age of 89.
- C. 4 brothers and 3 sisters - alive and well.

VII OCCUPATIONAL:

Mr. McCormick has worked as an insulator and has done as work for the past 25 years. He has worked for many companies during this period of time. He indicates that the working conditions and the type of work he has done have been similar for all these companies.

He indicates that he was also exposed to magnesium and K while working for the various companies.

He has not returned to work since the surgical procedure

He indicates that he worked for the Thorpe Insulation Co a number of times over the past 20 years. He worked for for a period of 11 months shortly before being hospitalized Oct. of 1967.

He indicates that his work activities with Thorpe Insulation Company were about the same as they were with the other

He indicates that he would usually use a mask when they furnished but on other jobs they would not be furnished

VIII PHYSICAL EXAMINATION: Ht 5'9" Wt 190 BP 114/78 P 86

The patient is a well-developed, well-nourished white male appearing his stated age of 57. He is alert, cooperative with no acute distress.

- A. HEENT - the fundi are negative; the pupils react to accommodation; there is no nystagmus.
- B. Chest and lungs - clear to percussion and auscultation; are healed surgical scars noted in the posterior chest areas extending around to both sides.
- C. Heart - regular sinus rhythm; no murmurs or thrills
- D. Abdomen - kidney, liver, spleen not palpable; no mass or tenderness.
- E. Back and extremities - good peripheral pulsations;
- F. Neurological - reflexes physiological; no pathological are noted.

The remainder of the physical examination is essentially contributory.

IX LABORATORY:

- A. Complete blood count - within normal limits.
- B. Sedimentation rate - 6 millimeters per hour.
- C. Latex-fixation - non-reactive.

- D. Uric acid - 3.6 milligrams percent.
- E. Thymol turbidity - 3.6 units.
- F. Cephalin flocculation - 0 at 24 and 48 hours.
- G. C-reactive protein - negative.
- H. Blood sugar - non-fasting, 104 milligrams percent.
- I. Blood urea nitrogen - 17.2 milligrams percent.
- J. Vital capacity - 94% of normal.
- K. Urinalysis - essentially negative.
- L. Posterior-anterior of chest - shows mild emphysematous changes together with residuals of bilateral thoracotomy.
- M. Electrocardiogram - within normal limits.

X DIAGNOSES:

- A. Chronic bronchitis.
- B. Pulmonary emphysema, mild, chronic.
- C. Post-operative thoracotomy for emphysematous bullae.

XI DISCUSSION & CONCLUSIONS:

Mr. McCormick has the history of working in the insulating field for a period of 25 years. His X-ray does not show the characteristic findings of asbestosis. I can see nothing in the available record to indicate that asbestosis was diagnosed by any of the attending physicians. It was not read into any of the X-rays taken at the St. Francis Hospital.

Asbestosis gives the characteristic picture of a ground-glass appearance and irregular thickening of the pleura with a shaggy appearance; also diffuse fibrotic changes. None of these is seen in the case of Mr. McCormick.

He has some findings of pulmonary emphysema. The pulmonary function studies run at the request of Dr. Kritzer showed the increase in residual volume as only of slight degree.

The chest X-ray taken by Charles Weinstein, M. D., a diagnostic radiologist, shows only changes of mild pulmonary emphysema. A combination of these two findings would indicate to me that his pulmonary emphysema is mild in degree.

There is a number of factors contributing to his chronic bronchitis and bronchiectasis as well as mild pulmonary emphysema. His cigarette smoking throughout his adult life is the most significant factor. There is hereditary tendency to develop this condition as well as pollutants in the general atmosphere. All of these factors have combined to contribute to the causation, aggravation and acceleration of his pulmonary condition.

His work activities over a period of 25 years and exposure to dust and fumes have probably also been a contributing factor.

Each of these years would probably have a similar effect on his lungs as far as aggravation and acceleration of his pulmonary process is concerned.

I would apportion 60% of the causation of his pulmonary condition to a combination of cigarette smoking together with pollutants in the atmosphere outside of his work and hereditary factors. I would apportion 40% to work factors over a period of 25 years in which he was exposed to dust and fumes.

His condition is permanent and stationary. He is capable of carry out light work activities on a full time basis. He should only work in the insulating field, if he has an adequate respirator or protective device. He should avoid further dust or fume exposure without adequate protection.

There is no specific treatment indicated for his condition at the present time. He may have superimposed infections from time to time which will require treatment. However, there is no indication for any type of treatment at the time of my examination.
