

Monsanto Seeks EPA Study

Company Claims 'False Controversy' Over Tests

Monsanto Co. has asked the federal government to make an "impartial review" of two tests of workers exposed to dioxin to settle what Monsanto says is a "false controversy" surrounding the studies' accuracy.

Dioxin is a toxic byproduct of some chemical processes.

Monsanto wants the studies, which were conducted by the company, to be examined by the Environmental Protection Agency and the National Institute of Occupational Safety and Health.

Critics contend that Monsanto's research was flawed.

The studies, published in scientific journals in 1980 and 1983, failed to find any chronic health effects of dioxin exposure other than chloracne, a serious form of acne.

Monsanto's research involves workers at Monsanto's Nitro, W. Va., plant who were exposed to dioxin. The company analyzed cancer-related deaths of employees who manufactured 2,4,5-T, a herbicide that also was an ingredient in the defoliant Agent Orange used in the Vietnam War.

Monsanto cited the studies in defending a suit brought by residents of Sturgeon, Mo. in 1979. They claimed that their health had been impaired after a railroad accident that caused a spill of 19,000 gallons of wood preservative and a tiny amount — estimated at a teaspoon — of dioxin.

In 1987, an Illinois circuit court jury in Belleville, awarded \$29,000 to a family whose farm was near the accident site and \$1 each to 63 other plaintiffs. But the jury also awarded \$10.25 million in punitive damages.

Monsanto appealed the punitive damages verdict to the Illinois Fifth District Appellate Court in Mount Vernon, Ill. Monsanto said its Nitro workers' dioxin studies are ac-

curate, adding that they have been unfairly assailed by environmental groups — such as Greenpeace — and an EPA chemist, Cate Jenkins, whose comments do not reflect EPA policy.

"The impartial action [by the federal government] would serve to put an end to this false controversy," Monsanto said in an Oct. 1 letter to EPA. "Absent such government action, Monsanto will continue to suffer damage to its reputation."

Monsanto sent a copy of the letter to the Post-Dispatch.

The letter said that a memorandum written earlier this year by Jenkins contained "untrue allegations" that the company had deliberately under-reported rates of cancer of the Nitro workers.

"Notwithstanding our efforts to correct the record, these baseless charges have been repeated in newspaper accounts and even before a congressional subcommittee," the letter said.

Jenkins didn't return phone calls. In previous interviews, she has said that some of her arguments were taken from plaintiffs' charges in the Sturgeon case.

Dan Bishop, a Monsanto spokesman, said EPA has not responded to the company's letter.

"These allegations have been around for a while," said William H. Farland, an EPA official, in a telephone interview. He runs EPA's office of health and environmental assessment.

Farland added that a NIOSH scientist, Marilyn Fingerhut, is conducting a national study of workers exposed to dioxin. "Her analysis includes the workers at Nitro," Farland said. "Her study will re-examine this. The study is under review [by agency scientists]." Fingerhut didn't return phone calls.

Oil Prices Hike Steam Heat Rates

A steep boost in fuel oil prices due to the Persian Gulf crisis has prompted at least an 18 percent increase in steam heat rates for many downtown commercial and residential buildings.

A temporary six-month rate boost was approved Friday by the Bi-State Development Agency's board for more than three-fourths of Bi-State's 300 steam heat customers. The rate boost will be retroactive to last month.

The rates could jump even higher — or could drop — during the six-month period according to fluctuations in price of fuel oil, which is burned to produce the steam.

Bi-State "will monitor the application of these procedures for correctness on a monthly basis for the duration of the emergency," a briefing paper stated.

The board voted unanimously to approve the 18 percent plan, which was recommended by Bi-State executive director John Leary. The board met at Bi-State's East St. Louis garage.

Speaking against the move were representatives of Plaza Square Apartments.

Robbyn Stewart, Plaza Square manager, urged the board to limit the boost to only three months. "We don't know what's going to happen in the Middle East," she said. "There is no

ers downtown to drop steam heat and adopt alternative heating methods.

The end result, she said, would be less business and revenue for Thermal and Bi-State.

Stewart also complained that Bi-State was not imposing a similar rate boost on so-called interruptible customers of steam heat — which have heating systems that can choose to use either steam or natural gas in a given month depending on which is cheaper.

In response, Leary noted in an interview after the meeting that the interruptible customers' rates are determined by a formula tied to the price of natural gas so as to keep steam rates competitive.
