SUBJECT: RURAL HOUSING
IN SOUTHERN STATES

To Members Supporting the White Lead Promotion
Programs

The U.S. Housing Authority is providing loans for the construction of a large number of farm homes for low income families through Regional and County Housing Authorities. For instance, loans were recently approved for more than 2,000 such homes in Louisiana and Mississippi and we understand that this program will probably be greatly expanded into other States, some work having already been done of this type in Georgia, Illinois, Arkansas and elsewhere.

Since we believe that most of these homes will be of frame construction, they should offer a good market for white lead. The Lead Industries Association has insufficient personnel to call upon these Regional and County Housing Authorities in the interests of white lead. We therefore thought it advisable to call this matter to your attention in case you are not already familiar with it, with the thought that perhaps your own sales representatives can get in touch with these authorities in the course of their travels.

The County Authorities will probably be located at the various county seats, and we understand that in some cases, their offices are in the offices of the County Farm Agents.

We will supply you with any further information we are able to get about this rural housing and are attaching a list of the rural projects approved on July 22, 1941.
