BIG UNITS TO HELP SMALL

Purnell Heads Campaign, With
Dr. Heiser, Author of 'Doctor's
Odyssey,' as Consultant

WASHINGTON, Feb. 27.—Big industry has moved to extend the health benefits developed for workers in large manufacturing establishments to smaller plants which have not had the time or money to install them, the National Association of Manufacturers announced today.

Charles R. Hook, president of the National Association of Manufacturers, reported the appointment of a nation-wide committee on healthful working conditions. Standards approved by such agencies as the American College of Surgeons, the National Bureau of Standards and the National Safety Council will help guide the work of the committee.

"One of the prime objectives of this new committee," he declared, "will be to make available to the small and medium-sized manufacturer the benefit of the experience and study of others in this important field."

The committee has Frank Purnell, president of the Youngstown Sheet and Tube Company, as chairman, and H. C. Beaver, president of the Worthington Pump and Machinery Corporation, Harrison, N. J., as vice chairman.

Dr. Heiser Is Consultant

Dr. Victor G. Heiser, author of "An American Doctor's Odyssey," is consultant.

A general advisory committee to be selected from experts will be headed by Dr. W. Irving Clark, personnel director of the Norton Company, Worcester, Mass.

"During the past twenty-five years," said Mr. Hook, "there have been many developments which improved factory working conditions. Accomplishments in this direction stand among industry's foremost achievements. Naturally, the most rapid advance has been achieved in the larger companies which could afford to devote time and money to the intensive study of working conditions and the development of medical services."
