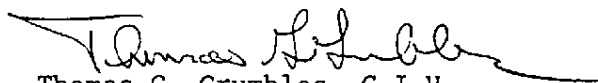
RE: U.S. v. Conoco

On October 3, 1987, the Vista Oklahoma City plant experienced a vinyl chloride release which resulted in emissions above the reportable quantity. The appropriate state and federal agencies were notified. Please contact me if you have any questions regarding this matter.

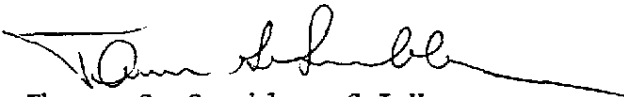

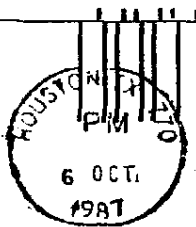

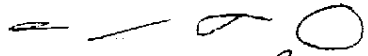

On August 25, 1987, the Vista Lake Charles Vinyl Chloride Monomer plant experienced an incinerator bypass which resulted in VC emissions of less than one pound.
