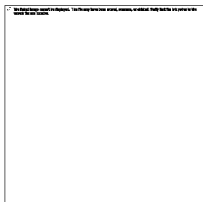

Retired Los Angeles partner Ursula Hyman recalls the cultural dynamics of WEB's early days.



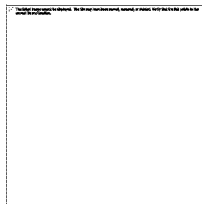
Erica Steinberger

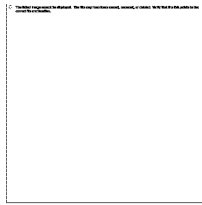
Enrich Your Professional Network
