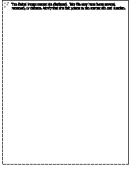
Just to be clear, we're talking Del Frisco's Grille on Pennsylvania, not the steakhouse on I Street.

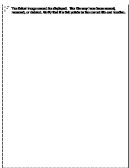
