We formerly showed "Turpentine 25" in our Soft Paste White Lead, but since mineral spirits have displaced turpentine, our C. D. P. label now carries the following statements:

Basic Carbonate of Lead	85%
Linseed Oil	9%
Mineral Spirits	6%

We do not print labels for Martin-Sumner, Lane, Rogers or Lane Bros., but they should be notified so that they may make the necessary changes in their plates.

Possibly you or Mr. Hildbrandt have already notified the Affiliates, but so that there will be no misunderstanding, I am sending copies of this letter to Messrs. Leary, Fortier and Stuart. Perhaps Innes and Lawrence should be notified also. Are you making soft paste lead for either of them?
