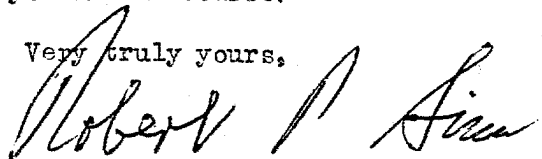

past 5 weeks.

DIAGNOSIS: In accident cases, state exact nature and location of the injury.

1. Dermatitis, contact, of both hands, both forearms, right arm, right Axilla and neck, due to contact with old gasoline, containing lead.
2. Plumbism, acute, cause same as above.
