21 COMES NOW defendant Kaiser Gypsum Company, Inc. (hereinafter
22 "Kaiser Gypsum"), and provides the following updated responses to
23 plaintiffs' standard interrogatories propounded pursuant to San
24 Francisco County Complex Asbestos Litigation General Order No. 29:

25 KAISER GYPSUM'S PRELIMINARY STATEMENT AND OBJECTIONS

26 Kaiser Gypsum was constituted in 1952 and has been
27 headquartered in California since that date. Kaiser Gypsum
28 disposed of its last operating manufacturing plant in August 1978
and subsequently has not engaged in manufacturing or product sales
anywhere in the United States. Thus, all Kaiser Gypsum product

1 sales occurred between 1952 and 1978. Therefore, Kaiser Gypsum's
2 responses to plaintiffs' standard interrogatories are based almost
3 entirely on its ongoing review of documents presently available to
4 the. These updated interrogatory responses reflect Kaiser Gypsum's
5 knowledge at this time and supersede any previous interrogatory
6 answers. Kaiser Gypsum reserves the right to further supplement
7 these responses in the event that more complete or accurate
8 information becomes available.

9 Kaiser Gypsum notes that these responses are made without
10 reference to the factual circumstances of any particular case,
11 and, accordingly, Kaiser Gypsum reserves the right to state
12 additional objections or provide supplemental responses that might
13 be appropriate in the specific context of a given plaintiff's
14 claim(s).

15 Kaiser Gypsum objects to requests for information that are
16 unlimited as to geographical scope on the grounds that such
17 requests are unduly burdensome and are not reasonably calculated
18 to lead to the discovery of evidence admissible in cases that are
19 subject to General Order No. 29. Accordingly, Kaiser Gypsum's
20 present responses hereto are limited to products sold and
21 operations conducted within the State of California.

22 Kaiser Gypsum objects to these interrogatories to the extent
23 that they call for information protected by the attorney/client
24 privilege or work product doctrine.

25 This Preliminary Statement and the objections contained
26 herein are incorporated into each of the responses set forth
27 below.

9 Kaiser Gypsum is a corporation.

10 (a) Its full and correct corporate name is Kaiser Gypsum
11 Company, Inc.

12 (b) Kaiser Gypsum is incorporated under the laws of the
13 State of Washington.

14 (c) Kaiser Gypsum was organized in 1952 through a somewhat
15 complicated process. Specifically, on June 19, 1952, Permanente
16 Cement Company (now known as Kaiser Cement Corporation) formed a
17 wholly owned subsidiary named Kaiser Gypsum Company, a California
18 Corporation. On August 1, 1952 Kaiser Gypsum Company purchased
19 from the Henry J. Kaiser Company two gypsum wallboard plants
20 located at Long Beach and Redwood City, California.

21 On December 1, 1952, Kaiser Gypsum Company was merged into
22 Pacific Coast Cement Company, another subsidiary of Permanente
23 Cement Company, with Pacific Coast Cement Company, a Washington
24 Corporation, which at the time of the merger had no assets or
25 operations and which was incorporated on November 28, 1927, being
26 the survivor. The name of the combined company was then changed
27 to Kaiser Gypsum Company, Inc.

1 (d) Kaiser Gypsum's principal place of business is located
2 at 3000 Busch Road, Pleasanton, California 94566.

3 (e) Kaiser Gypsum has held a certificate of authority to do
4 business in California from 1952 to the present.

5 (f) Kaiser Gypsum's California "registered agent" is CT
6 Corporation, 818 West Seventh Street, Los Angeles, CA 90017.

7 (g) Kaiser Gypsum is a wholly owned subsidiary of Kaiser
8 Cement Corporation, whose principal place of business is located
9 at 3000 Busch Road, Pleasanton, California 94566.

12 I. Kaiser Gypsum's Business: Gypsum Plaster,
13 Gypsum Lath, and Gypsum Wallboard - No Asbestos Used

14 Kaiser Gypsum was organized by Henry J. Kaiser (1882-1967),
15 the famous industrialist and World War II hero, in 1952 and
16 terminated its United States sales and manufacturing in 1978.
17 Between 1952 and 1978, Kaiser Gypsum's principal business
18 consisted of manufacturing and marketing gypsum plaster, gypsum
19 lath and gypsum wallboard. The word "gypsum" is derived from the
20 Greek word "gypso," meaning chalk. "Gypsum" is hydrous calcium
21 sulfate. Gypsum plaster is sometimes called Plaster of Paris,
22 because gypsum plaster was widely used in the capital of France
23 during the 19th century. Gypsum occurs in nature in rock form,
24 and is found in abundance in Baja California, Mexico.

25 A. Gypsum Plaster Products

26 During Kaiser Gypsum's first years in business, most houses
27 and many other buildings had interior walls that were made with
28 plaster. The plaster products sold by Kaiser Gypsum were

1 essentially finely-ground gypsum rock packaged in bags. Such
2 gypsum plaster products were mixed with water and an aggregate
3 (most commonly sand) at the construction site to form a paste.
4 The paste was applied by hand and smoothed with a trowel to form a
5 wall or ceiling surface. Sometimes several layers of plaster were
6 used, with the underneath layers being brown in color and the
7 surface layer being white. When dried, the plaster became quite
8 hard. A plaster wall or ceiling typically was finished by
9 painting the plaster surface or covering it with wallpaper.

10 Kaiser Gypsum's plaster products designed for the above
11 construction uses included Hardwall Plaster, Fibered Hardwall
12 Plaster, Dual Purpose Fibered Hardwall Plaster, Dual Purpose
13 Unfibered Hardwall Plaster, Wood Fibered Hardwall Plaster, Slow
14 Set Gauging Plaster, and Quick Set Gauging Plaster. They also
15 included plaster products for casting (e.g., making ornaments or
16 statues including Casting Plaster and Slow Set Casting Plaster).
17 Kaiser Gypsum also manufactured Plaster Retarder and Structural
18 Gypsum (Pre-Mixed Gypsum Concrete). Kaiser Gypsum plaster
19 products also included Red-E-Mix plaster, a pre-mixed product
20 which combined plaster and aggregate, that was introduced in 1956.
21 Gun Plaster, introduced in 1957, was applied by mixing the sacked
22 product on the job site in special portable mixing machines, and
23 it was then pumped through a large diameter hose to the inside of
24 a building where it was sprayed by plasterers onto walls, with
25 comparative speed and economy. Kaiser Gypsum never used asbestos
26 as a component in any of those products.

1 B. Gypsum Lath Products

2 The surface to which gypsum plaster was applied was called
3 "lath." Lath was sometimes made of wire, but lath also could be
4 made of hard, paper covered sheets of gypsum plaster (called
5 gypsum stucco), sometimes made with holes in them. The lath
6 sheets would be affixed to the interior wall framing, and
7 plaster would then be applied to the lath. The holes in the lath
8 would help keep the plaster in place while it dried. Kaiser Gypsum
9 made gypsum lath of this type. Kaiser Gypsum lath products
10 included Plain Lath and Perforated Lath, Foil-Back Insulating
11 Lath, Duralath, Gypsum Veneer Base, and Kaiserwall. Kaiser Gypsum
12 never used asbestos as a component in any of those products.

13 C. Gypsum Wallboard Products

14 In years following the Korean War, there were numerous
15 innovations in housing construction, including many changes
16 intended to lower housing construction costs. One such change was
17 the substitution of gypsum wallboard, or drywall, for plaster.
18 Gypsum wallboard, like gypsum lath, is basically a hard sheet of
19 gypsum plaster that is affixed to the wall framing. Typically
20 gypsum wallboard would be made in pieces that were 4 feet wide and
21 8 feet long. They typically were 1/2 inch or 5/8 inch thick.
22 During the manufacturing process, the wallboard's core of gypsum
23 plaster was covered by a special paper that could be painted or
24 covered with wallpaper.

25 Because more walls, partitions or ceilings could be made
26 using gypsum wallboard in a given period of time than could be
27 made by plastering over lath, constructing houses, apartments and
28 other buildings with wallboard was less expensive. Over time, as

1 building codes were amended to permit use of gypsum wallboard,
2 more construction of interior walls, partitions and ceilings was
3 done using wallboard and less using plaster. Reflecting this
4 trend, Kaiser Gypsum's business focused more on gypsum wallboard
5 as time passed. By 1960 about half of the construction in
6 California used wallboard and half still used plaster. Plaster use
7 continued to decline, and by the early 1970's substantially all of
8 the market demand was for gypsum wallboard. Kaiser Gypsum never
9 used asbestos as a component in any of its gypsum wallboard
10 products.

11 **D. Non-Asbestos Products Exceeded 90% Of Total Sales**

12 The bulk of Kaiser Gypsum's sales has always consisted of
13 products that did not use asbestos as a component. To illustrate,
14 the following chart shows sales totals in dollars for the years
15 1969-1975, the last full year prior to the complete cessation of
16 the use of asbestos as a component in Kaiser Gypsum products:

24 As these figures illustrate, Kaiser Gypsum's sales of non-
25 asbestos-containing products always were substantially more than
26 90% of its business.

1 II. Accessories For Use With Gypsum Wallboard

2 A. Nails, Wall And Door Frames, Cornerbead,
3 Paper Products - No Asbestos Used

4 With the expansion of its gypsum wallboard business, Kaiser
5 Gypsum also began selling other products needed to construct
6 interior walls, partitions or ceilings using gypsum wallboard.
7 These included special nails and other devices used to attach
8 wallboard to the supporting frame. They also included metal wall
9 or partition frames especially made for installing wallboard,
10 metal "cornerbead" used to make partition corners hard, and metal
11 doorframes for use in walls made using gypsum wallboard. Partly
12 to ensure that it could get access to adequate amounts of the
13 special paper used to make wallboard (by covering its gypsum
14 plaster core), Kaiser Gypsum acquired paper plants, where it also
15 manufactured commercial paper products such as cardboard boxes.
16 Kaiser Gypsum never used asbestos as a component in any of those
17 products.

18 B. Wallboard Joint Compounds -
19 Asbestos Used As A Component

20 When the walls or ceilings of a room are made from gypsum
21 wallboard, large pieces of wallboard are installed side by side,
22 leaving small spaces where two pieces of wallboard meet. These
23 spaces need to be filled so that they cannot be seen after the
24 wall is painted or covered with wallpaper. The products used to
25 perform that task are called joint compounds or joint finishing
26 compounds. At the time of use, these joint compounds are thick
27 putty or mud-like substances, which permits them to be pushed into
28 the spaces and smoothed with a putty knife or spatula. Paper or

1 cloth reinforcing tape is pushed into the joint compound to help
2 prevent cracking as the joint compound dries.. The joint compound
3 dries to form a hard rock-like substance.

4 Kaiser Gypsum manufactured and marketed such wallboard joint
5 compounds, and prior to the mid-1970's, these joint compounds
6 contained a small percentage of chrysotile asbestos as a
7 component. The purpose of the chrysotile asbestos component was
8 to prevent cracks from forming as the joint compound dried.

9 "Asbestos" is the Greek word for "incombustible," which refers to
10 things that will not burn. Chrysotile is the most common type of
11 asbestos used in products in the United States. Chrysotile is a
12 fibrous rock material derived from the rock "serpentine" which is
13 very common in California, where it is the "state rock."

14 These Kaiser Gypsum products were:

- 15 1. Joint Cement/Joint Compound
- 16 2. Finishing (Topping) Compound
- 17 3. 3-Purpose Wallboard Compound
- 18 4. One-Day Joint Compound
- 19 5. Pre-mix Joint Compound
- 20 6. Pre-mix Finishing Compound
- 21 7. Pre-mix Dual Purpose Joint Compound
- 22 8. Pre-mix Topping Compound
- 23 9. Laminating Compound

24 Kaiser Gypsum's separate responses to interrogatory subparts
25 (a)-(f) for each of these products are as follows:

26 1. Joint Cement/Joint Compound

27 (a) The trade name of this product originally was Kaiser
28 Joint Cement; about 1957 it was changed to Kaiser Joint Compound.

(b) Kaiser Gypsum marketed Kaiser Joint Cement in 1952, but
did not manufacture the product itself. Kaiser Gypsum does not
know whether the product marketed in 1952 contained asbestos as a

1 component. Kaiser Gypsum began manufacturing Kaiser Joint Cement
2 in 1953, at which time chrysotile asbestos was used as a
3 component.

4 (c) Kaiser Gypsum last manufactured Kaiser Joint Compound
5 with chrysotile asbestos as a component in 1975.

6 (d) The Kaiser Gypsum California plants that made this
7 product were located at Redwood City and Antioch. These plants
8 were in operation at different times. The product was
9 manufactured at Redwood City from 1953 through 1957 and at Antioch
10 from 1957 to 1975. Because of the heavy weight of the product,
11 low profit margin and high transportation costs, distribution
12 tended to center around the location of the manufacturing plant.
13 The product consisted primarily of minerals including casein or
14 polyvinyl, clay, talc, limestone and mica. The product
15 manufactured in Kaiser Gypsum's California plants included between
16 8% by weight and 16% by weight chrysotile asbestos as a component
17 depending on the formula in effect at a given date.

18 (e) This product was a white to off-white powder. It was
19 packaged and sold in sacks of 10 to 25 lbs. and in boxes of 5 and
20 18 lbs. Each container was labeled with the name of the
21 manufacturer, Kaiser Gypsum Company, Inc., the name of the product
22 and directions for its use.

23 (f) This product was a dry powder which, when mixed with
24 water, formed a thick paste. Upon application it dried to a hard,
25 durable surface. It was used to fill gypsum wallboard joints,
26 embed joint reinforcing tape, finish joints and to cover and
27 finish nail heads and metal cornerbead.
28

1 2. Finishing (Topping) Compound

2 (a) The trade name of this product was Kaiser Gypsum
3 Finishing (topping) Compound.

4 (b) Kaiser Gypsum began manufacturing finishing (topping)
5 compound in 1955, and chrysotile asbestos was used as a component
6 at that time.

7 (c) Kaiser Gypsum last manufactured finishing (topping)
8 compound with chrysotile asbestos as a component in 1975.

9 (d) The Kaiser Gypsum California plants that made this
10 product were located at Redwood City and Antioch. These plants
11 were in operation at different times. The product was
12 manufactured at Redwood City from 1955 to 1957 and at the Antioch
13 plant from 1957 to 1975. Because of the heavy weight of the
14 product, low profit margin and high transportation costs,
15 distribution tended to center around the location of the
16 manufacturing plant. This product consisted primarily of minerals
17 including casein or polyvinyl, clay, talc, limestone and mica.
18 The product included between 5.3% by weight and 16 $\frac{1}{2}$ % by weight
19 chrysotile asbestos as a component depending on the formula in
20 effect at a given time.

21 (e) This product was a white to off-white powder. It was
22 packaged and sold in sacks of 25 lbs. Each container was labeled
23 with the name of the manufacturer, Kaiser Gypsum Company, Inc.,
24 the name of the product and instructions for its use.

25 (f) This product was a dry powder which, when mixed with
26 water, formed a thick paste. Upon application it dried to a hard,
27 durable surface. It was used to top and finish gypsum wallboard
28 joints.

1 3. 3-Purpose Wallboard Compound

2 (a) The trade name of this product was Kaiser Gypsum 3-
3 Purpose Wallboard Compound.

4 (b) Kaiser Gypsum began manufacturing 3-Purpose Wallboard
5 Compound in 1968, and chrysotile asbestos was used as a component
6 at that time.

7 (c) Kaiser Gypsum last manufactured 3-Purpose Wallboard
8 Compound with chrysotile asbestos as a component in 1976.

9 (d) The Kaiser Gypsum California plant that made this
10 product was located at Antioch. Because of the heavy weight of
11 the product, low profit margin and high transportation costs,
12 distribution tended to center around the location of the
13 manufacturing plant. This product consisted primarily of minerals
14 including casein or polyvinyl, clay, talc, limestone and mica.
15 The product included between 5.1% by weight and 14.2% by weight
16 chrysotile asbestos as a component.

17 (e) The product was a white to off-white powder. It was
18 packaged and sold in sacks of 25 lbs. Each sack was labeled with
19 the name of the manufacturer, Kaiser Gypsum Company, Inc., the
20 name of the product and directions for its use.

21 (f) This product was a dry powder which, when mixed with
22 water, formed a thick paste. Upon application it dried to a hard,
23 durable surface. It was used to tape, top and finish gypsum
24 wallboard-joints, nailheads and metal cornerbead.

25 4. One-Day Joint Compound

26 (a) The trade name of this product was Kaiser Gypsum One-Day
27 Joint Compound Powder.

28

1 (b) Kaiser Gypsum began manufacturing One Day Joint Compound
2 Powder in 1968, and chrysotile asbestos was used as a component at
3 that time.

4 (c) Kaiser Gypsum last manufactured One Day Joint Compound
5 Powder with chrysotile asbestos as a component in 1975.

6 (d) The Kaiser Gypsum California plants that made this
7 product were located at Santa Ana and Antioch. Because of the
8 heavy weight of the product, low profit margin and high
9 transportation costs, distribution tended to center around the
10 location of the manufacturing plant. The product consisted
11 primarily of casein limestone and mica. The product included
12 3.4% by weight chrysotile asbestos as a component.

13 (e) This product was a white to off-white powder. It was
14 packaged and sold in sacks of 25 lbs. Each sack was labeled with
15 the name of the manufacturer, Kaiser Gypsum Company, Inc., the
16 name of the product and directions for its use.

17 (f) This product was a dry powder which, when mixed with
18 water, formed a thick paste. Upon application it dried to a hard,
19 durable surface. It was used to fill gypsum wallboard joints,
20 embed joint reinforcing tape, finish joints and to cover and
21 finish nailhead and metal cornerbead.

22 5. Pre-Mix Joint Compound

23 (a) The trade name of this product was Kaiser Gypsum Pre-Mix
24 Joint Compound.

25 (b) Kaiser Gypsum began manufacturing Pre-Mix Joint Compound
26 in 1959, and chrysotile asbestos was used as a component at that
27 time.
28

1 (c) Kaiser Gypsum last manufactured Pre-Mix Joint Compound
2 with chrysotile asbestos as a component in 1962.

3 (d) The Kaiser Gypsum California plant that made this
4 product was located at Long Beach. Because of the heavy weight of
5 the product, low profit margin and high transportation cost,
6 distribution tended to center around the location of the
7 manufacturing plant. This product consisted primarily of minerals
8 including casein or polyvinyl, clay, talc, limestone and mica.
9 The product included chrysotile asbestos as a component. The
10 percentage presently is unknown. Investigation is continuing.

11 (e) This product was a white to off-white colored paste. It
12 was packaged and sold in cans of 4 or 5 gallons and in cartons of
13 5 gallons. Each container was labeled with the name of the
14 manufacturer, Kaiser Gypsum Company, Inc., the name of the product
15 and directions for its use.

16 (f) This product was a thick paste like material which upon
17 application dried to a hard, durable surface. It was used to fill
18 gypsum wallboard joints, embed joint reinforcing tape, finish
19 joints and to cover and finish nailheads and cornerbead.

20 6. Pre-Mix Finishing Compound

21 (a) The trade name of this product was Kaiser Gypsum Pre-Mix
22 Finishing Compound.

23 (b) Kaiser Gypsum began manufacturing Pre-Mix Finishing
24 Compound in 1959, and chrysotile asbestos was used as a component
25 at that time.

26 (c) Kaiser Gypsum last manufactured Pre-Mix Finishing
27 Compound with chrysotile asbestos as a component in 1962.
28

1 (d) The Kaiser Gypsum California plant that made this
2 product was located at Long Beach. Because of the heavy weight of
3 the product, low profit margin and high transportation cost,
4 distribution tended to center around the location of the
5 manufacturing plant. This product consisted primarily of minerals
6 including casein or polyvinyl, clay, talc, limestone and mica.
7 The product included chrysotile asbestos as a component. The
8 percentage presently is unknown. Investigation is continuing.

9 (e) This product was a white to off-white colored paste. It
10 was packaged and sold in cans of 4 or 5 gallons and in cartons of
11 5 gallons. Each container was labeled with the name of the
12 manufacturer, Kaiser Gypsum Company, Inc., the name of the product
13 and directions for its use.

14 (f) This product was a thick paste like material which upon
15 application dried to a hard, durable surface. It was used to
16 finish gypsum wallboard joints and to cover and finish nailheads
17 and cornerbead.

18 7. Pre-Mix Dual Purpose Joint Compound

19 (a) The trade name of this product was Kaiser Gypsum Pre-Mix
20 Dual Purpose Joint Compound.

21 (b) Kaiser Gypsum began manufacturing Pre-Mix Dual Purpose
22 Joint Compound in 1960, and chrysotile asbestos was used as a
23 component at that time.

24 (c) Kaiser Gypsum last manufactured Pre-Mix Dual Purpose
25 Joint Compound with chrysotile asbestos as a component in 1975.

26 (d) The Kaiser Gypsum California plants that made this
27 product were located at Long Beach, Antioch and Santa Ana.
28 Because of the heavy weight of the product, low profit margin and

1 high transportation costs, distribution tended to center around
2 the location of the manufacturing plant. This product consisted
3 primarily of minerals including polyvinyl, clay, talc, limestone
4 and mica. The product included between 1.5% by weight and 6% by
5 weight chrysotile asbestos as a component depending on the formula
6 in effect at a given date.

7 (e) This product was a white to off-white or light buff
8 colored paste. It was packaged and sold in 5 gallon metal cans or
9 plastic pails, and 4 or 5 gallon cartons. Beginning in 1966 small
10 amounts were sold in 5 quart plastic buckets as an accommodation
11 product for lumber dealers under the name 3-purpose premix
12 compound. Each container was labeled with the name of the
13 manufacturer, Kaiser Gypsum Company, Inc., the name of the product
14 and directions for its use.

15 (f) This product was a thick paste like material which upon
16 application dried to a hard, durable surface. It was used to
17 finish gypsum wallboard joints, embed joint reinforcing tape,
18 finish joints and to cover and finish nailheads and metal
19 cornerbead.

20 8. Pre-Mix Topping Compound

21 (a) The trade name of this product was Kaiser Gypsum Pre-Mix
22 Topping Compound.

23 (b) Kaiser Gypsum began manufacturing Pre-Mix Topping
24 Compound in 1968, and chrysotile asbestos was used as a component
25 at that time.

26 (c) Kaiser Gypsum last manufactured Pre-Mix Topping Compound
27 with chrysotile asbestos as a component in 1976.
28

1 (d) The Kaiser Gypsum California plants that made this
2 product were located at Santa Ana and Antioch. Because of the
3 heavy weight of the product, low profit margin and high
4 transportation costs, distribution tended to center around the
5 location of the manufacturing plant. This product consisted
6 primarily of minerals including casein or polyvinyl, clay, talc,
7 limestone and mica. The product included between 0.9% by weight
8 and 2% by weight chrysotile asbestos as a component depending on
9 the formula in effect at a given date.

10 (e) This product was a white to off-white or light buff
11 colored paste. It was packaged and sold in metal and plastic
12 buckets of 4 or 5 gallons and in cartons of 4 gallons. Each
13 container was labeled with the name of the manufacturer, Kaiser
14 Gypsum Company, Inc., the name of the product and directions for
15 its use.

16 (f) This product was a thick paste like material which upon
17 application dried to a hard, durable surface. It was used to top
18 and finish gypsum wallboard joints.

19 9. Laminating Compound

20 (a) The trade name of this product was Kaiser Gypsum
21 Laminating Compound.

22 (b) Kaiser Gypsum began manufacturing Laminating Compound in
23 1961, at which time chrysotile asbestos was used as a component.

24 (c) Kaiser Gypsum last manufactured Kaiser Gypsum Laminating
25 Compound with chrysotile asbestos as a component in 1972, at which
26 time the product was discontinued.

27 (d) The Kaiser Gypsum California plants that made this
28 product were located at Antioch and Santa Ana. These plants were

1 in operation at different times. The product was manufactured at
2 Antioch from 1961 through 1970 and at Santa Ana in 1971 and 1972.
3 Because of the heavy weight of the product, low profit margin and
4 high transportation costs, distribution tended to center around
5 the location of the manufacturing plant. The product consisted
6 primarily of soya, flour and limestone. The product included
7 between 6.5% by weight and 10% by weight chrysotile asbestos as a
8 component depending upon the formula in effect at a given date.

9 (e) This product was a white to off-white powder. It was
10 packaged and sold in sacks of 25 lbs. Each container was labeled
11 with the name of the manufacturer, Kaiser Gypsum Company, Inc.,
12 the name of the product and directions for its use.

13 (f) This product was a dry powder, which when mixed with
14 water formed a thick paste. It was used as an adhesive to
15 laminate one piece of gypsum wallboard to another, which was
16 occasionally done to create gypsum drywall partitions having
17 thicker wallboard than could be created by a single sheet. For
18 example, gypsum wallboard typically came in sheets 1/2 inch and
19 5/8 inch thick. If one wanted a gypsum wallboard that was 1 inch
20 thick, this would be created by laminating together two pieces of
21 gypsum wallboard that were each 1/2 inch thick. Laminating
22 compound was used for this purpose. Additionally, it was used to
23 laminate gypsum wallboard to sound deadening board, which would
24 increase the wall's capacity to prevent transmission of sound from
25 one room to another.

28 largely of building contractors or building materials dealers.

29 Kaiser Gypsum has some retained sales orders and sales
30 invoices for some years which identify the purchasers of Kaiser
31 Gypsum products, the dates of sale, the amount of each product
32 sold and, in some cases, the sites to which the products were to

1 be delivered. These documents do not distinguish between sales of
2 asbestos-containing products and other products.

3 (j) Sales orders and sales invoices. See also Response to
4 Interrogatory 6(b).

5 C. Decorative Texture Finishes For Interior Walls
6 or Ceilings - Asbestos Used As A Component

7 Drywall partitions or walls made from gypsum wallboard are.
8 sometimes decorated with wall covering or wallpaper that is fixed
9 to the wall by an adhesive or glue. On other occasions such walls
10 are finished by painting them. There are many varieties of paint,
11 including some that are intended to create a textured surface
12 (rather than a smooth surface). Kaiser Gypsum manufactured and
13 marketed several texture paint products that during certain years
14 used chrysotile asbestos as one of numerous components. Drywall
15 ceilings are sometimes finished with decorative products, as are
16 the cement slab ceilings found in some high-rise buildings.
17 Kaiser Gypsum also manufactured and marketed decorative texture
18 products for use on such interior ceilings that, during certain
19 years, used chrysotile asbestos as one of numerous components.
20 The Kaiser Gypsum decorative wall and ceiling texture products
21 were:

- 22 1. Cover-Tex texture paint
- 23 2. Spray-Tex or Spray Cover-Tex texture paint
- 24 3. Kaiser-Tex texture paint
4. Covertex (TSS) wall texture
- 25 5. K-Spray ceiling texture

26 Kaiser Gypsum's responses to interrogatory subparts (a)-(f)
27 for each of these products are as follows:

1 1. Cover-Tex Texture Paint

2 (a) The trade name of this product was Cover-Tex texture
3 paint.

4 (b) Kaiser Gypsum marketed Cover-Tex texture paint in 1952,

13 product were located in Redwood City and Antioch. These plants
14 were in operation at different times. The product was
15 manufactured at Redwood City from 1953 through 1957 and at the
16 Antioch plant from 1957 through 1967. Because of the heavy weight
17 of the product, low profit margin and high transportation costs,
18 distribution tended to center around the location of the
19 manufacturing plant. The product consisted primarily of casein,
20 limestone and mica. The product included between 4.4% by weight
21 and 8.6% by weight chrysotile asbestos as a component depending
22 upon the formula in effect at a given date.

23 (e) This product was a white to off-white powder. It was
24 packaged and sold in sacks of 25 lbs. and sacks of 50 lbs. Each
25 container was labeled with the name of the manufacturer, Kaiser
26 Gypsum Company, Inc., the name of the product and directions for
27 its use.

1 (f) This product was a dry powder which, when mixed with
2 water formed a texture paint. It was used to produce texture
3 effects over gypsum wallboard surfaces.

4 2. Spray-Tex Or Spray Cover-Tex Texture Paint

5 (a) The trade name of this product was Spray-Tex. Later it
6 was changed to Spray Cover-Tex texture paint.

7 (b) Kaiser Gypsum began manufacturing this product in 1956,
8 at which time chrysotile asbestos was used as a component.

9 (c) Kaiser Gypsum last manufactured Spray Cover-Tex texture
10 paint with chrysotile asbestos as a component in 1967, when the
11 product was discontinued.

12 (d) The Kaiser Gypsum California plants that made this
13 product were located in Redwood City and Antioch. These plants
14 were in operation at different times. The product was
15 manufactured at Redwood City from 1956 through 1957 and at the
16 Antioch plant from 1957 through 1967. Because of the heavy weight
17 of the product, low profit margin and high transportation costs,
18 distribution tended to center around the location of the
19 manufacturing plant. The product consisted primarily of casein,
20 limestone and mica. The product included between 6.6% by weight
21 and 36.6% by weight chrysotile asbestos as a component depending
22 upon the formula in effect at a given date.

23 (e) This product was a white to off-white powder. However,
24 some colored versions of the product were offered. It was
25 packaged and sold in sacks of 25 lbs. and sacks of 50 lbs. Each
26 container was labeled with the name of the manufacturer, Kaiser
27 Gypsum Company, Inc. The name of the manufacturer, Kaiser Gypsum
28 Company, Inc., the name of the product and directions for its use.

1 (f) This product was a dry powder which, when mixed with
2 water formed a texture paint that was used to produce texture
3 effects over gypsum wallboard surfaces.

4 3. Kaiser-Tex Texture Paint

5 (a) The trade name of this product was Kaiser-Tex texture
6 paint.

7 (b) Kaiser Gypsum marketed Kaiser-Tex texture paint in 1952,
8 but it did not manufacture the product itself. Kaiser Gypsum does
9 not know whether the product manufactured in 1952 contained
10 asbestos. Kaiser Gypsum began manufacturing this product in 1953,
11 at which time chrysotile asbestos was used as a component.

12 (c) Kaiser Gypsum last manufactured Kaiser-Tex texture
13 paint with chrysotile asbestos as a component in 1967, when the
14 product was discontinued.

15 (d) The Kaiser Gypsum California plants that made this
16 product were located in Redwood City and Antioch. These plants
17 were in operation at different times. The product was
18 manufactured at Redwood City from 1953 through 1957 and at the
19 Antioch plant from 1957 through 1967. Because of the heavy weight
20 of the product, low profit margin and high transportation costs,
21 distribution tended to center around the location of the
22 manufacturing plant. The product consisted primarily of casein,
23 limestone and mica. The product included between 4.0% by weight
24 and 8.0% by weight chrysotile asbestos as a component depending
25 upon the formula in effect at a given date.

26 (e) This product was a white to off-white powder; however,
27 some colored paints were sold. It was packaged and sold in sacks
28 of 10 lbs. and sacks of 25 lbs. Each container was labeled with

1 the name of the manufacturer, Kaiser Gypsum Company, Inc., the
2 name of the product and directions for its use.

3 (f) This product was a dry powder which, when mixed with
4 water formed a texture paint. It was used to produce texture
5 effects over gypsum wallboard surfaces.

6 4. Cover-Tex (Tss) Wall Texture

7 (a) The trade name of this product was Kaiser Gypsum Cover-
8 Tex (TSS) wall texture paint.

9 (b) Kaiser Gypsum began manufacturing Cover-Tex Wall Texture
10 in 1968, at which time chrysotile asbestos was used as a
11 component.

12 (c) Kaiser Gypsum last manufactured Cover-Tex Wall Texture
13 with chrysotile asbestos as a component in 1975.

14 (d) The Kaiser Gypsum California plants that manufactured
15 this product were Santa Ana and Antioch. These plants were in
16 operation at different times. The product was manufactured at
17 Santa Ana from 1968 through 1975 and at the Antioch plant from
18 1968 through 1975. Because of the heavy weight of the product,
19 low profit margin and high transportation costs, distribution
20 tended to center around the location of the manufacturing plant.
21 The product consisted primarily of casein, limestone and mica.
22 The product included between 4.2% by weight and 8.7% by weight
23 chrysotile asbestos as a component depending upon the formula in
24 effect at a given date.

25 (e) The product was a white to off-white powder. It was
26 packaged and sold in 50 lb. sacks. Each container was labeled
27 with the name of the manufacturer, Kaiser Gypsum Company, Inc.,
28 the name of the product and directions for its use.

1 (f) This was a dry powder which when mixed with water formed
2 a paint-like product designed for hand or spray application. When
3 dry, it produced a hard, durable surface. It was used to produce
4 texture effects over gypsum wallboard surfaces.

5 . 5. K-Spray Ceiling Texture

6 (a) The trade name of this product was Kaiser Gypsum K-Spray
7 Ceiling Texture.

8 (b) Kaiser Gypsum began manufacturing K-Spray Ceiling
9 Texture with chrysotile asbestos as a component in 1961.

10 (c) Kaiser Gypsum last manufactured K-Spray Ceiling Texture
11 with chrysotile asbestos as a component in 1975.

12 (d) The Kaiser Gypsum California plants that manufactured
13 this product were Santa Ana and Antioch. These plants were in
14 operation at different times. The product was manufactured at
15 Santa Ana from 1973 through 1975 and at the Antioch plant from
16 1961 through 1971. Because of the heavy weight of the product,
17 low profit margin and high transportation costs, distribution
18 tended to center around the location of the manufacturing plant.
19 The product consisted primarily of casein, limestone and mica.
20 The product included between 1.3% by weight and 9.9% by weight
21 chrysotile asbestos as a component depending upon the formula in
22 effect at a given date.

23 (e) The product was a white powder with polystyrene
24 aggregate. It was packaged and sold in 32 lb. sacks. Each
25 container was labeled with the name of the manufacturer, Kaiser
26 Gypsum Company, Inc., the name of the product and directions for
27 its use.

1 (f) This was a dry powder which when mixed with water formed
2 a paint-like product designed for spray application. When dry, it
3 produced a hard, durable surface. It was used to produce texture
4 effects over gypsum wallboard or interior concrete ceilings.

16 systems, grooves were cut in gypsum wallboard ceilings and
17 electrical heating cables secured in the grooves. The groove-
18 cracks were then filled and the ceiling covered with a decorative
19 finish. In other systems, electric heating wires were stapled to
20 the surface of wallboard. Then the ceiling was covered with a
21 thick decorative finish that would conceal the heating wires.
22 Kaiser Gypsum made several products for finishing such systems,
23 and these products used chrysotile asbestos as one of numerous
24 components. These Kaiser Gypsum products were:

- 25 1. Filler Compound
26 2. Radiant Heat Compound
27 3. Radiant Heat Scrimless Surfacing Compound

28 Kaiser Gypsum's responses to interrogatory subparts (a)-(f)
for each of these products are as follows:

1 1. Filler Compound

2 (a) The trade name of this product was Kaiser Gypsum Filler
3 Compound.

4 (b) Kaiser Gypsum began manufacturing Filler Compound in
5 1961, at which time chrysotile asbestos was used as a component.

13 tended to center around the location of the manufacturing plant.
14 The product consisted primarily of minerals including limestone.
15 and mica. The product used chrysotile asbestos as a component in
16 its formula but the amount of asbestos called for in the formula
17 used to manufacture the product at the Antioch plant is uncertain.
18 Investigation is continuing.

19 (e) This product was a white to off-white powder. It was
20 packaged and sold in sacks of 50 lbs. Each container was labeled
21 with contained the name of the manufacturer, Kaiser Gypsum
22 Company, Inc., the name of the product and directions for its use.

23 (f) This product was a dry powder, which when mixed with
24 water formed a thick paste. Upon application it dried to a hard,
25 durable surface. It was used to cover radiant heating system
26 ceiling surfaces.

1 2. Radiant Heat Compound

2 (a) The trade name of this product was Kaiser Gypsum Radiant
3 Heat Compound.

4 (b) Kaiser Gypsum began manufacturing this product in 1968,
5 at which time chrysotile asbestos was used as a component.

6 (c) Kaiser Gypsum last manufactured Radiant Heat Compound
7 with chrysotile asbestos as a component in 1974, when the product
8 was discontinued.

9 (d) The Kaiser Gypsum California plant that made this
10 product was located in Santa Ana, where it was manufactured from
11 1968 through 1974. Because of the heavy weight of the product,
12 the low profit margin and high transportation costs, distribution
13 tended to center around the location of the manufacturing plant.
14 The product consisted primarily of sand and white portland cement.
15 The product included between 3.3% by weight and 3.6 by weight
16 chrysotile asbestos as a component.

17 (e) This product was a white to off-white powder. It was
18 packaged and sold in sacks of 60 lbs. Each container was labeled
19 with the name of the manufacturer, Kaiser Gypsum Company, Inc.,
20 the name of the product and directions for its use.

21 (f) This product was a dry powder, which when mixed with
22 water formed a thick paste that was used to cover radiant heating
23 cables stapled to ceiling surfaces.

24 3. ...Radiant Heat Scrimless Surfacing Compound

25 (a) The trade name of this product was Kaiser Gypsum Radiant
26 Heat Scrimless Surfacing Compound.

1 (b) Kaiser Gypsum began manufacturing this product in
2 California in 1972, at which time chrysotile asbestos was used as
3 a component.

4 (c) Kaiser Gypsum last manufactured Radiant Heat Scrimless
5 Surfacing Compound with chrysotile asbestos as a component in
6 1974, when the product was discontinued.

7 (d) The Kaiser Gypsum California plant that made this
8 product was located in Santa Ana, where it was manufactured from
9 1972. Because of the heavy weight of the product, the low profit
10 margin and high transportation costs, distribution tended to
11 center around the location of the manufacturing plant. The
12 product consisted primarily of sand, silica flour and mica. The
13 product included 5% by weight chrysotile asbestos as a component.

14 (e) This product was a greenish powder. It was packaged and
15 sold in sacks of 25 lbs. and in sacks of 50 lbs. Each container
16 was labeled with the name of the manufacturer, Kaiser Gypsum
17 Company, Inc., the name of the product and directions for its use.

18 (f) This product was a dry powder, which when mixed with
19 water formed a thick paste that was used to cover radiant heating
20 cables embedded in ceiling surfaces.

3 proved unsuccessful. Kaiser Gypsum never discovered a way for
4 them to be manufactured that would allow them to effectively
5 withstand the wide variety of weather and temperature conditions
6 that exterior products confront. Those exterior gypsum products
7 were marketed in several test areas and, as in the case of
8 interior gypsum drywall products, required the use of materials
9 to fill the spaces between pieces of gypsum wallboard and to
10 provide a decorative finish. Kaiser Gypsum offered products for
11 those purposes whose components included small percentages of
12 chrysotile asbestos. These products were:

- 13 1. X-Terior Premix Prefill Compound
- 14 2. X-Terior Premix Wall Texture Compound

15 Kaiser Gypsum's responses to interrogatory subparts (a)-(f)
16 for each of these products are as follows:

17 1. X-Terior Premix Prefill Compound

18 (a) The trade name of this product was Kaiser Gypsum X-
19 Terior Premix Prefill Compound.

20 (b) & (c) Kaiser Gypsum began and ceased marketing this
21 product during 1975. Chrysotile asbestos was used as a component
22 for the brief period during which this product was manufactured.

23 (d) The Kaiser Gypsum California plant that made this
24 product was located at Antioch. The product was marketed in a
25 limited market area where exterior gypsum wallboard was being sold
26 on a test basis. Kaiser Gypsum X-Terior Premix Prefill Compound
27 was made primarily of raw gypsum, PVA emulsion and mica. The
28

1 product included 1.5% by weight chrysotile asbestos as a
2 component.

3 (e) This product was a white to off-white paste. It was
4 packaged and sold in metal cans and plastic buckets of 60 lbs.,
5 and in cartons of 48 and 60 lbs. Each container was labeled with
6 the name of the manufacturer, Kaiser Gypsum Company, Inc., the
7 name of the product and directions for its use.

8 (f) This product was a paste that was used to pre-fill
9 joints in gypsum wallboard installed on building exteriors.

10 2. X-Terior Premix Wall Texture Compound

11 (a) The trade name of this product was Kaiser Gypsum X-
12 Terior Premix Wall Texture Compound.

13 (b) & (c) Kaiser Gypsum began and ceased marketing this
14 product during 1975. Chrysotile asbestos was used as a component
15 for the brief period during which this product was manufactured.

16 (d) The Kaiser Gypsum California plant that made this
17 product was located at Antioch. The product consisted primarily
18 of limestone, acrylic emulsion and mica. The product included
19 1.5% by weight chrysotile asbestos as a component.

20 (e) The product was a white to off-white paste. It was
21 packaged and sold in 58-lb. metal cans, plastic buckets and
22 cartons. Each container was labeled with the name of the
23 manufacturer, Kaiser Gypsum Company, Inc., the name of the product
24 and directions for its use.

25 (f) This product was a white to off-white paste that was
26 used to provide surface texture to gypsum wallboard installed on
27 building exteriors.

28 * * *

1 sold, and, in some cases, the sites to which the products were to
2 be delivered. These documents do not distinguish between sales of
3 asbestos-containing products and other products.

4 (j) Sales orders and sales invoices. See also Response to
5 Interrogatory 6(b).

6 **III. Products Made At Kaiser Gypsum's Oregon Plant**

7 From 1956 to 1978 Kaiser Gypsum owned and operated a plant
8 located at St. Helens, Oregon whose basic capability was to make
9 building construction products by compressing wood fibers
10 extracted from wood chips to make various types of sheets and
11 boards.

12 **A. Firtex Products - No Asbestos Used**

13 The overwhelming majority of the products Kaiser Gypsum made
14 at its Oregon plant were sold with the trademark "Firtex." No
15 product sold under this trade name ever used asbestos as a
16 component. Firtex products included various types of materials
17 intended to provide insulation against outside temperatures or to
18 dampen noise. Such products included sheathing that was nailed to
19 walls before outer layers of bricks or siding were installed. They
20 also included sheet products for insulating roofs. They also
21 included sound deadening board that was used in partitions to
22 reduce the noise that could be heard from adjacent rooms.

23 Firtex products also included materials intended for use on
24 ceilings. One type was tiles that could be glued or tacked to
25 ceilings to reduce noise. Another group of such products was used
26 in suspended ceilings. Suspended ceilings are made by hanging a
27 wood or metal frame from the structural members of a ceiling and
28 then laying square or rectangular decorative and insulating pieces

1 into the frame. Those pieces were termed "lay-in boards." Such
2 suspended ceilings used a significant amount of the room's
3 vertical space and because that vertical space cost money to
4 build, suspended ceilings were most commonly found in commercial
5 buildings or office buildings, which typically had higher ceilings
6 than houses during the 1956-1978 period when Kaiser Gypsum made
7 the products. The Firtex line of products was quite successful,
8 and Kaiser Gypsum sold them in great volume. ==:

9 B. Mineral Fiber Products

10 1. Kaiser Gypsum Ordinary And 1-Hour Fire Rated
11 Mineral Fiberboard Products - No Asbestos Used

12 As high-rise buildings became more common in California
13 during the 1960's, building code authorities became increasingly
14 concerned about the risks of fires in those buildings and
15 encouraged the development and use of products that were less
16 likely to burn. Since its Firtex wood-chip products would burn,
17 Kaiser Gypsum sought to develop other ceiling tile and lay-in
18 board products that would be more resistant to fire. Kaiser
19 Gypsum found that the manufacturing machinery at its St. Helens,
20 Oregon plant could be used to make ceiling tiles and lay-in boards
21 for suspended ceilings with various types of mineral wool as the
22 principal component (instead of wood chips). Mineral wool is the
23 name given to products made by heating various types of rock to
24 extremely high temperature (where they melt), spinning them into
25 threads, and then letting them cool. Mineral wool looks something
26 like steel wool that is used for rubbing rust off of metal or used
27 in certain kitchen scouring pads. Mineral wool does resist fire
28 and Kaiser Gypsum was successful in developing ceiling tiles and

1 **Mineral Fibreboard - U.L. Fire Rated**
2 **(Underwriters' Laboratories, Inc. Design)**

3 (a) The trade name of this product, a mineral fiber product,
4 was Kaiser Mineral Fibreboard - U.L. Fire Rated (Underwriters'
5 Laboratories, Inc. Design). The same product was cut into ceiling
6 tiles and lay-in boards for use in suspended ceilings. It was
7 used for acoustical ceiling tile and suspended lay-in board in
8 circumstances where a 2-hour fire resistance classification was
9 specified. Both the ceiling tiles and the lay-in boards were sold
10 under the trade name "Kaiser Mineral Fibreboard-UL Fire Rated
11 (Underwriters' Laboratories, Inc. design)."

12 (b) Kaiser Gypsum began manufacturing Mineral Fibreboard-
13 U.L. Fire Rated with chrysotile asbestos as a component in 1963.

14 (c) Kaiser Gypsum last manufactured Mineral Fibreboard-U.L.
15 Fire Rated with chrysotile asbestos as a component in 1974, when
16 the 2-hour fire-rated product was discontinued.

17 (d) The plant that made this product was located at St.
18 Helens, Oregon. This product included 1.6% by weight chrysotile
19 asbestos as a component.

20 (e) This product consisted of ceiling tiles and lay-in
21 boards with face side white or colored and with perforated or
22 fissured design for acoustical treatment. The tiles were 1/2" or
23 5/8" by 12" by 12" and the lay-in boards came in two sizes: 1/2"
24 or 5/8" by 24" by 24" and 1/2" or 5/8" by 24" by 48." They were
25 packaged and sold in boxes of various quantities. The boxes
26 contained the name of the manufacturer, Kaiser Gypsum Company,
27 Inc., the name of the product and other printed material. Kaiser
28 Gypsum's 2-hour fire-rated ceiling tiles and suspended ceiling

1 lay-in board products (in which chrysotile asbestos was used as a
2 component) were required to be specially marked because they
3 looked similar to other Kaiser Gypsum mineral fiberboard ceiling
4 tiles and lay-in boards (that did not contain asbestos as a
5 component) and building inspectors wanted to be able to check to
6 make sure that products with a 2-hour fire resistance
7 classification actually were being used by the building contractor
8 when those had been specified. It is believed that 2-hour fire-
9 rated ceiling tile and suspended ceiling lay-in board was stamped
10 on the back with either the initial "KG" or the word "Kaiser
11 Gypsum." It is believed that this marking was employed during the
12 entire period that the 2-hour fire-rated products were
13 manufactured by Kaiser Gypsum.

14 (g) Kaiser Gypsum is unsure as to the intended meaning of
15 "The U.S. Government's 'Qualified Products List'," but has no
16 knowledge that any of its 2-hour fire-rated mineral fiberboard
17 products ever appeared on such a list.

18 (h) Kaiser Gypsum is aware of the following suppliers of
19 asbestos:

25 Johns-Manville

1 Current addresses, if any, are not known to Kaiser Gypsum.
2 Most of the specific time periods during which these firms
3 supplied asbestos are unknown.

4 (i) (i through iii) Kaiser Gypsum is not aware of ever
5 selling such products to shipyards, power companies or refineries.

6 Kaiser Gypsum sold such products to non-governmental customers in
7 California from approximately 1963 to 1974. These customers
8 consisted largely of building contractors or building materials
9 dealers.

10 Kaiser Gypsum has some retained sales orders and sales
11 invoices for some years which identify the purchasers of Kaiser
12 Gypsum products, the dates of sale, the amount of each product
13 sold, and, in some cases, the sites to which the products were to
14 be delivered. These documents do not distinguish between sales of
15 asbestos-containing products and other products.

16 (j) Sales orders and sales invoices. See also Response to
17 Interrogatory 6(b).

18 **IV. Types Of Products Kaiser Gypsum**
19 **Never Made And Never Marketed**

20 Kaiser Gypsum has never mined, milled or marketed asbestos.
21 Kaiser Gypsum never designed, manufactured, or marketed any
22 product in which amosite, crocidolite or other amphibole forms of
23 asbestos was used as a component. Kaiser Gypsum never designed,
24 manufactured, or marketed floor tile, pipe insulation or pipe
25 covering, refractory products, boiler insulation, acoustical
26 plaster, or sprayed fireproofing or sprayed thermal insulation
27 products. Kaiser Gypsum never designed, manufactured or marketed
28 any sort of brake products. It never designed, manufactured or

1 marketed paper products, textile products, or roofing products in
2 which asbestos was used as a component. Kaiser Gypsum never
3 designed, manufactured or marketed any products intended for use
4 in ships or shipyards, or any products intended for use in trains
5 or other railroad equipment or railroad facilities.

6 V. Null-A-Fire Type-X Gypsum Wallboard -
7 Allegedly Contaminated Vermiculite Ore

8 This part of Kaiser Gypsum's response, though not directly
9 called for by the subject interrogatories, is being made in light
10 of earlier versions of Kaiser Gypsum's responses to these
11 interrogatories and evolving knowledge, in the context of
12 historical regulatory uncertainties and disputes about whether
13 vermiculite ore used as a component in some Kaiser Gypsum Null-A-
14 Fire Type-X Gypsum Wallboard products may have been contaminated
15 in a way that caused certain workers to be exposed to airborne
16 "asbestos." Kaiser Gypsum's position is that no Kaiser Gypsum
17 Null-A-Fire Type-X Gypsum Wallboard using vermiculite ore as a
18 component could have been a substantial contributing factor to any
19 disease caused by exposure to airborne asbestos fibers.

20 As background, in 1954 Kaiser Gypsum introduced Null-A-Fire
21 brand wallboard, a 5/8" thick gypsum wallboard that was approved
22 by the Research Committee of the Pacific Coast Building Officials
23 Conference and certified by the National Board of Fire
24 Underwriters for a one-hour fire rating. This product was
25 developed in response to the appearance of California building
26 code requirements that walls in several types of public buildings
27 must have such one-hour fire resistance. The term one-hour fire
28 rating meant that, when used as a wall surface, the gypsum

1 wallboard would resist the passage of flame and heat for at least
2 one hour. The certified product had to be made in accordance with
3 Underwriters Laboratories Code No. 3543. Wallboard products that
4 were fire rated were labeled as "Type X" to distinguish them from
5 ordinary gypsum wallboard products that had not passed fire-rating
6 tests.

7 When introduced in 1954, the primary component of Kaiser
8 Gypsum's Null-A-Fire wallboard was gypsum stucco, which is the
9 gypsum plaster that forms the greatest percentage by weight of all
10 gypsum wallboard. Gypsum plaster, including wallboard stucco,
11 does not burn, and consequently, all gypsum plaster and gypsum
12 drywall construction poses less risk of fire than does wall
13 construction featuring wood or plastic paneling. However, the
14 ordinary 5/8" gypsum wallboard did not pass the one-hour fire
15 test, because the heat of the test caused the gypsum plaster to
16 shrink and crack, letting the fire through in less than an hour.
17 Kaiser Gypsum found that by adding small proportions of glass
18 fiber and perlite a board could be constructed that would resist
19 shrinking and cracking under the heat of the fire test for the
20 required one-hour period. Perlite is a very light substance,
21 white in color, that looks like puffed breakfast cereal. It is
22 often used in soil for potted plants to help keep the soil from
23 caking. Perlite is made by heating little pieces of volcanic
24 glass to very high temperatures, which causes them to pop like
25 popcorn.

26 Kaiser Gypsum continued to market its Null-A-Fire Type X
27 gypsum wallboard products that contained perlite for more than a
28 decade following their introduction in 1954. However, other

1 manufacturers introduced fire-rated wallboard products that used
2 vermiculite instead of perlite to provide added fire protection.
3 Vermiculite is a mica-like mineral found in the ground in a number
4 of places. In the 1890's it was known by gold prospectors as
5 "fool's gold," because it sparkled in the sun like precious metal.
6 Vermiculite does not weigh much, which makes it useful as a
7 component of construction materials and the melting point of
8 vermiculite is about 2500 degrees, which makes it valuable as
9 fireproofing.

10 Vermiculite consists of many layers of thin plates that have
11 small amounts of water trapped in them. When heated, the water
12 turns to steam causing these plates to expand. Such expanded
13 vermiculite is used by nurseries everywhere to help hold air and
14 moisture in plant soil so that young plants will grow faster and
15 stronger.

16 Until 1965, Kaiser Gypsum could not use vermiculite to
17 provide fire protection in gypsum wallboard, because other
18 companies had secured patents from the United States government
19 which gave them exclusive rights to use vermiculite in their
20 gypsum wallboard products. In 1965, Kaiser Gypsum secured patent
21 licenses from other companies which authorized Kaiser Gypsum to
22 begin with vermiculite in its wallboard products to provide
23 increased protection against fire. Kaiser Gypsum then began to
24 develop such wallboard products and to present them for fire-
25 testing. Since vermiculite expands when it is heated, vermiculite
26 used in a wallboard tends to offset the shrinkage that occurs in
27 gypsum when it is heated, and thus, vermiculite could serve to
28 help a wallboard to hold its shape and provide the desired fire

1 protection. Because the capacity to expand was desired, the
2 Kaiser Gypsum products used as the ingredient vermiculite that had
3 not previously been heat-expanded. This unexpanded vermiculite
4 was referred to sometimes as vermiculite ore. When testing and
5 fire code authorities recognized and certified these Kaiser Gypsum
6 products as fire-rated, or qualified to be marketed as "Type X,"
7 Kaiser Gypsum began marketing vermiculite-containing gypsum
8 wallboard under its Null-A-fire brand. Kaiser Gypsum manufactured
9 limited quantities of 1/2" Null-A-Fire Type X wallboard beginning
10 in 1967, and began manufacturing 5/8" Null-A-Fire Type X wallboard
11 in 1969. It continued to market such products until it disposed
12 of the last of its gypsum business in April 1978. Like other
13 wallboard products, those Null-A-Fire wallboards consisted
14 primarily of gypsum plaster. The formulas varied over the years
15 but the vermiculite ore percentage did not exceed 4% by weight of
16 the products.

17 Controversy concerning vermiculite reflects the regulatory
18 proposals published and regulations adopted by the U.S.
19 Occupational Safety and Health Administration ("OSHA") and the
20 responses of vermiculite companies to those government actions.
21 OSHA is a U.S government agency, created by federal legislation in
22 1970, that adopts and enforces workplace safety and health
23 regulations. OSHA has been politically controversial from the
24 beginning. California originally established a parallel state
25 program administered by its Division of Occupational Safety and
26 Health, but that agency and program were terminated several years
27 ago.

1 The federal OSHA undertook to regulate exposure to "asbestos"
2 in the workplace as one of its first regulatory undertakings, and
3 OSHA adopted regulations on asbestos in 1972. (See Kaiser
4 Gypsum's response to Interrogatory No. 15, below.) Thereafter, it
5 undertook to enforce those regulations. In due course, it began
6 to threaten manufacturers who used various substances other than
7 asbestos with charges of violating the OSHA asbestos exposure
8 regulations. This triggered a long-lasting legal and scientific
9 dispute concerning what minerals are "asbestos" for purposes of
10 the OSHA regulations and what minerals should be regulated like
11 asbestos even if they are not asbestos.

12 In that context, vermiculite supplier W.R. Grace & Co.
13 (hereinafter "Grace") issued an "Important Notice to Vermiculite
14 Ore Processors," dated March 17, 1976 warning that "employers of
15 workers handling vermiculite ore" should be "aware of the OSHA
16 regulations," because OSHA was applying them to Grace vermiculite
17 plants and proposed to make the regulation of dust more strict
18 under the regulations. Grace stated that the issues related to
19 vermiculite reflected a "tramp" mineral "found in vermiculite
20 deposits" named "tremolite, defined by OSHA as one of the asbestos
21 family." Disputes over these OSHA proposals persisted for years.
22 Then, on June 20, 1986, OSHA published in the Federal Register (at
23 51 Fed. Reg. 22612) a "Final Rule" that defined "asbestos" to
24 include "tremolite" and applied asbestos exposure limits and
25 warnings to tremolite. However, shortly thereafter those
26 regulations were "stayed," that is, not made effective, by OSHA as
27 to tremolite and several other minerals to prevent the federal
28 courts from deciding whether the regulations were "arbitrary and

1 capricious." (See 51 Fed. Reg. 37002; Oct. 17, 1986.) The
2 scientific and regulatory debate continued for more years until
3 OSHA published regulations in 1992 (57 Fed. Reg. 24310; June 8,
4 1992) declaring that some tremolite is "platy" or non-fibrous, and
5 "platy tremolite" would not be deemed to be asbestos.

6 However, OSHA found other tremolite was fibrous or
7 "asbestiform" and that such "asbestiform tremolite" would be
8 regulated as asbestos. OSHA further limited these regulations by
9 providing that even products with asbestiform tremolite would not
10 be subject to asbestos regulation if asbestiform tremolite "is
11 present in a product in concentrations less than 1.0 percent by
12 weight."

13 Kaiser Gypsum admits that for a limited number of years some
14 of its Null-A-Fire products contained vermiculite, but Kaiser
15 Gypsum denies that these products contained asbestiform tremolite.
16 Kaiser Gypsum further contends that any attempt under state law to
17 deem any products that have less than the amount that would
18 subject them to federal regulation to be asbestos-containing
19 products would be preempted by federal law and the Supremacy
20 Clause of the U.S. Constitution.

21 RESPONSE TO INTERROGATORY NO. 11:

22 Not applicable.

23 RESPONSE TO INTERROGATORY NO. 12:

24 Kaiser Gypsum is unaware of entering into any such rebranding
25 agreements.

26 RESPONSE TO INTERROGATORY NO. 13:

27 During 1952 Kaiser Gypsum purchased Joint Cement, Cover-Tex
28 texture paint and Kaiser-Tex texture paint from Wesco Waterpaints,

1 Inc., then located in Berkeley, California, that was packaged in
2 Kaiser Gypsum's name. It is unknown to Kaiser Gypsum whether
3 asbestos was used as a component of those products. During
4 December 1953, after Kaiser Gypsum began manufacturing joint
5 compounds and texture paints, Kaiser Gypsum entered into an
6 agreement with Wesco Waterpaints, Inc., then located in Berkeley,
7 California, to purchase joint cement, topping compound and texture
8 paint packaged in Kaiser Gypsum's name for a period of 90 days.
9 It is unknown to Kaiser Gypsum whether any purchases were made
10 pursuant to this agreement or whether any products purchased had
11 asbestos as a component. In an abundance of caution, Kaiser
12 Gypsum is providing the information it has obtained from its
13 records. Kaiser Gypsum has no information demonstrating that any
14 product obtained from Wesco Waterpaints, Inc. was an asbestos-
15 containing product. Kaiser Gypsum knows of no other agreement
16 entered by it that provided for rebranding any product of another
17 company's which may have been an asbestos-containing product in
18 Kaiser Gypsum's name for sale in California.

19 RESPONSE TO INTERROGATORY NO. 14:

20 Kaiser Gypsum did not purchase or acquire asbestos from the
21 "General Service Administration" or any branch or agency of the
22 United States Government.

23 RESPONSE TO INTERROGATORY NO. 15:

24 Yes, as to products marketed in 1972 or thereafter.

25 (a) Beginning in 1972, in response to regulations adopted by
26 the U.S. Occupational Safety and Health Administration (see 37
27 Fed. Reg. 11318, June 7, 1972), Kaiser Gypsum affixed caution
28 labels to the packages and containers of its asbestos-containing

1 products. The OSHA regulations requiring this label were made
2 subject to the limitation that "no label is required where
3 asbestos fibers have been modified by a bonding agent, coating,
4 binder, or other material so that during any reasonably
5 foreseeable use, handling, storage, disposal, processing, or
6 transportation, no airborne concentrations of asbestos in excess
7 of the exposure limits prescribed in paragraph (b) of this section
8 will be released." In light of then-existing ambiguities as to
9 what tests OSHA would recognize as adequate to demonstrate a
10 product's falling within this exception, Kaiser Gypsum applied the
11 caution label to all its then-manufactured products in which
12 chrysotile asbestos was used as a component.

13 Initially, the labels were four inches by eight inches in
14 size and had yellow backgrounds with red letters. They were
15 affixed to the bag or container of the product by adhesive in a
16 prominent place. Later, as new bags and containers were
17 purchased, the labels were printed onto the side of the bag or
18 container and are believed to have been the same color or colors
19 as the bag/container or the printing thereon. The label read:

20 CAUTION: contains asbestos fibers; avoid
21 creating dust; breathing asbestos dust may
22 cause serious bodily harm.

23 (b) Beginning in 1972; exact date unknown.

24 (c) This label caution remained the same during the
25 remaining time the products upon which it was used continued to
26 use asbestos as a component.

27 RESPONSE TO INTERROGATORY NO. 16:

28 Not applicable.

1 RESPONSE TO INTERROGATORY NO. 17:

2 Most of Kaiser Gypsum's products were sold in the form of a
3 powder or paste; therefore, the name of the company was on the
4 packaging of the product. However, Kaiser Gypsum's 2-hour fire-
5 rated ceiling tiles and suspended ceiling lay-in board products
6 (in which asbestos was used as a component were specially marked
7 because they looked similar to other Kaiser Gypsum mineral
8 fiberboard ceiling tiles and lay-in boards (that did not contain
9 asbestos as a component) and building inspectors wanted to be able
10 to check to make sure that 2-hour fire-rated products actually
11 were being used by the building contractor when those had been
12 specified. It is believed that each piece of 2-hour fire-rated
13 ceiling tile and suspended ceiling lay-in board was stamped on the
14 back with either the initial "KG" or the word "Kaiser Gypsum."
15 Such marking was employed during the entire period that the 2-hour
16 fire-rated products were manufactured by Kaiser Gypsum.

17 RESPONSE TO INTERROGATORY NO. 18:

8 RESPONSE TO INTERROGATORY NO. 19:

13 Kaiser Gypsum has retained a number of brochures, pamphlets,
14 catalogs and other product information documents. Many of these
15 documents discuss both asbestos-containing products and other
16 products, and many of the documents are similar. For these
17 reasons, rather than attempting to identify each individual
18 document, Kaiser Gypsum will make representative documents
19 available for inspection upon reasonable notice at the offices of
20 Dillingham & Murphy, 225 Bus, 6th Floor, San Francisco,
21 California.

22 (a) through (c) - See statement above.

23 (d) To provide potential users of such products with
24 information about the products.

25 (e) Some of these documents still exist.

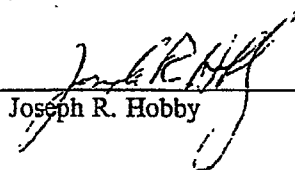

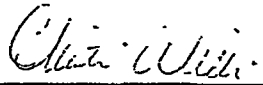
