Dear Dr. Hamlin:

Upon returning to the office after an absence of several weeks, I find a letter from Roy Gardner in which, among other things, he expresses interest in the project on siderosis which we discussed. He says, as you probably know, that the investigation ties in with another project which he has underway for Dr. Cranch of Union Carbide.

I discussed the possibility of the Foundation helping support this investigation with Dr. Lanza, Chairman of our Medical Committee, in New York last month. We left it that the Committee would give the project further consideration upon receipt of Dr. Gardner's proposal. As I recall, during our discussion here, you were to provide us with a copy of this proposal which Jack reviewed at our meeting. Accordingly, I would like to have this at your convenience in order that it may be transmitted to the Medical Committee.
