MEMBRANE FILTER METHOD

"Measurement of Airborne Asbestos Fiber by the Membrane Filter Method" has been prepared under the auspices of the Air Hygiene & Manufacturing Committee of the Asbestos Textile Institute to fill the need for instruction in the accurate measurement of airborne asbestos fiber in order to conform with Federal, State and Provincial statutory requirements for Asbestos Threshold Limit Value. The procedure described represents the technique approved for use in ATI members own plants. EDITORIAL

For some time we have been concerned with the many misleading or erroneous statements reported by various communications media to the effect that the manufacture and use of asbestos and asbestos-based products pose hazards to occupational and public health. Allegations that asbestos is a threat to the general public as well as to those occupationally exposed to its dust have been voiced by many groups, both public and private. Acceptance of the unfounded claims as "fact" has led to some large U.S. cities considering proposals to ban the use of asbestos-containing spray insulations used in building construction.

There has long been the need for a spokesman to represent the Asbestos Industry to present the known facts, as they are, based on extensive medical research.

We in the Asbestos Industry know that asbestos is a valuable material and that it greatly contributes to the comfort and safety of humanity. We also know asbestos does present certain occupational health hazards and that through improved industrial hygiene practices the Industry is effectively controlling the hazard to asbestos factory and mine workers. We know the Industry is cooperating to establish effective dust control in construction work. We know that the effects of asbestos are both dose and time related. And we know there is presently no evidence of a hazard to the general public from exposure to the minute amounts of asbestos that may be present in community air.

BUT THE PUBLIC AT-LARGE DOES NOT KNOW THESE FACTS.

We are pleased to report that the Asbestos Industry has taken a positive step to meet the increased need for a competent, reliable source of accurate and complete information concerning the effects of asbestos dust on human health — Eight leading asbestos products manufacturers in the United States have organized the *Asbestos Information Association/North America*.

The basic objectives of AIA/NA are to (1) provide an authoritative channel of communication, (2) publicly rebut irresponsible and uninformed criticism, and (3) disseminate information on the uses of asbestos in our modern technological society.

It was our privilege to attend a "background briefing" of AIA/NA where we were provided with factual informa-

THE HISTORY OF THE ASBESTOS TEXTILE INDUSTRY IN THE UNITED STATES

Chapter VII: General Asbestos & Rubber Company (now a division of Raybestos-Manhattan, Inc.)

The history of the General Asbestos & Rubber Company is a prime example of my premise that the steam engine is the father of the asbestos textile industry.

In the year 1895 there was, in the City of Charleston, North Carolina, a busy industry known as the Charleston Iron Works. This company manufactured pumps and steam engines for the phosphate industry in South Carolina.

The predecessor company of General Asbestos & Rubber Company was the Charleston Metallic Packing Company. The founders were Samuel Hughes and George W. Williams. The State Charter issued July 18, 1895, described the firm as "a manufacturer of steam, hydraulic and other packings used in the mechanical arts." Its original and primary account was the Charlestown Iron Works.

The original factory was located on Cumberland Street near Meeting Street in downtown Charleston. The business grew steadily and it was recapitalized several times. Four additional downtown locations were used. By 1900 the management decided to produce its own asbestos yarn and cloth and Building #5 at Columbus and East Bay Streets was rented from the American Tobacco Company to house the original cards, spinning frames, twistors and looms.

On February 1, 1910, the Secretary of State authorized the changing of the name of the firm to General Asbestos & Rubber Company. The new Charter was issued to C. Bissell Jenkins, Sr., M. B. Barkley, J. P. Thomas and W. F. Taylor, being a majority of the Board of Directors.

By 1914 the business had outgrown the five downtown locations and Lockwood Green was commissioned to build a new plant on the present site at North Charleston, adjacent to the Charleston Naval Shipyard.

On May 1, 1916, Samuel Hughes II, son of the original founder, joined the company as an engineer. He was largely responsible for the continuing development of the Garco line
