For interview with Dr. Robert A. Kehoe:

INTRODUCTION

This is an interview with Dr. Robert A. Kehoe about his recollections and impressions of Mr. Charles F. Kettering. Dr. Kehoe is director of the Department of Preventive Medicine and Industrial Health, University of Cincinnati, and director of the Kettering Laboratory and of the Institute of Industrial Health at that university, as well as Medical Director of Ethyl Corporation. He has had many associations with Mr. Kettering beginning in 1924. The interview was recorded on October , 1960, by T. A. Boyd.

INTERVIEW

Dr. Kehoe, you kindly gave me in 1948 an account of your associations with Mr. Kettering, of how in the summer of 1924 you were called to the then General Motors Chemical Company at Dayton to look into a critical health situation which had developed there in the handling of concentrated tetraethyl lead, and something of the events and the investigations which followed and resulted in provisions by which tetraethyl lead as an antiknock agent in gasoline could be used without any hazard to health. This interview is intended as an extension of that one 12 years later in which you may speak further of any of the subjects discussed then or of anything else that may be in your mind. How would you like to begin?

In what you did to throw practical safeguards around the use of tetraethyl lead in gasoline you made it possible for one of Mr. Kettering's major developments, and one which had huge economic importance, to fulfill its purpose. Is there anything about your experiences in that endeavor that you would like to record?

In what few suggestions I have made, I have perhaps overlooked areas of particular importance and interest. So won't you please recount whatever else of your recollections and impressions of Mr. Kettering that you think would be of interest?
