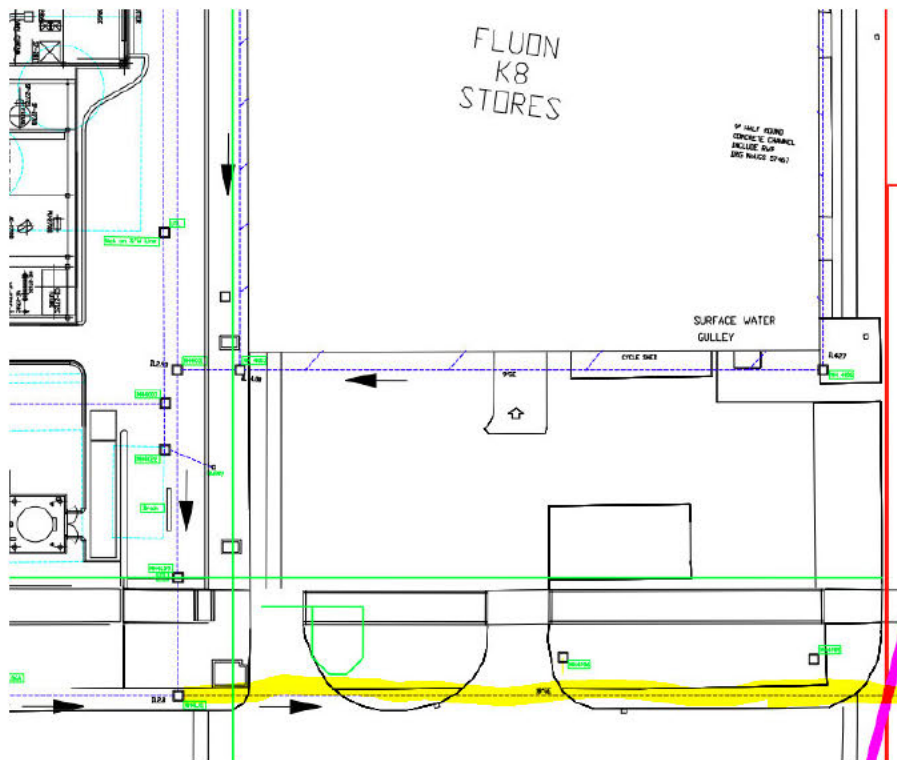
- Manhole card included for MH2H07 (grid ref J3) but based on observations on site believe this does not ultimately drain in the direction of Hillylaid pools (see comment below on sheet 4 MH4L01)

Drainage Plan sheet 3 - Rev B, last updated 03/02/2012

- Manhole card included for MH3J02 (grid ref P6) this is the connection from storm water to AGC effluent drainage system.

Drainage Plan sheet 4 - Rev B, last updated 03/02/2012

- We have included the manhole card for MH4L01 (grid ref K6) but based on observations on site believe this does not drain in the direction of Hillylaid pools (MHSQ01 – no manhole card, grid ref E10 on sheet 5). This is the drain shown to the south of K8 stores highlighted below.



Drainage Plan sheet 5 - Rev B, last updated 03/02/2012

These drawings need to be updated to confirm drainage to Hillylaid pools and confirm observations on site.

Access to W2 Hillylaid Pools / W3 Royles Brook

We have arranged a site meeting to review locations and safe access for upstream/downstream locations for accessing Hillylaid Pools / W3 Royles Brook.

The Royles Brook upstream location from the AGC plant and photos are included the link for info. Once we have confirmed access and proposal sample method for all locations, we'll let you know.

Updated draft Regulation 61 Feedback

We noticed that there are no formal timescales on AGCCE submitting the data back to EA or periods for EA review of proposals. We are anticipating providing the information in stages over a 24-month period and can develop a programme based on the date the notice is served.

Apologies for not getting back to you sooner I have been off work for quite a bit of July. Note, I also have holiday booked 4th – 20th August best contact will be [REDACTED] if you need anything over this period.

Regulation 61 – meeting with our internal team planned for this Thursday and plan to get comments back to you by the end of this week.

Did you receive the presentation slides I sent on 07/07/2023? [REDACTED] had an issue receiving and I resent last week. We removed some slides due to confidentiality but if there is anything specific you need, please let us know.

In response to your questions following the visit:

- We will review and mark up drainage plans and will send these across to you.
- We have not completed any PFAS monitoring at W2 Hillylaid Pools / W3 Royles Brook.
 - Not 100% sure how we could sample W2. Understand that Hillylaid Pools is culverted and not accessible, but we will review this as part of the drainage plans and see if access would be available via any manholes on the Hill House site. There might also be public access to Hillylaid Pools downstream (off site) closer to the River Wyre.
 - For W3 sampling would be possible upstream of our discharge point.
 - I'll try and get some photos of these locations for you and send across with the drainage plans.
- Photos – I have shared a link with you to access these. Link will be valid for ~ 1 month, please download photos you require/let me know if you need any other reminders.
