We have been made aware through our Japanese colleagues that Environment Agency commissioned work to develop socioeconomic analysis to prepare for a potential future restriction on dispersive uses of PFAS under UK REACH. This is done by consultants, EFTEC and WCA. WCA consultant contacted one of the industrial associations asking for information on the PFAS in the following dispersive applications to be sent by the 13th of November:

1. Surface coatings (including packaging)
2. Paints, printing inks and varnishes
3. Coatings on textiles, upholstery, leather, apparel, and carpets (TULAC)
4. Cleaning agents, varnishes, polishes, and waxes
5. Lubricants
6. Drilling fluids and mining
7. Cosmetics
8. Personal protective equipment
