It has been a long time. Keri Norris, Jeff Bell, and I were together in DC two weeks ago, and we were talking about you and our meeting with you and Harlan way back when, which led to our great victory at the FTC. I am sure your ears were ringing.

I am writing at Keri's suggestion to see if you might be able to help secure EPA Chairman Scott Pruitt's participation at an event we are hosting on the first 100 days of the Trump Administration. (See below) The event is scheduled for Wednesday, May 3, 2017, at the Watergate Hotel in Washington, D.C. and we would like to feature Chairman Pruitt as a keynote speaker. - A large audience of thought leaders from a diverse list of companies, organizations, and communities, such as Baker Hughes, BP, Caterpillar, Chevron, ExxonMobil, Halliburton, Daimler, Dell, Keystone Consolidated Industries, JPMorgan Chase, Mars, Nestle, Samsung, Shell, Sprint, Steel Manufacturers Association, U.S. Chamber of Commerce, U.S. Steel Corporation, Verizon, and many others
- A platform to help contribute to the news cycle on a day that will receive concentrated media focus at the premier program commemorating the 100th day in D.C. and build relationships with other senior administration officials and Members of Congress, as well as the business and legal community

We really would like to have Chairman Pruitt on the program, and one of my partners (Joseph Corrigan) has reached out to his office as well. 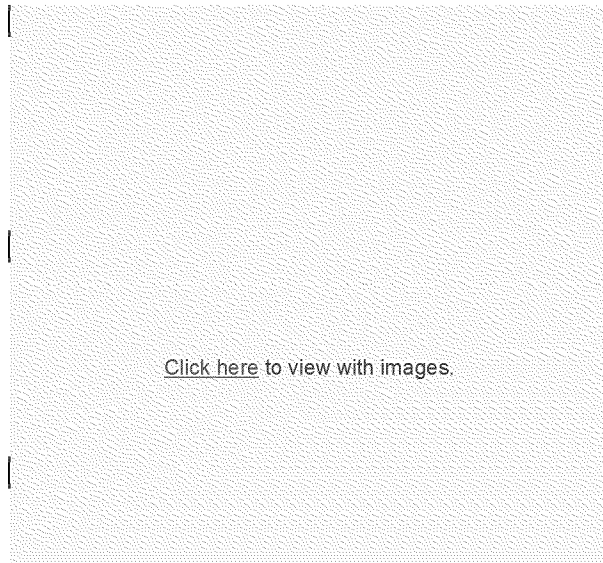

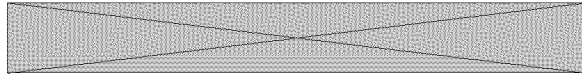
