In July Henry Alden Sherwin opened a Retail Paint store at 118 Superior Street, Cleveland, Ohio. The business consisted of wholesaling and retailing paints, oils, and varnishes. Partners in the enterprise were H. A. Sherwin, Truman Dunham, and G. O. Griswold.

One traveling representative was engaged. The sales in this first year amounted to \$400,575.44.

A Linseed Oil works were built at Cleveland, which was the company's first step towards the developments which later gave to Sherwin-Williams direct control over practically all raw materials entering into the manufacture of its products. A year of organization, expansion, good business methods, systems, credit, etc.

On February 3rd, Messers Truman Dunham and G. O. Griswold retired from the firm, and a new partnership agreement was signed by Mr. Sherwin and Mr. Edward Porter Williams under the name, Sherwin, Williams & Co.

Thus started a remarkable business relationship which lasted throughout the remainder of the lives of both Mr. Sherwin and Mr. Williams.

In April Mr. S. P. Fenn was engaged as bookkeeper of the newly organized business.

The store and office were moved from 118 to 126 Superior Street, Cleveland, and a warehouse engaged in the rear, opening on Long Street.

New partnership agreement formed, admitting Mr. W. H. Glover. (See partnership agreement in exhibit case file, Historical Collection). Financial panic in Fall of 1873 weathered unscathed.

Reorganizing the growing demand for ready mixed paint, on September 30th, 1880, produced the first high grade outside house paint under the name of "Painter's Prepared Paint." A few months later, January 4th, 1881, the name was changed to "Sherwin-Williams Paint."

Also added to the line: Paste Colored Paints.

Mr. J. C. Beardslee joined the company at Cleveland.

Sales in this year amounted to \$444,771.48.

First can of SWP 355 kept in Mr. Sherwin's personal desk until 1916 when shortly before his death he gave it to Mr. Sieplein to be opened at the 50th Anniversary Convention, by Phil Steyer. A panel was painted in the presence of the assembled representatives, the package was again sealed up and is being kept in the Historical Collection for opening in 1966 on the 100th Anniversary.

On May 18th, a fire destroyed a large part of the Cleveland factory. Loss \$70,000.00. The land on which this building had stood, previously leased, was immediately purchased, and construction of a new plant started at once.

On July 14, 1884, articles of incorporation were drawn up, under the name The Sherwin-Williams Co. Charter of incorporation was granted July 18th. Sherwin, Williams & Co., of Chicago was transferred to The Sherwin-Williams Co. Capital of the corporation amounted to \$300,000.00.)

Engaged Mr. Percy Neyman, graduate of Massachusetts Institute of Technology as chemist. (check-for-accuracy)

Large fire at Cleveland Lumber Yard, across the river from our plant, but our plant was fortunately undamaged. (See Mr. Williams letter in Historical Collection to Phil Steyer thanking him and other employees for heroic work during the fire.

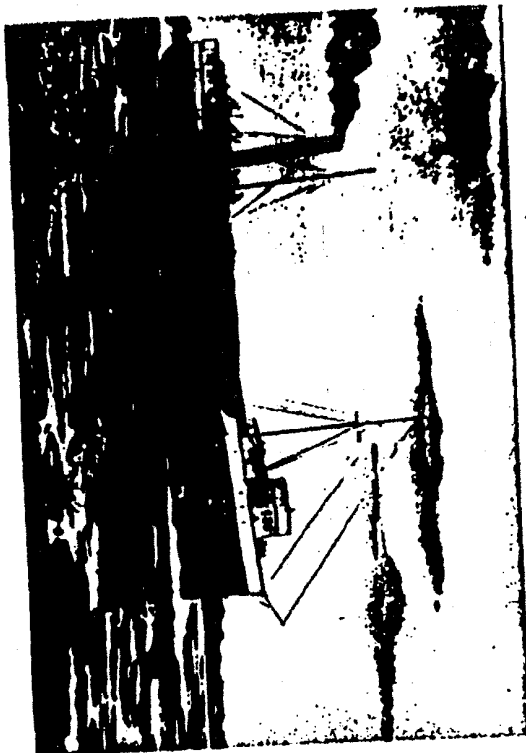

The Sherwin-Williams Co's. Lake

THE SHERWIN-WILLIAMS Co. has, since 1870, been much interested in supplying paints for lake vessels and as such has been involved in Great Lakes shipping. At one time the Company actually participated in this great industry.

Among many other features, the Company early operated a subsidiary, The Cleveland Box Company, to manufacture wooden packing boxes for the shipment of paints. This factory was located on Stones Levee with a dock on the Cuyahoga River. Lumber for boxes was brought down by boat from Duluth and upper lake lumber ports. In 1890 freight and handling had developed to such an extent that it seemed to justify the purchase of a boat to be operated solely for this purpose.

Accordingly, The S-W Transit Co. was organized and the steamer A. G. Lindsay purchased. This ship was built in 1889 by the Detroit Dry Dock and Engine Company. She had a wooden hull 196 feet long, a 37-foot beam and a 22-foot depth, and a gross tonnage of 1354 tons. She was equipped with a two-cylinder F and A engine and two fire box boilers. Under favorable conditions she could develop a speed of eight or nine miles an hour. This shipping undertaking proved very satisfactory and operated profitably for several years. Lumber was brought down the lakes and return cargoes of coal or other materials were then taken up.

Mr. E. L. Trautman, who at that time was specially interested in the Company's box manufacture, relates that on one trip the Lindsay contracted to take a considerable quantity of dynamite on the up trip to Duluth. The captain being a little nervous about this unusual cargo, conveniently arranged some urgent business which required him to stop over in Chicago, so he had the mate take charge of her to the port where this hazardous cargo was delivered. The captain, finishing his mission in Chicago, traveled by rail to board the ship at the head of the lakes.

The Walter H. Cottingham Co., Ltd., of Montreal was definitely established, and offices opened in Montreal, where a factory was also put into operation. Mr. E. M. Williams was sent to Montreal to supervise the establishment of the business there.

The Cottingham Varnish Co., of Montreal, having been organized the previous year, bought additional land in Montreal, erected a plant, and started the manufacture of varnish.

Mr. Walter H. Cottingham appointed Resident Manager of The Walter H. Cottingham Co., and the Cottingham Varnish Co.

Organized the Old Colony Paint Co., of Boston, which took over the Sherwin-Williams warehouse in Boston.

Organized the Orange Belt Co., Los Angeles, Cal., for retail business.

Sold out the Atheron Paint Co., of Worcester, Mass.

Added Brighten up Stains to the regular line.

Sales in this year amounted to \$1,117,060.80.

(1905) In this year, the Company adopted the "Cover-the-Earth" trade-mark as its official trade-mark, replacing the older mark of the Chameleon on the painter's palette. This Cover-the-Earth design had been made first by Mr. George W. Ford in 1895 for use on some enclosures planned for the Worcester store, and the idea "took" with the Company, and came thus to be officially adopted.
