Health Hazards

Dusts resulting from handling Phthalocyanine Green Y GT-805-D are considered as inert or nuisance dusts.

The U.S. Department of Labor (OSHA) has ruled that an employee's exposure to nuisance dust in any eight-hour work shift of a forty-hour week shall not exceed a Time Weighted Average of 15 mg/m³ total dust or 5 mg/m³ respirable dust.**

The American Conference of Governmental Industrial Hygienists (ACGIH) recommends a Threshold Limit Value, TLV[®], for a nuisance dust of 10 mg/m³ total dust or 5 mg/m³ respirable dust. Du Pont has elected to observe the ACGIH limit in handling Phthalocyanine Green Y GT-805-D.

Safety Precautions

Good general ventilation should be provided to keep dust concentration below nuisance dust exposure limits. A chemical cartridge mask with a suitable dust filter should be used in areas where the nuisance dust limits are exceeded.
