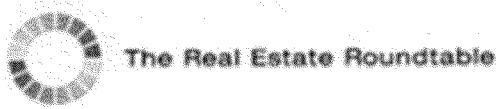

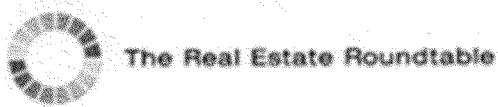
Got it. Thanks for getting back to me, and if plans change please let me know. We can be fluid.

It was great to speak to you earlier. Following up on our earlier conversation, we really appreciate Administrator Pruitt's invitation to participate in the Smart Sectors strategy – and RER would be delighted to join the partnership. Thank you.
