Attendance

Anyone attending the event was required to register and had to receive an invitation from our office.

Media/Press

The McCormick office has received over 100 media RSVP's, with a decent amount being Pennsylvania media. The White House sent around a media guidance today, so we anticipate more is to come. The panels and roundtables will all be open to the media (print, radio, TV, state, local, national, etc.). The Summit will be livestreamed on the Senator's [website](#) and reposted to his social media channels as well. Panel Details

We are currently on track for our panel to start at 12:30 PM, however we ask that you please be flexible while we work to lock in that time.
