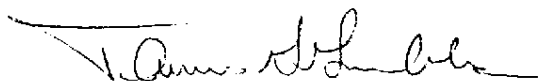

ACCREDITED LABORATORIES

(As of July 13, 1987)

To make it easier to locate a laboratory or laboratories in a particular area, listings are now broken down geographically by states and alphabetically within each state. To find the listing of a laboratory, where the name but not the location is known, refer to the alphabetical cross-reference at the end of the geographical listing.

The following laboratories have been accredited under the Laboratory Accreditation Program of the American Industrial Hygiene Association.

Those marked by a bullet (*) accept samples on a fee basis.

Proficiency testing is an integral part of the American Industrial Hygiene Association's laboratory accreditation program, and is fulfilled by the laboratory's participation in the NIOSH Proficiency Analytical Testing Program (PAT). This program presently includes quarterly samples for lead, cadmium, zinc, asbestos, silica and organic solvents. (The following solvents are provided on a rotating basis: carbon tetrachloride, benzene, cellosolve acetate, chloroethylene, p-dioxane, toluene, chloroform, 1, 2 dichloroethane,

methylene chloride, methyl chloroform, methyl ethyl ketone and o-xylene.) Accredited laboratories are required to analyze all materials in the PAT Program which they analyze as a part of their routine laboratory operations. The numbers in () indicate analyses in which the laboratory participates. Users should check with individual laboratories for current proficiency status if such information is desired.
