

MEMORANDUM OF DECISION

DATE: 1-19

- I. PURPOSE: To provide funds for modifications in the dump area and for the construction of two additional trash hoppers.
- II. PRESENT FACILITIES: At present the dump area is being used to handle "Transite" scrap and dust, pallets, damage and some miscellaneous refuse such as cardboard, banding, wire, lumber, etc. All other "burnables", as well as plastic waste, are being trucked to a land fill area outside the plant.
- III. PROPOSED FACILITIES: It is proposed to remove the scrap pipe along the west side of the dump and to grade and land fill the entire area. In the future no materials other than pipe and dust will be taken to the dry dump. A water line and hose will be installed to wet down the dust and prevent air-borne dust. To keep all burnables out of the dump, it is necessary to construct two additional trash hoppers to service the Section and Flextron Departments.

- VII. BENEFITS OR SAVINGS: The restriction of the Plant dump site to pipe and dust will greatly simplify maintenance of the area. The additional trash hoppers will allow various departments to more effectively segregate their waste material and do an improved job of getting them away from the plant. Under the authority of the Solid Waste Disposal Act (Article 4477-7, V.T.C.S.) the Plant Dump Site must be registered with the Texas Water Quality Board. The proposed modifications should be completed prior to registration.

DISPOSAL OF DRY WASTE

The purpose of this appropriation is to provide funds to grade and land fill the present dump. In addition two trash hoppers are required to handle trash for disposal in a land fill dump outside of the plant.

This will permit dumping only scrap pipe and dust in the plant dump where the material will be wet down to prevent air-borne contamination until covered with dirt.

It is necessary that this dump be registered with the Texas Water Quality Board and before registering it must be prepared so as to meet the requirements of the Texas Solid Waste Disposal Act.

The project is not included in the 1972 C.E.P.

Approval is recommended in order to meet Texas State regulations and to avoid receiving a citation from the Texas Water Quality Board.
