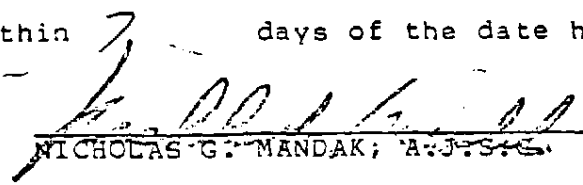
IT IS on this ^{16th} day of January, 1987

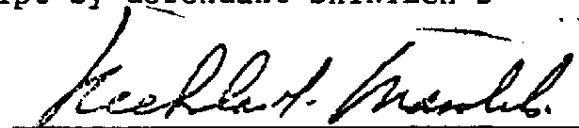
