Dear Dr. Kehoe:-

Under separate cover I am sending the papers lent me some months ago for use in the lead poisoning cases. Thank you for the loan. The papers have been of great value to me in forwarding my education on this subject which is so completely misunderstood by nearly all the laity, who are very little behind most of the medical profession on that point. More power to you and your brethren in spreading enlightenment, because the farther it spreads, the better it will be for everybody having to do with the handling of lead at any stage of its mining and use.

To bring you down to date on our case -

The referee awarded in favor of young [REDACTED] We have taken an appeal to the board, and that is to be presented to the board on October 29, 1942. There is no telling when the decision will be handed down by the board. Young [REDACTED] has continued to show improvement, which his physicians say is conclusive proof that the tentative diagnosis of one Philadelphia man, of amyotrophic lateral sclerosis, was altogether erroneous. I am much relieved that the boy does not have that terrible condition.

My brother, about whom I could read the opinion in your eyes, went on until Thursday afternoon, when he passed away of a cardiac condition. His weight was down to less than 70 pounds. I find from talking to one of his physicians while he was in Hahnemann Hospital they gathered from occasional remarks by him that he had diagnosed his condition long before any of his brethren suspected it. Instead of being a good patient, he continued to be the devoted physician, with the usual result of taking away from his patients the deep professional understanding and skill that can only be acquired by years of intensive practice.

Thank you for the loan of these papers, and thank you for the intensive education given me during our short time together.
