Dear Mr. Watson:

In reference to our telephone conversation of two weeks ago, I know of no specific indications or need for electrocardiography as part of the surveillance program in workers with potential exposure to vinyl chloride or to TDA. Similarly, I believe that the serologic tests for tumor (carcino-embryonic-alpha-feto protein) have no proven application and if they are being done by Dow, it must be on an investigative basis.

I have discussed with Dr. Beidleman the management of the two patients who continue to present with abnormal liver function tests in the absence of any other abnormalities; namely, [REDACTED] and [REDACTED]. I have also examined their liver biopsies which are essentially negative. I have informed him of our mutual decision that they be seen by an expert in liver disease in consultation and he is to arrange such a consultation.

In a letter to me dated November 7th, Dr. Blalock raises the question of the six months testing for individuals having 10 or more years of employment. He points out that we had hoped that the computer would flag those cases which fall into this category. Is this something that we should discuss or can it wait until the meeting that will be held within the next month or two? There seems little question but that the six months examinations are required by Federal Regulation. Dr. Blalock plans to re-start the examination of those requiring yearly investigation in January and I see no problem at all with this.
