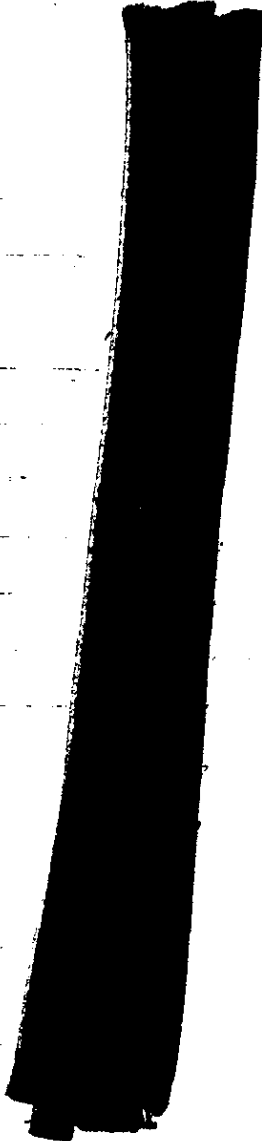
REFERENCE:
