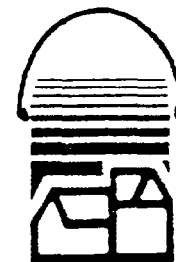
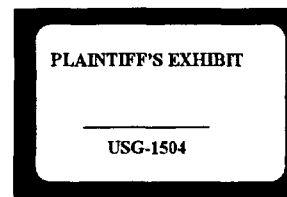

Asbestos Removal and Hazards Control (ARHC) proposes to remove and dispose of certain asbestos-containing materials located in the following areas of your plant complex:

Location of Work	Work to Be Performed
1. Outside Plant in Mill Area	Remove and dispose of asbestos insulation on not to exceed five (5) ten-foot long pieces of two-foot diameter duct. Insulation is covered with aluminum jacketing. Pieces of duct are lying on ground.
2. Board Building	Remove and dispose of not to exceed 16 sheets of asbestos transite which are eleven feet long by forty inches wide and which are mechanically fastened to the Board Building.

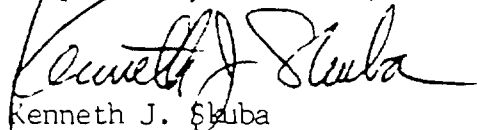

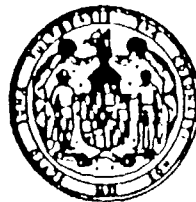
