Unless I am much mistaken, this is merely another case of confusing gasoline dermatitis with possible effects of Ethyl fluid in such gasoline. If I am mistaken all the trouble you have taken with me in the past in such matters has been wasted.

[REDACTED] Sheet Metal Worker	1-3-30	Dermatitis, Traumatic, Chronic, Mod. Severe. Caused by irritation from muriatic acid.	None
[REDACTED] Sheet Metal Worker	4-3-33	Recurrence of above. However, this time, employee believed that irritation was due to burns or infections from Ethyl lead deposits on gasoline tanks, which he repairs in the Sheet Metal Department. Physician gave diagnosis this time as: "Dermatitis, dorsal surface hands, cause unknown."	None

The foregoing are some of the comparatively recent cases of injury alleged to be due to the effects of ethyl lead gasoline poisoning. Time would not permit tracing down each employee's personal record to ascertain whether he had complained of suffering from contact with ethyl gasoline. Reports of injury are not classified and filed according to the nature of injury, but they are filed in the personal file of the employee concerned. Hence it would require more time than was permitted to make an exhaustive and complete report. Whenever cases of this kind are severe enough to involve loss of time from work, complete reports are made on forms C.A. 1, 2, 3 and 16, and the Chief, Materiel Division, is furnished with copies of same.
