Dear Jim:

Enclosed is the copy of your text on which I have made a few comments. I have retained a copy for Harry Rhodes to look at and he will contact you directly if he has any additional comments.

As we discussed, I would suggest a paragraph or two on the hazard, or lack of a hazard, to the general population. I think legislators, especially, should hear the industry side of this phase of the asbestos story. I have enclosed a copy of my 12/75 paper for the JPT with the "public environment" section circled.

I have always been impressed by the fact that, as I understand it, the Quebec asbestos miners have a lower incidence of lung cancer than the general population in Montreal. If true, perhaps this is another point to make.

Is there any way to establish the actual number of deaths per year due to asbestos exposure? I found the attached table in my files, but it only covers asbestosis for 1960-1967. It would be good information if we knew something about trends based on actual data rather than speculations by NIOSH, EPA, OSHA, etc.

I think the "Asbestos Issue" idea is a good one and commend J-M for the work already expended on it. I am sure we will use your more general presentation when available.

Thank you for allowing me to review the text and perhaps I'll see you at the Substitutes Workshop.

BECAUSE IT DEALS WITH HUMAN HEALTH, THE ASBESTOS MATTER IS NOT ONLY

ASBESTOS IS A GENERIC TERM APPLIED TO SIX MINERALS WHICH ALL HAVE A FIBROUS STRUCTURE. ASBESTOS CAN BE DIVIDED INTO TWO MAIN CLASSES, BASED ON THE CRYSTALLINE STRUCTURE OF THE HOST ROCK -- SERPENTINE AND AMPHIBOLES. WITHIN THESE TWO CLASSIFICATIONS THERE ARE FOUR ~~THREE~~ COMMERCIALY SIGNIFICANT VARIETIES OF ASBESTOS: CHRYSOTILE, ~~serpentine variety of amphiboles crocidolite & amosite.~~ The only ~~CROCIDOLITE, AMOSITE AND ANTHOPHYLITE.~~ EACH OF THESE DIFFER PHYSICALLY AND CHEMICALLY FROM EACH OTHER.

WHILE ASBESTOS FORMATIONS ARE FOUND EVERYWHERE IN THE EARTH'S CRUST, CHRYSOTILE IS THE MOST IMPORTANT COMMERCIALY SINCE IT REPRESENTS 95% OF WORLD PRODUCTION.

I know this is correct but asbestos can't be lit in the first place. I usually describe it as "non-burning".

THE WORD "ASBESTOS" IS DERIVED FROM AN ANCIENT GREEK TERM MEANING "INEXTINGUISHABLE." THE GREEKS AND ROMANS USED ASBESTOS TO MAKE WICKS FOR TEMPLE LAMPS. CLASSICAL WRITERS OF REPUTE ~~SUCH AS PLINY, PEUTARCH AND PAUSANIAS~~ WROTE ABOUT A SUBSTANCE WHICH, WHEN LIT, DID NOT BURN OUT. ~~PLINY SPECIFYING WHAT IT WAS.~~ *He usually describes it as "non-burning".* PLINY SPEAKS OF TABLECLOTHS WHICH WERE CLEANED BY EXPOSING THEM TO FIRE. LATER MARCO POLO WROTE OF HAVING SEEN FIREPROOF SHEETS IN SIBERIA. IT IS ALSO KNOWN THAT ASBESTOS WAS USED FOR MEDICAL PURPOSES IN THE PAST AND IN CERTAIN COUNTRIES IT WAS USED IN THE MAKING OF LIGHT POTTERY AND ^{IN} THE BUILDING OF ~~HIGHLY RESISTANT~~ OVENS. THE SECOND DISEASE IS LUNG CANCER. THERE IS LESS INCIDENCE OF THIS ASBESTOS-RELATED DISEASE THAN THERE IS ASBESTOSIS, BUT LUNG CANCER IS SIGNIFICANT BECAUSE IT IS THE CHIEF CAUSE OF DEATH AMONG PERSONS ~~EXPOSED TO ASBESTOS~~. ALSO, THE EVIDENCE IS QUITE CLEAR THAT THE GOVERNMENT FAILED TO TAKE RESPONSIBLE ACTIONS TO PROTECT ITS EMPLOYEES. THE BURDEN OF FAIRLY COMPENSATING THESE GOVERNMENT EMPLOYEES FALLS SQUARELY UPON THE U.S. NAVY AND CONGRESS.

AND, THE ASBESTOSIS DANGER WAS BELIEVED BY ALL TO DISAPPEAR WITH THE REDUCTION OF DUST COUNTS TO LEVELS RECOMMENDED BY THE U.S. PUBLIC HEALTH SERVICE IN 1938. A10807

IT IS IMPORTANT TO RECOGNIZE THE LEVEL OF KNOWLEDGE ABOUT ASBESTOS HEALTH HAZARDS DURING THE YEARS. THERE ARE ACTUALLY TWO TIME PERIODS INTO WHICH MEDICAL KNOWLEDGE CAN BE DIVIDED.

There are also millions of others who work with or use asbestos-containing products in which the fibers are locked in as previously described. These workers, and the general population, may be exposed to fiber levels slightly above background, but these levels do not constitute a health hazard. Many publicity-seekers extrapolate from these numbers and forecast hundreds of thousands of deaths from asbestos. This is blatantly false and inaccurate!

IN THE FIRST PERIOD THERE WAS GENERAL KNOWLEDGE THAT ASBESTOSIS EXISTED AMONG ASBESTOS FACTORY WORKERS. J-M WAS PAYING WORKERS COMPENSATION CLAIMS FOR ASBESTOSIS TO ITS OWN FACTORY WORKERS AS FAR BACK AS THE 1930's AND EVERYONE INCLUDING THE MEDICAL PROFESSION, INSURANCE COMPANIES, UNIONS AND WORKERS KNEW ABOUT IT.

ALSO IN THE 1930's, JOHNS-MANVILLE, OTHERS IN THE INDUSTRY AND OUR INSURANCE CARRIERS, UNDERWROTE MEDICAL STUDIES ON ASBESTOS-RELATED DISEASE. SEMINARS WERE CONDUCTED DURING THESE TIMES AND ATTENDED BY THE CHIEF OCCUPATIONAL MEDICAL OFFICER OF THE U.S. PUBLIC HEALTH SERVICE AND HIS COUNTER-PART IN CANADA. REPORTS WERE PUBLISHED ONCE THE STUDIES WERE COMPLETE.

IN 1938, AS I SAID, THE U.S. PUBLIC HEALTH SERVICE PUBLISHED THE RESULTS OF ITS FIRST STUDY MADE SPECIFICALLY TO CHARACTERIZE ASBESTOSIS AND IDENTIFY A SAFE LEVEL OF EXPOSURE BELOW WHICH ONE WOULD NOT GET ASBESTOSIS. FROM THAT STUDY RECOMMENDED STANDARDS FOR WORKING ENVIRONMENTS WERE ESTABLISHED AND IT WAS BELIEVED THAT THERE WAS NOT ANY DISEASE PROBLEM BEYOND ASBESTOSIS.

TRAGICALLY THESE RECOMMENDED STANDARDS FOR ASBESTOS DUST CONTROL LATER PROVED TO BE INADEQUATE, AND, DURING THE WAR AND INTO THE 1960's, THERE CONTINUED TO BE EXCESSIVE EXPOSURE TO ASBESTOS.

FURTHER, IN 1946 THE GOVERNMENT UNDERTOOK AND PUBLISHED THE RESULTS OF ANOTHER STUDY WHICH INDICATED THAT INSULATION WORK IN SHIPYARDS WAS NOT A HAZARDOUS OCCUPATION.

TO ASBESTOS IN DRINKING WATER FROM NATURAL SOURCES IN AREAS WHERE ASBESTOS IS A PART OF THE EARTH'S CRUST AND ON POPULATIONS RECEIVING DRINKING WATER THROUGH ASBESTOS-CEMENT PIPE HAVE UNIFORMLY FAILED TO DEMONSTRATE ANY RISK ASSOCIATED WITH THE INGESTION OF ASBESTOS IN WATER.

DOES ASBESTOS-CEMENT PIPE CONTRIBUTE ASBESTOS TO DRINKING WATER CONVEYED THROUGH IT? THIS PRODUCT HAS BEEN IN USE FOR OVER 50 YEARS AND HAS AN EXCELLENT RECORD.
