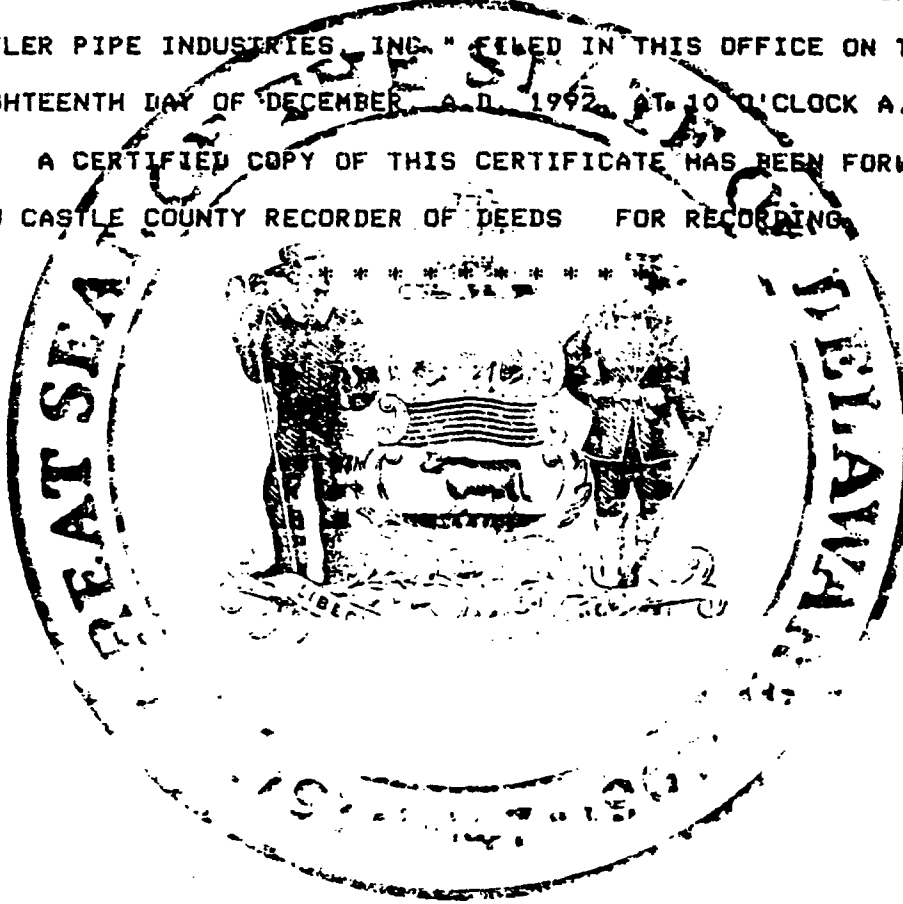

**CERTIFICATE OF AMENDMENT  
TO THE  
CERTIFICATE OF INCORPORATION  
OF  
TYLER PIPE INDUSTRIES, INC.**

Pursuant to the provisions of Section 241 of the General Corporation Law of the State of Delaware, Tyler Pipe Industries, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), does hereby certify:

**FIRST:** That the Board of Directors of the Corporation, by unanimous consent pursuant to Section 141(f) of the General Corporation Law of the State of Delaware, adopted resolutions setting forth and declaring advisable the following proposed amendment to the Certificate of Incorporation of the Corporation.

A. Article 1 of the Certificate of Incorporation is hereby amended to read as follows:

**"FIRST:** The name of the Corporation is Swan Transportation Company."

**SECOND:** That thereafter, pursuant to resolution of the Board of Directors, the proposed amendment was submitted to and approved by the sole stockholder of the Corporation.

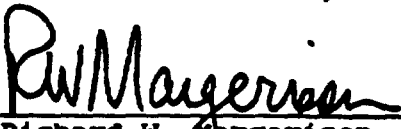
**THIRD:** That said amendment was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.

**FOURTH:** That the capital of said corporation shall not be reduced under or by reason of said amendment.

**FIFTH:** In accordance with Section 103(d) of the General Corporation Law of the State of Delaware, this amendment shall become effective at 4:50 p.m., December 26, 1992.
