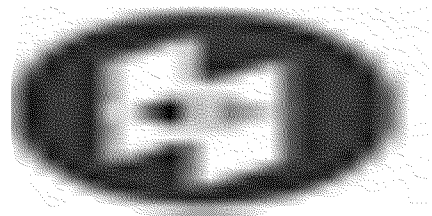

The timing for the meeting would be Thursday, June 15 at a time that is convenient between 12:30 and 2:30 at the Marriott Wardman Park, 2660 Woodley Road, NW, Washington, DC.
